1. MINUTES

The minutes of the meeting held on 21 November 06 were approved as a correct record and signed by the Chairman.

2. APPROVAL OF HAVERING'S STATEMENT OF LICENSING POLICY FOR THE LICENSING ACT 2003

The Committee received a report on the result of the consultation on Havering's Draft Statement of Licensing Policy for the Licensing Act 2003.

Section 182 of the Licensing Act 2003 requires all Licensing Authorities to prepare and publish a statement of Licensing Policy that they propose to apply in exercising their functions under the Act during the three year period to which the policy applies. The current policy expires on the 7 January 2008.

The report outlined that the Statement of Licensing Policy had been reviewed and rewritten to include good practice, current guidance and experience from implementing the Act. In exercising their functions under the Licensing Act 2003, Licensing Authorities must have regard to the licensing objectives:

- Prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- Protection of children from harm

The Committee was informed that the Licensing Authorities, it can only publish its Statement of Licensing Policy if it had paid due regard to guidance issued by the Government. Havering's draft Statement of Licensing Policy was produced following the Department of Culture Media and Sport (DCMS) revised guidance to local authorities on the Licensing Act 2003.

The relevant bodies had been consulted as required by the Act. All comments received had been included in the draft policy regarding CCTV, planning and the pool of conditions.

Having considered the details of the report, the Committee made the following observations:

That the Licensing Authorities consider 50 metres as the distance for of consultation.

RESOLVED

That the Committee recommend to Council that the Havering Revised Statement of Licensing Policy.

A copy of the Havering Draft Statement of Licensing Policy is on display in the Members Resources Room.

3. LICENSING PERFORMANCE INDICATORS 2007-2008

The Committee received a report that outlined a set of performance indicators and targets for Members to consider in order to scrutinise the functions of Environmental Health officers.

Members reviewed LPI44 to 90% and agreed that the Committee meet twice a year to consider the performance indicators.
