3 APPOINTMENT TO THE POST OF GROUP DIRECTOR, SOCIAL CARE & LEARNING

The Committee interviewed two applicants for appointment to this position. The Sub-Committee carefully considered the merits of each candidate by reference to the written profiles, results of earlier tests and evaluations and also satisfied themselves as to their professional competency by questioning them in turn.

Members then deliberated on their individual merits. After weighing the relative strengths and experience of the candidates as indicated by their application and by interview, the Committee **RESOLVED TO APPOINT** Joy Hollister, currently employed by the City of London Corporation in the position of Director of Community and Children's Services, as she had the requisite experience, skills and knowledge to discharge the duties of GD Social Care & Learning and should be appointed to that post, subject to the notification provisions of paragraph 12 of the Staff Employment Procedure Rules set out in part 4 of Havering's Constitution and upon confirmation from the Chief Executive and Group Director Finance & Commerce that the appropriate references had been received and were satisfactory.

The Sub-Committee further **RESOLVED** that, in the event Joy Hollister declined the appointment, it should be re advertised.
