A3	PE00414/18 - 22-44 NORTH STREET ROMFORD - DEMOLITION OF EXISTING BUILDINGS AND ERECTION OF 2-TIERED BUILDINGS TO PROVIDE 95 RESIDENTIAL AND 3 COMMERCIAL UNITS	<ul> <li>The Committee received a developer presentation from Lexus Planning</li> <li>The revised proposed scheme ranged in height from 6 to 12 storeys, and provided 95 residential units, and approximately 373 sq. m of commercial floor space</li> <li>The revised scheme proposed 62 private and 33 affordable residential units</li> <li>The revised scheme would essentially be car-free, with the provision of 10 flexible use disabled spaces, which could also be utilised for a car club; vehicular access to the site was from The Mews to the east.</li> <li>Amenity space for the development would be created through the provision of a communal garden at level 5 of the lower building to the south, as well as private terraces and balconies.</li> <li>Members raised the following issues:</li> <li>Whether comparison to buildings nearby which were outside of the Conservation Area was disingenuous</li> <li>What the justification was for the proposed height, why so high?</li> <li>Density of scheme.
