SUMMARY

The current Joint Health and Wellbeing Strategy (2015–2018) was signed off by the Havering Health and wellbeing Board in April 2015. It has been reviewed and refreshed in line with recent developments within the local health and social care economy to ensure it remains fit for purpose.

The Board agreed the reframed themes and priorities for the strategy in May 2016. These have been reflected in the refreshed strategy document now presented to the Board for approval. This incorporates comments received from Board members, the most notable being specific reference to End of Life Care. Some further minor changes have been made, which are shown in red text.

REPORT DETAIL

Governance

The Board previously decided that a governance structure will be confirmed once the refreshed strategy had been agreed.

It was agreed in May 2016 that the following groups will report to the HWB:

- Health Protection Forum.
- JSNA Steering group.
- Local Children's Safeguarding Board and Adult Safeguarding Board (*noting that this may need to be reviewed as a result of change to safeguarding arrangements*)
- Care Transformation Board

The draft refreshed strategy that was circulated to the Board for comment listed the following as reporting to the HWB:

- Joint Management and Commissioning Forum.
- End of Life Strategy Group.
- Poverty Reduction Programme Executive
- Mental Health Partnership Board (including Dementia Partnership).

The following were listed as having a "partnership relationship" with HWB:

- Integrated Care Coalition and/or ACO programme board (tbc)
- Community Safety Partnership
- Primary Care Transformation Board

One comment was received; that a yet-to-be established SEND Partnership Board also to report to the HWB.

The Health and Wellbeing Board is asked to agree the above governance arrangements, following which a structure chart will be developed to describe the

relationships with the groups listed above. In addition, the Chairs of all groups will be contacted with the request that their respective Terms of Reference be updated for subsequent sign off by the HWB

Performance Dashboard

The Board agreed to provide feedback and input, as necessary, to identify the key strategic documents and action plans already in place to deliver the strategy. This was circulated to the Board as an “Implementation Plan”.

Comments were received on the Implementation Plan, which will be used to develop a Performance Dashboard. This will be finalised in readiness for the Health and Wellbeing Board meeting May 2017.
