Part A - Report seeking decision

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

Authorisation to award a contract to Haynes and smith Ltd. in the sum of £2,759,139.39 for the construction of a 2 storey stand alone class room block with associated accommodation and first floor infill extension.

AUTHORITY UNDER WHICH DECISION IS MADE

Authority for member of SLTunder Section 3 of the Constitution as follows **Contract powers**

(b) To award all contracts with a total contract value of between £500,000 and £5,000,000.

STATEMENT OF THE REASONS FOR THE DECISION

Need for School places

Havering, in common with the many other London Boroughs and urban areas is currently experiencing an increase in demand for school places. This increase in demand is due to rising birth rates in Havering and families moving into the borough from other parts of London, the UK and abroad. All Local Authorities including Havering have a statutory duty to ensure that there are enough school places available in the borough to accommodate all children who live in the borough and might require one. The increase in demand for school places has meant that in some areas of Havering, the demand for places is higher than the number of places available.

Demand for places across this area has been high with a significant projected deficit. Almost all the schools in this planning area have already been expanded. However, due to the sustained and increasing demand, a further permanent expansion in this area is required.

Broadford Primary School is an outstanding school and has accordingly been agreed as an appropriate location for additional numbers to be accommodated. The governing body agrees with the proposal in-principle and supports a permanent solution with enhanced facilities suitable for the proposed increase in pupil numbers.

The permanent expansion of both schools from two to three forms of entry is necessary in order to ensure that the Council is able to fulfil its statutory duty of securing sufficient school places to meet the needs of children and families in Havering.

Procurement

7 contractors from the ConstructionLine database were invited to tender on the basis of the JCT Design and Build Contract 2016. Four contractors returned tenders and these have been assessed on a 70/30 cost/ quality basis as follows:

Haynes and Smith (Contractor B) has also confirmed that it can deliver the accommodation by November 2018 subject to early formal instruction.

The tender has been checked by Jacobs, the Council's building professional consultant. The tender report is attached as an exempt appendix (due to the commercial sensitivity). Jacobs has confirmed that all works have been fully priced at reasonable rates. This contractor has successfully completed five projects for schools within the Borough in recent years at similar rates.

The tender submitted is considered to be competitive and bona fide and is therefore recommended for approval.

Part B - Assessment of implications and risks

LEGAL IMPLICATIONS AND RISKS

Part 3, section 3.3 of Havering's Constitution permits members of the Senior Leadership Team (SLT) to approve the award of all contracts with a total contract value between £500,000 and £5,000,000.

As a Local Education Authority, the Council has a statutory duty to secure that sufficient schools are available for their area as set out in section 14(1) of the Education Act 1996. Technical Services seek to procure these Works in accordance with this duty.

The proposed contract value is below the EU threshold for Works contracts governed by the Public Contracts Regulations 2015. The Council is therefore under no obligation to advertise the contract opportunity in the OJEU.

In accordance with CPR 13, officers instead invited seven organisations from Constructionline. Although only four organisations submitted tenders, officers are satisfied that the number of candidates was sufficient to ensure genuine competition.

All Contracts with a value above £150,000 along with any collateral warranties will need to be sealed. This should be carried out by Legal Services.

Risks

As with most capital schemes, there is a risk that the scheme could overspend due to issues arising during the build process, however given the size of the works, and previous experience of the contractor any significant overspend is unlikely. Any small

issues arising can be funded from the remaining contingency budget within the school phase 3/4 expansion programme.

As with all contracts there is a risk to contractor delivery/continued operation. However the contractor selection process will partly mitigate this risk, along with careful project management.
