DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

This Executive Decision approves the implementation of safety improvements including zebra crossing, humped zebra crossings, junction speed table, speed table and junction alteration with narrow approaches in Butts Green Road and North Street, following the completion of public consultation and at the recommendation of the Highways Advisory Committee as set out on drawing Nos QQ005-2, QQ005-3, QQ005-4, QQ005-5 and QQ005-6.

At its meeting of 9th January 2018, the Highways Advisory Committee considered a report on the proposals (copy attached) and the following recommendations:

That the Committee having considered the representations and information set out in this report recommends to the Cabinet Member for Environment, Regulatory Services and Community Safety that the safety improvements as detailed below and shown on the relevant drawings be implemented as follows:
 - (a) Butts Green Road by south of Wykeham Avenue (Plan No:QQ005-2)
 - Humped zebra crossing
 - (b) Butts Green Road by Hillview Avenue and Berther Road (Plan No:QQ005-3)
 - Humped zebra crossing
 - Junction speed table
 - (c) North Street by Seymour Place (Plan No:QQ005-4)
 - Zebra crossing
 - (d) North Street by Burnway (Plan No. QQ005-5)
 - Speed table

- (e) North Street by Fentiman Way (Plan No:QQ005-6)
 - Junction alteration with narrow approaches
- 2. That, it be noted that the estimated costs of £90,000, can be met from the Transport for London's (TfL) 2017/18 Local Implementation Plan allocation for Accident Reduction Programme.
