Part A – Report seeking decision

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

Authorisation to award a contract to Valuegrade Ltd. in the sum of £1,484,694.00 for the construction of a classroom block and ancillary works to existing school.

AUTHORITY UNDER WHICH DECISION IS MADE

Authority for member of CMT under Section 3 of the Constitution as follows **Contract powers**

(b) To award all contracts with a total contract value of between £164,176 and £5,000,000.

STATEMENT OF THE REASONS FOR THE DECISION

Need for School places

Havering, in common with the many other London Boroughs and urban areas is currently experiencing an increase in demand for school places. This increase in demand is due to rising birth rates in Havering and families moving into the borough from other parts of London, the UK and abroad. All Local Authorities including Havering have a statutory duty to ensure that there are enough school places available in the borough to accommodate all children who live in the borough and might require one. The increase in demand for school places has meant that in some areas of Havering, the demand for places is higher than the number of places available.

Rainham Village Primary School is a popular, good school and has been agreed as an appropriate location for additional numbers to be accommodated. The governing body of the school agrees with the proposal and supports a permanent solution with enhanced facilities suitable for the proposed increase in pupil numbers

The permanent expansion from two to three forms of entry is necessary in order to ensure that the Council fulfils its statutory duty of securing sufficient school places to meet the needs of children and families in Havering.

Procurement

9 contractors on the ConstructionLine database were invited to tender on the basis of a JCT Design and Build Contract 2016. 7 contractors returned tenders and this is considered to be sufficient for genuine competition. These have been assessed on a 70/30 cost/ quality basis as follows:

Part B - Assessment of implications and risks

LEGAL IMPLICATIONS AND RISKS

The report seeks approval for the award of a below threshold construction contract which has been procured in line with the requirements set out in the Councils Contract Procedure Rules and in accordance with the Public Contract Regulations 2015 and EU Principles of equal treatment, transparency and non discrimination.

The Council is a Local Education Authority within the meaning of Section 12 of the Education Act 1996 and has a general responsibility for education under Sections 13 and 14 of the Act. Such obligations include under Section 16 the provision and maintenance of primary and secondary education establishments. Such powers may be supplemented by other legislation notably the Council has a wide "general power of competence" under Part 1 Chapter 1 of the Localism Act 2011. The recommendations in this report are compatible with these statutory powers.

School Expansion Programme re Primary Expansion £3,250,000

Expenditure of £534,949 has been expended in delivering the first phase of the expansion. £2,715,051 remains in the budget to fund this project The surplus of £793,357 will be returned to the school expansion programme contingency.

This will help to ensure there is sufficient balance within the schools expansion phase 3/4 contingency budget, and utilised across the schools expansion programme in accordance with the capital virement rules.

Risks

As with most capital schemes, there is a risk that the scheme could overspend due to issues arising during the build process, however given the size of the works, and previous experience of the contractor any significant overspend is unlikely. Any small issues arising can be funded from the remaining contingency budget within the school phase 3/4 expansion programme.

As with all contracts there is a risk to contractor delivery/continued operation.

However the contractor selection process will partly mitigate this risk, along with careful project management.
