## Geographical description of the area and description of the building

The premises is situated in South Street Romford, opposite Romford Bus Terminal and Romford Station. It is a single storey building that operates as a takeaway fast food business.

To the left hand side is an Off Licence (Aforda) which is licensed for the sale of alcohol, to the right is a Betting Shop (Ladbrokes). Two doors away from the Betting shop is a Pub (The Goose) which is licensed for the sale of alcohol, films, music (recorded and live) and late night refreshment. There is also another takeaway premises (Hot & Tasty) opposite. They are licensed for late night refreshment.

a) General – all four licensing objectives (b,c,d,e)

The Licensee, that is the person in whose name the premises licence is issued, shall ensure that all times when the premises are for any licensable activity, there are sufficient competent staff on duty at the premises for the purpose of fulfilling the terms and conditions of the licence and for preventing crime and disorder. The Licensee shall ensure that all staff will undertake training in their responsibilities in relation to the sale of alcohol, particularly with regard to drunkenness and underage persons. Records will be kept of training and refresher training.

b) The prevention of crime and disorder

Any incidents of a criminal nature that may occur on the premises will be reported to the Police. The Licensee will install comprehensive CCTV coverage at the premises and it is operated and maintained at the premises.

The CCTV system shall conform to the following points:

1. Cameras must be sited to observe the entrance and exit doors both inside and outside.
2. Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
3. Cameras viewing till areas must capture frames not less than 50% of screen.
4. Cameras overlooking floor areas should be wide angled to give an overview of the premises.
5. Be capable of visually confirming the nature of the crime committed.
6. Provide a linked record of the date, time and place of any image.
7. Provide good quality images –colour during opening times.
8. Operate under existing light levels within and outside the premises.
9. Have the recording device located in a secure area or locked cabinet.
10. Have a monitor to review images and recorded picture quality.
11. Be regularly maintained to ensure continuous quality of image capture retention.
12. Have signage displayed in the customer area to advise that CCTV is in operation.
13. Digital images must be kept for 31 days.
14. Police will have access to images at any reasonable time.
15. The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy, if this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Copies must be made available to Police on request.

c) Public safety

Appropriate fire safety procedures are in place including fire extinguishers, internally illuminated fire exit signs, numerous smoke detectors and emergency lighting (see enclosed plan for details of locations). All appliances are inspected annually. All emergency exits shall be kept free from obstruction at all times.

d) The prevention of public nuisance

All customers will be asked to leave quietly.

Clear and legible notices will be prominently displayed to remind customers to leave quietly and have regard to our neighbours.

e) The protection of children from harm

The licensee and staff will ask persons who appear to be under the age of 25 for photographic ID such as proof of age cards, the Connexions Card and Citizen Card, photographic driving licence or passport, an official identity card issued by HM Forces or by an EU country, bearing the photograph and date of birth of bearer.

All staff will be trained for UNDERAGE SALES PREVENTION regularly.

A register of refused sales shall be kept and maintained on the premises.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

**Objection summary:** The application has declined to provide any rebuttal further to cumulative impact while the proposed conditions appear ill equipped to successfully address the promotion of all four licensing objectives.

### Policy considerations

#### Licensing Policy 1

In considering applications for new licences, variations to existing licences and licence reviews the Licensing Authority will take the matters listed below into account:

- whether the premises is located in an area of cumulative impact;
- the type of premises and their cumulative impact on the area and the mix of premises in the area;
- the location of the premises and the character of the area;
- the views of the responsible authorities;
- the views of other persons;
- past compliance history of current management;
- the proposed hours of operation;
- the type and number of customers likely to attend the premises;
- whether the applicant is able to demonstrate commitment to a high standard of management, for example through active participation in the Safe and Sound meetings and pub watch.

#### Licensing Policy 2

The Licensing Authority has adopted a special policy relating to cumulative impact in relation to:

- Romford town centre within the ring road
- St Andrews Ward

This policy creates a rebuttable presumption that applications for new premises licences, club premises certificates, or variation applications that will add to the existing

cumulative impact, will normally be refused, unless the applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact and not impact adversely on the promotion of the licensing objectives. The exception to this policy will be for applications for restaurants where alcohol is sold ancillary to a table meal and the terminal licensing hour is in line with the policy.

## Licensing Policy 7

When dealing with new and variation applications the Licensing Authority will give more favourable consideration to applications with the following closing times:

Consideration will also be given to the type of area that the premises is located in with regulated activities normally being permitted until 23:30 in residential areas and 00:30 in mixed use areas.

These hours are not pre-determined and each application will be considered on its merits.

## Licensing Policy 14

The Licensing Authority is committed to protecting the amenity of residents and businesses in the vicinity of licenced premises, particularly when late hours have been sought. Where relevant representations are received the Licensing Authority will impose appropriate restrictions or controls on the licence to support the prevention of undue noise disturbance from licensed premises.

## Licensing Policy 19

The Licensing Authority will require consideration of measures to protect children from harm to be reflected in the operating schedule where applicants identify the need, having regard to their type of premises or licensable activities. Applicants for premises licences and club premises certificates authorising the admission of children without accompanying responsible adults will be required to submit a safeguarding children protection policy detailing the steps to be taken to ensure that children in their charge will be protected from harm when on licensed premises or engaged in activities relating to the licence.

## Representation

This application is designed to extend the hours during which late night refreshment for take-away may be provided on a Friday and Saturday from the current terminal hour of 02:00 to a new terminal hour of 04:00. The current 02:00 terminal hour is already in excess of the guideline terminal hours identified in Licensing Policy 7.

The premises is located at Havering's most significant crime 'hot-spot' at the transport hub adjacent to Romford station. The premises is located within Romford's cumulative impact zone as defined in Licensing Policy 2. The applicant, via his agent, has declined to offer any rebuttal of Havering's special policy further to cumulative impact despite receiving two contacts from the licensing authority suggesting it would be in the interests of the applicant to do so. This might suggest that the applicant does not accept cumulative impact as a legitimate concern.

The premises' recent history required that, after an intervention by the Police in September 2016, the late night refreshment hours were reduced to their current level (i.e. an 02:00 terminal hour Monday to Sunday). A series of conditions were added further to the premises licence holder's duty to ensure that all employees have the right to work in the UK.

The current premises licence holder and hence applicant for this variation had the licence transferred to him in June 2018. Clearly he had no involvement in the reasons for the previous Police intervention. We must remember, however, that the premises' location remains a constant. The location at the place where large numbers of people congregate makes it a popular destination at which revellers like to visit on their journey home having spent the night consuming alcohol. Dispersal from the town centre is therefore delayed. A failure to disperse can and does lead to anti-social behaviour of various forms. The hours reduction in September 2016 was a measure encouraged by the Police to reduce the ongoing effects of anti-social behaviour which had attended this premises at that time.

The conditions proposed by the applicant to add to those already on the licence might appear less than reassuring given the location of the venue and its previous history.

### General – all four licensing objectives

This section appears to have a two-fold proposal: (a) a sufficient number of competent staff shall be on duty and (b) training shall be provided to staff.

With regard to (a) we would normally expect that a sufficient number of staff are on duty as a matter of course as, notwithstanding anything else, it is simply good business practice to have enough staff to attend to customers; making it a conditional requirement might therefore appear open to interpretation.

With regard to (b) we would normally be reassured to see that training requirements are installed on a premises licence. In this case, however, the proposal raises some concerns. The applicant proposes that *The Licensee shall ensure that all staff will undertake training in their responsibilities in relation to the sale of alcohol, particularly with regard to drunkenness and underage persons. Records will be kept of training and refresher training.* This premises licence does not authorise the sale of alcohol so it is difficult to see what responsibilities staff may have further to the sale of alcohol. We may perhaps conclude one of two things: either the premises is selling alcohol without an authorisation or the proposed condition has been included in a less than diligent 'copy-and-paste' approach to application submission wherein the conditions from another application have been copied and put into this one with little thought given to whether they are appropriate.

## **The prevention of crime and disorder**

This section proposes conditions further to the installation of CCTV. There is already a CCTV condition on the current version of the licence but the proposals contained here expand upon the applicant's CCTV commitments. While such proposals are welcomed we might reasonably have expected that the applicant outlines what he intends to do to address the extended period from 02:00 to 04:00 in which significant numbers of customers, in all likelihood under the influence of alcohol, are likely to arrive at his premises. Are we to conclude that the applicant is of the view that the mere presence of CCTV within the premises will successfully prevent crime and disorder from occurring during this early morning period?

## **Public safety**

A number of proposals are identified further to the presence of firefighting equipment and emergency lighting. Again, while all public safety proposals are to be welcomed we might reasonably have hoped that the applicant's public safety risk assessments addressed the issue further to the weekend 02:00 to 04:00 period in which the premises is likely to be full of customers who are under the influence of alcohol.

## **The prevention of public nuisance**

This section proposes that customers will be asked to leave the premises quietly and attendant signage will request similarly. There are numerous forms of public nuisance so we might have reasonably expected that matters such as customer behaviour and customers' disposal of litter might also have been addressed here.

## **The protection of children from harm**

The applicant's proposals here are:

*The licensee and staff will ask persons who appear to be under the age of 25 for photographic ID such as proof of age cards, the Connexions Card and Citizen Card, photographic driving licence or passport, an official identity card issued by HM Forces or by an EU country, bearing the photograph and date of birth of bearer. All staff will be trained for UNDERAGE SALES PREVENTION regularly. A register of refused sales shall be kept and maintained on the premises.*

It is my understanding that there is no age restriction placed upon the purchase and consumption of hot food such as a kebab, a hamburger or a bag of chips. We certainly would not expect that the operator self-imposes a Challenge 25 policy further to the sale of kebabs to ensure that only customers who can provide identification to prove that they are over the age of 18 are permitted to buy the food available. Again, training for 'underage sales prevention' might reasonably be considered to relate to the sale of alcohol rather than to the provision of hot food. The proposals here might appear entirely redundant therefore unless we conclude that alcohol sales are being made from this premises. Entirely absent from this section are, for example, any proposals further to what the applicant's response might be should an unaccompanied child arrive on the premises late in the evening or in the early hours of the morning.

Perhaps we might reasonably conclude that this is another example of the application's 'copy-and-paste' approach to proposing steps to promote the licensing objectives. The proposals contained in this application might appear to have been copied from an application for an off-licence premises supplying alcohol rather than from a premises providing late night refreshment alone. Such an approach clearly does not reassure us that the applicant is providing appropriate consideration towards the duty to promote the licensing objectives. Little thought appears to have been given to the completion of the application form which in turn suggests that little thought will be given to the actual

implementation of these proposals. How can the premises licence holder expect that providing his staff with training further to the sale of alcohol will benefit his staff's approach to the supply of late night refreshment? Why are the premises' customers expected to show identification to prove they are over 18 when there is no age restriction further to the supply of hot food?

While the location of this premises works in the applicant's favour further to potential customer footfall it also works in the opposite direction as the responsibilities further to promoting the licensing objectives placed upon the applicant are greatly increased so will naturally require extra diligence. This application unfortunately suggests to us that the applicant's approach is *likely* to adversely impact upon the promotion of the licensing objectives and would therefore *add* to cumulative impact in this area. Based upon this assessment we are unable to support the application.

In relation to the application received by Police on 05<sup>th</sup> November 2018 to vary the premises licence for Way2Save, Med Shish 151 South Street Romford RM1 1PL, with a view to extend their licence so that they would be permitted to open from 2300hrs until 0400hrs Friday to Saturday instead of their current permitted hours of 2300hrs until 0200hrs. Police have supplied background information concerning the history of the venue and the history of the area. Police would like to object to this application, the licensing objectives that Police are objecting under are Crime and Disorder, Public Nuisance are listed below the Background of the venue.

The venue is situated in the middle of a busy transport hub only a short distance from numerous licensed venues. The clientele that would be attending the venue in the early hours of the morning would be people that are heavily intoxicated and unpredictable. In the past the venue has been the cause of large scale disorder and anti-social behaviour. Due to the size of the venue it can become over crowded very quickly and with only one or two door supervisors it would not be policed in a safe manner and the fear is that this will lead to confrontation inside and outside the venue.

The Police strongly believe that the any extension in Med Shish hours would have a direct result in an increase of Anti-Social Behaviour and violent crime at the location and in the nearby area.

The Police at this time do not have confidence that the venue will run efficiently in accordance with the requested licence conditions.
