### Part A - Report seeking decision

### DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

That having considered the information contained in this report, The Assistant Director for environment authorises the implementation of minor highway works to place road markings to improve turning manoeuvres at the junction of Chandlers Way, Rainham.

The proposals are shown on drawing No. QR022\_19\_OF\_101\_GA, which is attached in appendix 1 of this report.

### STATEMENT OF THE REASONS FOR THE DECISION

### Background

When turning right at a signalised junction, particularly where traffic exits simultaneously from the opposite direction, it is important to wait safely and move forward when there is a suitable gap in traffic proceeding on the opposite side of the road.

In the case of Chandlers Corner in Rainham, right turning traffic exiting from Upminster Road North and Upminster Road South and both arms of New Road (A1306) is held back as there are no road markings to guide drivers a safe spot to stop. This adversely effects the traffic flow, highway safety and increases congestion at the junction.

**Reasons:** To overcome the problem, it is proposed to install road markings je 'Port to Port' road markings at the junction of Chandlers Corner in Rainham. The purpose is to improve the turning manoeuvres by means of guidance road markings. These markings are 'site specific' ie are only installed at junctions where there is a special need identified. The proposals are shown on drawing No. QR022\_19\_OF\_101\_GA.

The proposals are aimed at keeping the junction clear which will reduce congestion and increase traffic flow.

It is the responsibility of the borough to reduce potential accidents, subject to availability of funds, wherever these are identified in the borough. As a result. Transport for London had approved special funding of £10k with a view to improve safety at the junction.

#### OTHER OPTIONS CONSIDERED AND REJECTED

The 'Do Nothing' option was considered but this was abandoned due to the current problem at the junction which cannot be ignored on road safety grounds.

### Part B - Assessment of implications and risks

#### **LEGAL IMPLICATIONS AND RISKS**

The Council has powers to install traffic signs on its road network by virtue of powers granted under Part V of the Road Traffic Regulation Act 1984, with S65 granting powers and giving duties for the placing of traffic signs.

The form and conditions under which traffic signs may be installed are prescribed by the Traffic Signs Regulations & General Directions 2016 and road markings that indicate stopping controls are prescribed traffic signs for this purpose.

### FINANCIAL IMPLICATIONS AND RISKS

The estimated cost of implementing the proposals is £0.005m which will be met by Transport for London through their Local Implementation Plan bid allocated for 2018/19 (A2950). Details of the estimated costs are shown below:

This is a standard project for Street Management and there is no expectation that the works cannot be contained within the cost estimate. There is an element of contingency built into the financial estimate. In the unlikely event of an 'overspend', the balance would need to be contained within the overall Environment budget.
