GUIDANCE NOTES ON COMPLETING THIS FORM

- (a) In this section you should include details of your job, or any business that you carry on.
- (b) If you are employed, or have been appointed, give in this section the name of the person or body who employs or has appointed you.
- (c) Complete this section by giving details of any payments you have received in respect of your election expenses (for example, from a political party or other group) or payments made to you in connection with carrying out your official duties.
