



The Mayor advised Members and the public of action to be taken in the event of emergency evacuation of the Town Hall becoming necessary.

Father Sean Shiels, of Corpus Christi Church, Collier Row, opened the meeting with prayers.

The meeting closed with the singing of the National Anthem.

#### 39 MINUTES (agenda item 3)

It was **RESOLVED**:

#### 42 **PETITIONS (agenda item 6)**

Pursuant to Council Procedure Rule 23, a petition containing 1,405 signatures was presented to the Mayor by Councillor David Durant from the operators of Damyns Hall Aerodrome, seeking support for the aerodrome remaining open.

It was noted that the petition would be passed to Democratic Services for attention in accordance with the Petitions Scheme.

Councillor Mark Logan had given notice of an intention to present a petition but, as he was absent from the meeting, it was agreed that he should have opportunity to do so at the next meeting.

#### 43 **PETITIONS SCHEME (agenda item 7)**

The Governance Committee reported that, with effect from 15 December, the Council was obliged by law to provide a facility for the submission of petitions electronically through the internet ("ePetitioning"). A contract had now been entered into for that facility (on an interim basis), funded from money provided by the government.

The Committee now recommended that Council adopt an amendment to the Council's statutory Petition Scheme to make provision in it for ePetitioning.

The report was adopted without division and it was **RESOLVED**:

#### That the following be added at the end of the Petition Scheme:

Petitions raised and submitted electronically ("ePetitions")

The Council's website contains a dedicated area that enables petitions to be raised and submitted electronically. Such petitions are referred to as ePetitions. An ePetition may be raised by going to the Council's website at <u>www.havering.gov.uk/petitions</u> and following the guidance given there.

Any ePetition raised on the website will be assigned a closing date. Once the closing date is reached, no further signatures may be added to it and its processing in accordance with this Petition Scheme will begin.

ePetitions will be treated in exactly the same manner as petitions submitted using more traditional methods. An ePetition may be submitted in place of, or in addition to, a petition on paper (but any individual may sign only an ePetition or a paper petition, not both).

It will be necessary for those signing a petition electronically to confirm that they are qualified to do so, by providing a postal address in Havering where they live, work or study.

All ePetitions raised on the Council's website will be moderated to ensure that they comply with the requirements of this Petition Scheme. The Council reserves the right to refuse to place on the website any ePetition that does not comply with the Scheme.

#### 44 REVIEW OF HAVERING'S STATEMENT OF LICENSING POLICY FOR THE LICENSING ACT 2003 (agenda item 8)

Council was reminded that, under current legislation, the Council was obliged to prepare a Statement of Licensing Policy and to review it every three years. The existing Statement was about to expire and the Licensing Committee, following a consultation exercise, had carried out the triennial review. Council was now invited to approve a revised Statement, to come into effect on 7 January 2011.

The report was adopted without division and it was **RESOLVED**:

#### That the revised Statement of Licensing Policy be adopted.

#### 45 ADOPTION OF SECTION 16 OF THE LONDON LOCAL AUTHORITIES AND TRANSPORT FOR LONDON ACT 2003 (agenda item 9)

Section 16 of the London Local Authorities and Transport for London Act 2003 empowered the Council to serve Notices on residents who drove across a footway or verge without due authority requiring them to stop doing so. If a resident were to ignore such a Notice, the Council would then have power to carry out works to prevent mechanically-propelled vehicles from being taken across the footway or verge

The Act enabled the Council to recover its reasonable costs of carrying out such work. The installation of bollards at a small number of premises and the associated publicity was expected to encourage residents either to stop crossing the footway without an authorised vehicle crossover or to submit an application to have one constructed in the proper form.

The report was adopted without division and it was **RESOLVED**:

That the powers conferred by Section 16 of the London Local Authorities and Transport for London Act 2003 be brought into force in the borough with effect from 1 April 2011.

#### 48 HOUSING POLICIES (agenda items 12/12A/12B)

#### Motion on behalf of the Labour Group

Council notes:

That everyone is entitled to a secure, affordable, decent home in a safe community;

That the capping of housing benefit payments and its linking to the Consumer Price Index rather than the Retail Price Index will lead to thousands of residents in Havering losing an average of £1000 a year;

That these cuts will hit vulnerable residents in private rented accommodation hardest and will cause a shortfall in the budgets of thousands of families, forcing many to become homeless and ultimately increasing the cost to local government; That every social tenant has a reasonable expectation of a home with a working central heating system, fitted windows and doors and a safe kitchen;

That completing the Decent Homes Programme would create or support hundreds of jobs in Havering with 17 jobs being created for every £1million of refurbishment investment;

That the security and stability of a home, be it privately rented or socially rent, is one of the most important anchors in a family's life and that security of tenure is one of the principle protections provided by social housing; and

That the end of the promise of security of tenure for social tenants will see thousands of Londoners living on shorter, insecure tenancies, constantly in fear of being moved on at the whim of the council into private accommodation they cannot afford.

#### Council resolves:

To write directly to the Housing Minister urging him to cancel the steps the Government has taken to deny families the prospect of a secure, affordable decent home.

To call on the Members of Parliament representing Havering to condemn the stigmatisation of social and private sector rented tenants.

#### 12A Amendment on behalf of the Independent Rainham Residents' Group

Add the following:

[Council resolves] To write to the Prime Minister David Cameron and ask him not to punish poorer members of society for the financial crisis and housing shortage by hiking rents and removing security of tenure from council and social housing tenants.

#### **12B Amendment on behalf of the Administration**

Amend to read:

This Council notes and condemns the damage done to current housing finance through the spending decisions of the previous Labour Government and deplores the historic failure to provide adequate funding for Havering.

The Labour Group motion was debated. At the conclusion of the debate, the amendment by the Independent Residents' Group was **LOST** by 5 votes to 32 (see voting division 1). The amendment by the Administration was then **CARRIED** by 39 votes to 8 (see voting division 2) and adopted as the substantive motion without division.

#### **RESOLVED THAT:**

This Council notes and condemns the damage done to current housing finance through the spending decisions of the previous Labour Government and deplores the historic failure to provide adequate funding for Havering.

#### 50 **DARTFORD TOLL INCREASE (agenda item 14)**

#### Motion on behalf of the Residents' Group

This Council registers its opposition to proposals to increase the Dartford Crossing toll from £1.50 to £2.00 in 2011 and to £2.50 in 2012. As part of the forthcoming consultation process, this Council also agrees to reiterate the approved motion at Full Council on 22 October 2008 to oppose any charges for the use of the Dartford Crossing and that the government should recognise the construction costs have been met and that any future charging is unjust.

The motion was considered without debate and agreed without division.

#### **RESOLVED THAT:**

This Council registers its opposition to proposals to increase the Dartford Crossing toll from £1.50 to £2.00 in 2011 and to £2.50 in 2012. As part of the forthcoming consultation process, this Council also agrees to reiterate the approved motion at Full Council on 22 October 2008 to oppose any charges for the use of the Dartford Crossing and that the government should recognise the construction costs have been met and that any future charging is unjust.

#### MAYOR'S ANNOUNCEMENTS

First, I would like to say thank you to our Council staff who worked hard during the recent severe weather conditions to keep Havering moving and to ensure our essential services were delivered.

I am personally looking forward to a very special date on Friday – our Older Person's Christmas Party at the YMCA. The party means so much to our elderly residents, for many it is their only opportunity to celebrate Christmas. May I say that I am very proud that we are continuing to stage this event.

I am proud to say that we are continuing to attract national recognition for ground breaking initiatives and great inspection results.

I am extremely pleased to tell you tonight, before it is officially announced tomorrow, that our Children's Services has been assessed as 'performs excellently' in the Ofsted Annual Children's Services Assessment.

In addition to this The Care Quality Commission has judged us to be are performing 'well' in the social care we provide for adults.

We have also gained Equality Framework for Local Government Achieving Status for demonstrating consistent improvement of performance in equality, and reflecting this in everything we do.

It is also great news that our Commissioning Adult and Children's Services has been shortlisted for an LGC Award in the Health and Social Care category. This is for introducing a new system which gives vulnerable people in need of care more choice and control over their own support.

I would now like to say well done to the pupils, staff and Governors at Ardleigh Green Infants School for an excellent Ofsted inspection. The Ofsted inspectors said it is an 'outstanding school' where pupils make excellent progress in all aspects of their development.

I have also attended countless prize giving ceremonies across the borough for children of all ages. ## ORAL REPORT BY COUNCILLOR GARRY PAIN, MEMBER CHAMPION FOR YOUNGER PERSONS

As the Champion for younger persons, I have the privilege, not only to serve the people of St Andrews Ward but to represent all the young people of our Borough.

This great honour has not only shown me what a fantastic job this council and all the voluntary and youth groups do for our young people, but reinforce the commitment that this Conservative administration continues to show when it comes to investing in our future.

Over the past few months Madam Mayor I have visited Youth Groups to Theatre Groups, Sports Centres to Art Clubs, Church Groups to Play Centres the list goes on and on.

#### 1 FAIRER CHARGING POLICY: CONSULTATION

To the Cabinet Member for Individuals (Councillor Steven Kelly) By Councillor Linda Van den Hende

Given that consultation on the Fairer Charging Policy appears to have been delayed, can the Cabinet Member confirm that the proposed charges will not be implemented on 1 January 2011 as originally proposed in the Cabinet report of 14 July 2010?

#### Answer:

Following the consultation, and the final decisions regarding which of the proposals will or will not be implemented, a reasonable and fair timetable for implementation will be agreed. The Council will contact any people affected and advising them of any change in their charges. It is likely this will be nearer the 4th of April than the 1st of January, but this will be dependent on the number of people affected and the extent of the changes to fairer charging that are agreed.

In response to a supplementary question, the Cabinet Member undertook to ensure that details of the Equalities Impact Assessment were provided in writing to the questioner but stated that, as all consultees were already known the Council, there had been no special need to identify their specific requirements.

#### 2 STANDARDS COMPLAINT: COUNCILLOR LOGAN

#### To the Cabinet Member for Community Safety (Councillor Geoff Starns) By Councillor Jeffrey Tucker

The Government has announced plans to abolish the Standards Board of England by 2012. This is because the Members Code of Conduct has been abused by councillors to wage political vendettas against political opponents, at taxpayers' expense, which brings local government into disrepute.

How much, as an estimate, did the complaint by former Councillor Mark Gadd, against Cllr Mark Logan cost in Council time and money?

#### Answer:

The abolition of the Standards Board for England is a matter for the government. However, in this case, the decision of the Council's Standards Committee, which resulted in a suspension of Councillor Logan was upheld by the First Tier Tribunal. It can hardly be said, therefore that this was an abuse of process.

The Council's Standards Initial Assessment Sub-Committee concluded that the complaint was sufficient to be investigated. The Consideration Sub-Committee accepted the Deputy Monitoring Officer's recommendations. The complaints made by Councillor Mark Gadd against Councillor Mark Logan were substantiated. Councillor Logan was found to have breached Paragraphs 3 (1) and 5 of the Council's Code of Conduct.

At the Standards Sub-Committee on 19 January 2010, the Sub-Committee not only found those breaches but imposed a sanction of suspension for a period of one month, a requirement that he undertake relevant training and provided that no members allowance be paid to him for the period

of suspension. That decision was upheld by the First-tier Tribunal following Councillor Logan's appeal, judgement being given on 16 August 2010. Councillor Logan sought permission to appeal against that decision which was refused by the First-tier Tribunal.

The Tribunal have indicated that they plan to make a decision on the costs of the proceedings although that has not yet been made. It is therefore possible that there may be some recovery of the costs of the appeal from Councillor Logan. This was clearly an unmerited appeal.

The cost of the internal investigation in notional fees was £3,936.80. It should be emphasised that this is internal time recording information only and is not related to any payment of monies.

In response to a supplementary question, the Cabinet Member reminded Members that elected Councillors should always be open, transparent and accountable in their dealings with the public and with each other

#### 3 SCHOOL SPORTS PARTNERSHIPS: WITHDRAWAL OF SUPPORT

#### To the Cabinet Member for Children & Learning (Councillor Paul Rochford) By Councillor Keith Darvill

What will be the impact on Havering Schools and Colleges of the Coalition Governments decision to withdraw support from the hugely successful School Sports Partnerships?

#### Answer:

The local authority is actively working with the two schools who are involved in running Havering's School Sports Partnership. Both schools are committed, as is the LA, to finding a way to continue this very successful support for sport in schools across the authority.

The authority has already established some "centres and clusters of excellence" in a number of areas and we are discussing with these two schools as to whether this would be a helpful way forward for them. There is a reduced level of LA funding for these partnerships but they would enable the schools to be supported via the structures and systems that are being developed as part of our work for these centres of excellence.

As the funding to support schools now sits within schools budgets, eventually the success of programmes like this will rest on decisions that schools individually and collectively would take themselves. What the authority is working on is to provide a framework and Quality Assurance system to support this.

In the light of resent press coverage should the funding situation change the LA would work collaboratively with schools to support any developments they may wish to see in place

In response to a supplementary question, the Cabinet Member stated that the Council shared with the government a desire to see children increasing their participation in sports activities.

#### 4 HOUSING BENEFIT CHANGES: MOVEMENT OUT OF CENTRAL LONDON

#### To the Cabinet Member for Housing (Councillor Lesley Kelly)

By Councillor Ray Morgon

As a result of the overhaul of housing benefit payments, would the Cabinet Member confirm what, if any, arrangements the Council has put in place to deal with the anticipated influx of residents moving out of Central London into Havering?

#### Answer:

I think it is unlikely that there will be an influx of such applicants to move into Havering because although we do have rents which are below the cap currently, this will change when the additional rule, originally planned to be introduced in October 2011, that Housing benefit can only be paid for rents which are in the lowest third of the market comes in. All 3,000 claimants on Housing benefit in Havering are on rents which are currently above the 30<sup>th</sup> percentile. So, as there is only a very small private rented market in Havering, and an even smaller market available for Housing benefit claimants, I think it is unlikely that new claimants coming into the Borough would be able to find private rented accommodation in Havering.

#### 5 ELECTED POLICE COMMISSIONER FOR LONDON

#### To the Leader of the Council (Councillor Michael White) By Councillor David Durant

The Administration has said they are in favour of directly elected Police Commissioners. In London the GLA Mayor would fulfil this role.

GLA Mayor Boris Johnson has unfavourably compared the Government's housing benefit changes to the conflict in Kosovo!

Does the Administration believe Boris Johnson would make a good Police Commissioner?

#### Answer:

Yes

In response to a supplementary question, the Leader of the Council stated that he did not agree that elected commissioners would fetter the police service.

#### 6 CARAVAN SITES ACT LICENCE AND MODEL STANDARDS 2008

#### To the Cabinet Member for Housing (Councillor Lesley Kelly) By Councillor Paul McGeary

In view of the deteriorating condition of the communal facilities at Sunset Drive Park Home Site at Broxhill Road since its sale by the Council will the administration as a matter of priority exercise its powers to enforce Licence Conditions to ensure such communal facilities are maintained and improved for the benefit of residents?

#### Answer:

As set out in my answer on the Mobile Homes Model Licence Conditions at the last Council meeting, we do not have any intention of exercising our powers to enforce Licence Conditions at this stage. A review of the Caravan Sites is scheduled for the first quarter of 2011.

In response to a supplementary question, the Cabinet Member invited the questioner to provide specific details of issues requiring enforcement for further investigation.

#### 7 NOTIFYING RESIDENTS OF PLANNING APPLICATIONS

To the Cabinet Member for Individuals (Councillor Steven Kelly) By Councillor Brian Eagling

The Planning Department recently sent out a letter to the residents of Harold Wood on a 2nd class stamp with incorrect information. They then had to send another letter with the

correct information on it - this cost the residents of Havering £683. Would the Chairman confirm how thoroughly correspondence is checked/proof read before being sent out?

#### Answer:

The Head of Development and Building Control informs me that outgoing correspondence is routinely checked for accuracy. The extent of specific proof reading depends on the type and purpose of letter involved.

In the case referred to, the main elements of the letter were correct. The letter was sent by first class, not second class post. It contained information about the application reference, the date of Committee at which the application would be considered and information about how the public may seek to speak at Committee. However the letter also contained a development description which didn't include revisions made to the scheme. This technicality would not have been immediately evident to the administrative staff issuing the letters. On realising that there was an inaccuracy embedded within the letter a managerial decision was made to issue a follow up letter clarifying the position for residents and thereby avoiding any confusion for them or members. The Harold Wood proposal involved notification of lots of residents therefore reflecting the postage cost.

<u>In response to a supplementary question</u>, the Cabinet Member stated that the incident in question had been the result of an honest mistake, which was a rare occurrence. Existing procedures were generally sufficient to ensure that correct information was circulated to residents.

### 8 TENANTS TRANSFERRED TO REGISTERED SOCIAL LANDLORDS – USE OF UTILITIES

#### To the Cabinet Member for Housing (Councillor Lesley Kelly)

In the absence of Councillor Mark Logan, the question was asked by Councillor Michael Deon Burton

Are all Council tenants who have had their council dwellings transferred to Registered Social Landlords, the beneficiary of full utilities - the same as what they had prior to transfer?

Councillor Burton clarified the meaning of the question before the Cabinet Member was invited to reply.

#### Answer:

The range of services supplied by a new landlord, including utility supplies, will depend of the Transfer Offer to tenants and the Transfer Agreement between the Council and the receiving Registered Social Landlord. The Transfer Offer itself will have been drawn up in consultation with residents and is distributed to all tenants prior to the transfer ballot.

To date, the only council tenants in Havering who have had their dwellings transferred to a Registered Social Landlord are those on the former Mardyke Estate, now known as Orchard Village, which the Council transferred to Old Ford Housing Association on 31 March 2008.

For those tenants whose homes have been retained and improved to the Decent Homes Standard by Old Ford, there has been no change to their utilities.

In response to a supplementary question, the Cabinet Member agreed to provide the questioner with details of the procedure by which tenants who believed that their rights had been altered could seek redress.

#### 9 COMPACT PARTNERSHIPS

#### To the Cabinet Member for Community Empowerment (Councillor Robert Benham) By Councillor Denis Breading

What proposals have the Administration to form 'Compact Partnerships' consistent with Coalition Government policies?

#### Answer:

Havering already has a well-established Compact Partnership, which is led by the voluntary and community sector and includes representatives of the Council, the NHS, and the Police. The Partnership produced Havering's first Compact agreement in 2004, and has since produced and promoted Good Practice Guides for Communication & Consultation, Funding, Volunteering, and Equalities & Diversity. Continuing support for the Compact is provided by the Compact Steering Group, chaired by the voluntary sector, and a Compact Annual General Meeting is held as part of the Havering Strategic Partnership's Voluntary Sector Conference each year.

In response to a supplementary question, the Cabinet Member expressed confidence that the Regeneration Team would explore every avenue to ensure that Havering was able to obtain the maximum benefit from the wide range of grants available for voluntary sector activity..

#### 10 USE OF CONSULTANTS AND EXTERNAL ADVISERS

#### To the Leader of the Council (Councillor Michael White)

In the absence of Councillor Clarence Barrett, the question was asked by Councillor Ray Morgon

Would the Leader set out how much has been spent on consultants/external advisers and in which departments for 2009/10, 2010/11 to date and the projected figure for 2010/11?

#### Answer:

The majority of this spend relates to the implementation of the Council's Transformation Programme, and particularly where these costs were charged to revenue in 2009-10. This includes the corporate transformation team, and the specific programmes for customer services, internal shared services, and adult's services. The Transformation Programme is helping the Council achieve the £19.6m of savings agreed by Cabinet in July of this year as part of our budget strategy for meeting the anticipated cuts in Government funding.

The only other significant sums relate to the implementation of the Council's IT disaster recovery programme, which is designed to bring much needed resilience to our IT infrastructure, which is a key element supporting the Transformation Programme, and support to the Building Schools for the Future programme, which was supporting the Council's preparatory work.

In broad terms the level of spend is likely to be at least at the same level owing to the Transformation Programme, which is delivering major savings as well as transforming Havering's services. In Social Care & Learning, the overwhelming majority of this work is funded by grant from government.

In response to a supplementary question, the Leader of the Council confirmed that consultants were used for their expertise in areas where expertise was not available in-house.

#### 11 LONDON THAMES GATEWAY DEVELOPMENT CORPORATION: ABOLITION

#### To the Cabinet Member for Community Engagement (Councillor Robert Benham) By Councillor Jeffrey Tucker

When the London Thames Gateway Development Corporation is abolished, how will that impact on the planning process in Havering and Rainham?

#### Answer:

Consistent with its localism agenda, the coalition government has signalled its intention that planning decision making powers should be returned to the Boroughs. Discussion between the Boroughs and the Department of Communities and Local Government have commenced based upon an anticipated return date of April 2011, although this requires legislative changes which DCLG are leading on.

Currently Havering acts as a consultee on applications to be determined by LTGDC, although Havering receives the application fee and manages the notification/consultation process. In taking over the whole of the planning application process, there would be additional work required, particularly in connection with pre-application discussions, negotiating on proposals, agreeing conditions and legal agreements and managing negotiations with statutory consultees. There would also be additional work for the Council in the handling of appeals. The resource implications for the Planning section are currently being assessed.

In response to a supplementary question, the Cabinet Member confirmed that he expected the return of planning powers to the Council to lead to improvements.

#### 12 DECENT HOME STANDARD FUNDING

#### To the Cabinet Member for Housing (Councillor Lesley Kelly)

By Councillor Denis O'Flynn

Will she make a statement about the prospects for a continuation of Decent Homes Standard Funding for the next 4 financial years and the number of properties in the Borough due to be improved as a result thereof?

#### Answer:

The Coalition Government issued a Consultation Paper on 11<sup>th</sup> November, which confirmed the continuation of the Decent Homes Programme. The Consultation Paper sets a deadline for Local Authorities who have more than 10% non decent stock, to bid for the resources that have been made available in this programme. There is £1.6bn available for 49 authorities including Havering, and the funding is designed to bring 150,000 properties back up to the Decent Homes Standard. Havering will be submitting a bid for funding by the deadline, which is 11<sup>th</sup> January 2011, with the aim of bring all the remaining 57% of our housing stock which is currently non decent, back up to the Decent Homes Standard. However, this is likely to be spread over a longer period of time, than the next four years. Once we have received our allocation in February/March 2011, I will be able to confirm how many properties can achieve the Decent Homes Standard in the next four years.

<u>In response to a supplementary question</u>, the Cabinet Member agreed that she would consider how best to communicate to tenants progress with the Decent Homes Programme.

#### 13 TREES OVERHANGING PRIVATE PROPERTIES

#### To the Cabinet Member for Environment (Councillor Barry Tebbutt)

By Councillor Ray Morgon

Would the Cabinet Member explain why he allows residents properties to sustain damage as a result of trees overhanging their properties?

#### Answer:

If StreetCare are made aware of issues of overhanging highway trees, they will be inspected to ascertain what pruning is required as appropriate.

#### 14 VILLAGE GREEN APPLICATIONS: HOLDING OF PUBLIC INQUIRIES

#### To the Cabinet Member for Community Engagement (Councillor Robert Benham) By Councillor David Durant

When will the Public Inquiries into the Abbs Cross, Ongar Way and Gooshays Village Green applications be held? And can you explain how the rules regarding the 'appropriation of land' could impact on these applications.

#### Answer:

The applications for registration of parcels of land at Ongar Way and Abbs Cross have been registered and advertised and dates are currently being sought for non-statutory public inquiries in respect of both sites in the New Year. The application for a parcel of land east of Gooshays Drive has not yet been registered and the applicant has been invited to correct a number of issues with the application which are holding up its registration and advertising.

Prospective developers of land are increasingly concerned about any issues that affect the title of the land that they are seeking to acquire and the appropriation of land for planning purposes would reduce these concerns. The effect of appropriation for planning purposes, in conjunction with Sections 237 and 241 of the Town and Country Planning Act 1990, is that if there were any restrictive covenants affecting the land these would be cleared and appropriation would take precedence over applications to register land as town or village greens.

#### 15 HOUSING WAITING LISTS – OVERCROWDING

#### To the Cabinet Member for Housing (Councillor Lesley Kelly)

By Councillor Pat Murray

How many Havering families on the Councils Housing waiting list are currently living in overcrowded homes?

#### Answer:

At 1 December 2010, there were 1,186 overcrowded households on the Housing Register, living in Havering and requiring at least one extra bedroom to be regarded as adequately housed.

#### 16 **PUBLICATION OF ITEMS OF EXPENDITURE**

#### To the Leader of the Council (Councillor Michael White) By Councillor Ray Morgon

Would the Leader confirm that all items of expenditure over  $\pounds$ 500 will be made public from 1<sup>st</sup> January 2011?

#### Answer:

The Council firmly supports the principle of transparent government and will be publishing this information in accordance with the guidance issued by the Secretary of State. All payments over the £500 threshold will be published apart from those exempted on the grounds of the Freedom of Information Acts, The Data Protection Act and the Environmental Information regulations. All other payments will be published and any commercially sensitive or privately confidential information will be redacted or removed. The Council intends to fully comply with the requirements of the regulation from January.

#### 17 WALKWAY BETWEEN VIKING WAY AND UPMINSTER ROAD SOUTH, RAINHAM

#### To the Cabinet Member for Community Engagement (Councillor Robert Benham) By Councillor Mark Logan

I welcome investment in the Rainham Walkway, but what was the total cost of, and who funded, the Walkway and folly between Viking Way and Upminster Road South.

#### Answer:

The Council secured significant external funding for this vital link between the car park and the Village centre, and the Walkway is being funded by the following agencies:

Although open, final elements of the scheme are still being constructed and as Members are aware, the scheme has encountered significant problems, which has necessitated additional works by the contractor. The final cost of the scheme is, therefore, still under negotiation with the contractor to seek to ensure the capital cost of the works is kept within the overall budget available.

#### 18 HOUSING BENEFIT PROPOSED CHANGES: IMPACT ON HAVERING

#### To the Leader of the Council (Councillor Michael White)

By Councillor Keith Darvill

What is the predicted impact on the Borough of Havering of the Coalition Government's proposals in respect of Housing Benefit?

#### Answer:

The Housing Benefit staff have done a detailed analysis of the impact of the proposed changes to Housing benefit, and they have been working with staff in the Housing Department to work together to deal with the proposed changes. Members will be aware that there are a number of changes which were proposed which included:

- A fixed cap in the amount of money that Housing benefit would pay, for different sized properties (the Local Housing Allowance Rate or LHA rate). This proposal was originally intended to come into effect on 1<sup>st</sup> April 2011
- A calculation of the LHA rate based on the 30<sup>th</sup> percentile this was due to come into effect in October 2011
- The calculation of Housing Benefit for people on Job Seekers Allowance (JSA) at 90% of the rent, if they have been on benefit for 12 months. This was due to come into effect in April 2013

- All benefits are due to be uprated in line with Consumer Price Index from April 2013
- Claimants who are between the ages of 25 and 35, who currently are entitled to LHA for a one bed property, will in future only be entitled to a room in a shared housed or "the shared room rate". This change is due to come into effect in October 2011.
- An increase in the non-dependant deduction rate effective from April 2011.

There has been a lot of concern expressed about the scale and speed of the changes, and I can say that clearly, the Government have listened and responded to some of those concerns. There have been some recent changes to the proposals announced, which have the effect of enabling claimants to have more time to prepare for the changes. The amendments to the proposals are:

- Only new claims will be capped, from April 2011
- The rule that the LHA rate will be calculated at the 30<sup>th</sup> percentile has been brought forward for new claimants to April 2011
- All existing claimants will not have their Housing benefit re-assessed until the date of their Housing benefit renewal and then they will be granted a 9 months transitional period to either negotiate a lower rent, or seek alternative accommodation. This phases in the cap until December 2012 when all LHA claimants will be subject to it.
- Housing Benefit can be paid directly to landlords, where landlords are reducing their rents in line with the new LHA or a level close to that.

Staff have calculated the number of residents affected by the changes based on current LHA caseloads.

- There are 149 households affected by the change in the Shared room rate. They will lose on average £82 per week
  - Other claimants are all affected by the change to the 30<sup>th</sup> percentile. These are:
    - 260 households in shared accommodation who will lose £6 per week;
      - o 789 households in one bed accommodation who will lose £5.75pw
      - o 1365 households in two bed accommodation who will lose £10.35pw on average
      - o 494 households in 3 bed accommodation who will lose £11.31pw
      - o 120 households in 4 bedroom property who will lose around £34 per week and
      - 16 households in 5 bed accommodation who will be paid benefit only at the 4 bed rate in the future.

#### 19 UNAUTHORISED ABSENCE FROM SCHOOL: FINING PARENTS <u>To the Cabinet Member for Children & Learning (Councillor Paul Rochford)</u> By Councillor John Wood

None have been issued. Fly-tipping is an offence for which there is no authority or power to issue a fixed penalty notice, and it is an offence which carries a maximum penalty of an unlimited fine and a term of imprisonment. It is an offence which must be heard by a Court.

#### 22 OUTLYING CAR PARKS: INCOME

Would the Cabinet Member advise if any consideration has been given to powering illuminated street signs by solar panels (similar to the vehicle activated 30 mph warning signs) as this may generate savings in energy costs and be more environmentally friendly?

#### Answer:

To convert to Solar power would be expensive and the return would not be seen for over 25 years.

However StreetCare staff along with colleagues in Finance & Commerce are currently exploring options to –

- de-illuminate any signs that do not need to be lit;
- put photocells in all signs so as to reduce burning hours from 24hrs to dawn-to-dusk, saving around 66% in energy; and
- replace the electrical equipment in the signs with LED which will save around 30% energy compared to a normal Fluorescent type.

#### 27 QUEEN'S THEATRE: TICKET SALES

To the Cabinet Member for Towns & Communities (Councillor Andrew Curtin) By Councillor Ray Morgon

During the last 12 months to the end of October 2010, would the Cabinet Member advise how many tickets were sold for all events and performances at the Queens Theatre?

#### Answer:

#### 28 STREET LIGHTING: HOURS OF OPERATION

#### 29 MANDATORY COUNCIL SERVICES

#### To the Leader of the Council (Councillor Michael White) By Councillor Ray Morgon

Would the Leader of the Council provide a list of all services that have to be provided by law?

#### Answer:

There is no definitive list and in order to complete this substantial piece of work resources would have to be re-directed from other parts of the organisation.

Just as an indication of the level of work, the Council's Constitution contains some statutory provisions which can be found in Part 3, Section 4. Councillor Morgon will see the difficulties here in that some of the powers are described as powers and some as duties and there are 53 of these just relating to functions which cannot be the responsibility of the Executive.

Given the wide range of legislation affecting local government each legislative provision would need to be considered to determine if it was a power, a function or a duty. In respect of those where there was a duty, consideration would then need to be given to the level of that duty and whether there was a discretionary element.
