## Control of microphones

## MAYOR'S ANNOUNCEMENTS

March is a very busy time for the Council with the setting of the council tax. And as usual this has been a smooth process, performed efficiently and effectively. I would like to thank everyone involved.

I am also pleased to announce that the Council's Housing Service has been awarded four stars under the Audit Commission's new Comprehensive Performance Assessment.

The service was assessed as being accessible and effective. It now takes only two days to be registered on the housing list. And 95\% of homeless people submitting a housing application can expect a decision within 33 days, which is far higher than the national average. Well done to colleagues in the Housing team.

I recently visited Gaynes School to help judge the 'Gaynes Factor' talent competition. There was a fantastic turnout, with over 300 young people and parents attending the event.

I presented the winner of the competition, Abbie Snelling, with the Shooting Star trophy. I was impressed by the high level of talent from all of the students. It is always great to see the quality of the acts that take part in competitions involving our young people.

I also went along to James Oglethorpe Primary School to find out more about the work of School Councils. Six School Councils, composed of students that were elected representatives of their school, attended the event.

The event was a way of exchanging student views on best practice at the various schools. It was very impressive to see such a positive and mature approach from the young people towards solving problems and improving school life for their fellow students in Havering.

I also opened the Council celebrations of International Women's Day at the Town Hall. The event paid homage to the achievements of local women and their contribution to the community.

I joined the celebrations with distinguished guests Asad Ahmed, from BBC London, Chief Executive Cheryl Coppell and Stephanie Miller, Chief Executive of Homes in Havering. It was great to see such widespread support and interest for a subject which affects millions of women everyday.

The opening of Sainsbury's at Hilldene shopping centre in Harold Hill was a great success and very well attended. I'm sure the store will be warmly received by local people and ties in very well with the Council's regeneration plans for Harold Hill

I was delighted to take part in 'The Best of the Best', Havering's first Book Awards. A number of both primary and secondary schools took part, with eight winners being chosen from over 100 entrants. I presented the winners with their awards and was pleased to see such enthusiasm towards an important subject like reading.

I attended St. Alban's Catholic Primary School as they performed the play 'Easter Passion'. This was a play that told the Easter story with a modern twist. It was great to see
pupils having fun, and expressing their talents whilst still conveying the message of Easter so clearly.

I'm delighted to say that I was on cue when I unveiled a statue, commissioned by the Council, to commemorate the opening of the new affordable housing complex at Eldon Court, Romford. Called simply 'Queue', it is a representation of Romford's past, present and future.

It depicts a bus queue: a man holding a snooker cue represents Romford's nationally renowned snooker club; another is holding a bowling ball as the site is formerly a bowling green. A woman carrying shopping bags refers to the current use of the site, and right at the front, a lady leads a child - signifying the future of Romford.

The statue endorses all that we know. That Romford, and indeed all of Havering, has a past to celebrate, a present to be proud of and a future we can all look forward to.

## MEMBERS' QUESTIONS AND ANSWERS

1 Removal of street trees To the Cabinet Member for StreetCare (Councillor Barry Tebbutt) By Councillor Clarence Barrett

How many street trees have been removed in each of the last three years?

## Answer

In the last 3 years we have removed 1,278 trees of which 640 were dead, dying or diseased, 289 were high risk, 79 were vandalised or hit by vehicles, 218 were removed because falling fruit causes problems and the remainder were ad-hoc removals.

In the same period 1,288 trees were planted.

## 2 Fly tipping - enforcement

To the Cabinet Member for StreetCare (Councillor Barry Tebbutt)
By Councillor Clarence Barrett
In each of the last three years, what is?
a) Number of fly tips reported
b) Number and value of fixed penalty notices issued
c) Collection rate of fixed penalty notices issued
d) Number of related prosecutions

## Answer

The StreetCare Enforcement team was established in August 2005. During the formative process and whilst policies were being developed, the primary response was to provide educational campaigns, guidance and written warnings.

In April 2006 Cabinet formally agreed the StreetCare Enforcement Policy, Which follows the general principles of Advice, Warning, Enforcement. In some circumstances the policy permits escalation to a more significant response earlier in the process. The Better Havering Campaign formed the backbone of advice and guidance, when added to increased enforcement action, this resulted in a reduction in fly-tips in 2006-07 when compared with the preceding year. DEFRA recognised the improved performance by awarding Havering a Best Value performance indicator grading of Very Effective for BVPI 199d.

I have the figures for each of the last three years here, and will provided Councillor Barrett with a copy at the end of this meeting.

## 3 Brookway playsite - fencing repair To the Cabinet Member for Environmental \& Technical Services (Councillor Paul Rochford) <br> By Councillor Jeffrey Tucker

In order to prevent an accident, could this Council please assist by re-erecting the fencing between Brookway Playsite and the road, without any further delay?

## Answer

In response to receipt of this question, officers from the Parks and Open Spaces Service, in conjunction with a Health and Safety Officer, immediately undertook a Risk Assessment of the site, in order to ensure that those using the park were in no immediate danger. The assessment states the risk of accident is low.

In order to improve the appearance of the site and tidy up the damaged chainlink fencing, measurements were obtained to replace the chainlink fence with a bowtop railing. We estimate these works to cost approximately $£ 3,500$ and this will be added to a list of schemes that are being placed in the capital programme of parks improvement works for 2008/09.

Answer
The car started operating $8^{\text {th }}$ June 2007. Since then 21,289 Penalty Charge Notices or PCNs have been issued.

To put these figures in context, the total number of PCNs issued by the Parking Service (by CCTV car and parking attendants on foot) from 1/4/07 to mid February 2008 was 44,150 - this total is $1.3 \%$ higher than the equivalent period in 2003/4. Hence while the CCTV car is a more efficient means of carrying out parking enforcement, it largely substitutes for PCNs previously issued by parking attendants on foot.

8 CCTV car: issuing of parking tickets around schools
To the Cabinet Member for StreetCare (Councillor Barry Tebbutt)
By Councillor Andrew Mann
Can you tell me how many tickets the CCTV Car has issued to vehicles parked around schools, with a breakdown of the top twenty across the Borough.

## Answer

The database in Parking Services records the road in which each PCN is issued, but does not distinguish whether a ticket is issued in conjunction with enforcement around schools during the 'school run' period, or general enforcement at other times. However, records maintained by the parking attendants indicate that a total of 586 PCN's have been issued, the top 20 schools being as follows

10 Large Coach Fleet: cessation of provision
To the Cabinet Member for Sustainable Communities \& Health (Councillor Steven Kelly)
By Councillor Barbara Matthews
Can you please explain the reasons why you have decided to cease provision of the Large Coach Fleet.


#### Abstract

Answer The basic problem is one of economics. Four of the seven large coaches are in need of replacement due to high maintenance costs and the inability to meet the London Emission Zone Standards that come into force in June 2008. The remaining three coaches will not meet the emission standards for 2012 and will need to be replaced. All of these vehicles are in excess of 10 years old, the retention of three vehicles which do meet the emission standards would not generate sufficient revenue to justify their retention, and would make an operational loss.

The cost of a low specification replacement coach, to replace the four that do not meet the emission zone standard, suitable for school swimming and educational visits would be $£ 160,000$ each. Second hand vehicles with engines that would meet the emission standards for 2012 and beyond are in short supply as commercial operators rush to secure them for their own operations.

There is also the problem that very nearly half of the large coach work is ad-hoc which is taking trips to the continent, trips across the country, various other trips, and the basic vehicles of $£ 160,000$ each would be inadequate and uneconomical.

Passenger Transport Service will give advice to schools on the procurement of large coach trips from commercial suppliers, and also have provided details of other local authorities who could be able to assist in the provision of transport for school swimming.

There is no question of us stopping or reducing the number of special educational needs coach traffic, or social services day care or other services.

## STANDARDS COMMITTEE: EFFECTS OF THE STANDARDS COMMITTEE (ENGLAND) REGULATIONS 2008

The Standards Committee (England) Regulations 2008 were laid before Parliament on 17 April and came into force on 8 May. These long-awaited Regulations change the approach to handling allegations that a member or co-opted member (or former member or co-optee) has failed to comply with the Members' Code of Conduct: complaints will now go direct to the Standards Committee rather than to the Standards Board for England, and most will be dealt with at local level.

The Regulations hold no particular surprises: the Standards Committee must continue to consist of at least $25 \%$ independent members and no more than one Cabinet member. The Standards Committee must, however, establish separate Sub-Committees, each chaired by an Independent Member, to undertake

- the initial assessment of the allegation (the so called "initial sift")
- a review of an initial sift decision to take no further action when requested by any party to the complaint

Standards Committees may hear complaints that have been investigated, or establish Sub-Committees to do that, but either must be chaired by an Independent Member.

At least three members (including at least one elected member of the Council and one Independent Member, in the chair) must be present at any meeting of the Committee or of a Sub-Committee but any Member who sat on a SubCommittee doing an initial sift cannot sit on a subsequent Sub-Committee reviewing the outcome of that initial sift. It is, however, permissible for any of the Members/Independent Member who sat on either the initial sift or any review to sit on the actual hearing.

The Committee considered a report (which had also been considered by the Standards Committee, whose recommendations were taken into account by the Committee). Guidance from the Standards Board and officers' advice was that consideration ought to be given to increasing the Independent Members by one and the Councillor Members by three. This would maintain the
requisite $25 \%$ membership of Independent Members, to give a "pool" of nine Councillors and three Independents from which to draw two members and one Independent to deal with the initial sift and two different members and one different Independent Member to deal with any review of an initial sift decision. It would provide a greater pool of Members (one further Independent and three further Councillors) from which to draw any hearings Sub-Committee and/or to provide a safety net should any Members or Independent Member not be available for a particular meeting.

There will be an inescapable obligation to ensure that any initial sift is undertaken within 20 days of receipt of a complaint. Information on performance indicators must also be reported to the Standards Board on time taken on decision making etc. The expectation is that this will be done on a quarterly basis.

The Committee accepted the Monitoring Officer's view that, if the number of Independent Members were not increased by one, then the Council could be in a vulnerable position since Independent Members cannot be appointed without a lengthy recruitment process by Council. If one of the current Independent Members were to resign or be unavailable for a period of time then the Council would not meet its performance indicators and would be acting contrary to any Guidance as it would not be possible to deal with any complaints within the timescales. It was noted that the Standards Board now had intervention powers which it would exercise if it considered that the Council or Standards Committee were failing in their duties.

Although the Council is currently compliant with the Regulations there is no leeway to cope with any additional meetings of the Standards Committee or the need for different Independent and Councillor Members for SubCommittees dealing with the initial sift and any subsequent review. There is a serious risk of non-compliance should either of the two current Independent Members not be available within what are now short timescales. This will mean that the Council is at risk of not complying with the Guidance and/or of failing the performance indicators, which among other things would inevitably impact adversely on the Council's CPA score.

The Standards Committee had proposed that the new arrangements be reviewed after six months' operation, with which this Committee concurred. This Committee also agreed to consider further the basis for setting the terms of office of Independent Members. The Committee considered a number of recommendations of the Standards Committee, adopted them and now RECOMMENDS as follows:

That, having regard to the likelihood that the workload of the Standards Committee will be greatly increased in consequence of the recent changes in legislation:

1 The number of Independent Members of the Standards Committee
be increased to three

2 The number of Councillor Members of the Standards Committee be increased to nine (5:2:1:1)

3 Separate Sub-Committees of the Standards Committee be established to assess, review and hear complaints, each comprising an Independent Member as Chairman (as required by law) and two Councillors selected without regard to political balance considerations, such Sub-Committees to be appointed as need arises and in accordance with current working practices

4 The Assistant Chief Executive, Legal \& Democratic Services, be authorised to amend the Constitution as necessary to give effect to these recommendations

The appointment of Independent Members of the Standards Committee is a matter for the Council to decide, and it is anticipated that a further report on these issues will be presented at the next meeting.

The recommended increase in the number of Councillor Members is dependent upon the appointment of an additional Independent Member, and cannot be effected until then.

## Adjudication and Review Committee

1.1 The major part of the work if this Committee is carried out through Hearings Panels. The composition of Hearings Panels varies according to the nature of the issue adjudicated - as indicated in the following table:

## Type of hearing

Corporate complaints procedure (including housing tenants' complaints)

Children Act complaints

Adult Care complaints

Housing tenancy appeals

Membership of Panel
Three Members and a non-voting independent person

Three independent persons (one as chairman) with voting rights (to accord with legal requirements, elected Members may no longer serve on this type of Panel)

Two independent persons (one as chairman) with voting rights and one Member (to accord with legal requirements, no more than one elected Member may serve on this type of Panel)

Three Members
1.2 The independent persons used for such hearings are taken from a pool of such people appointed on behalf the Adjudication \& Review Committee, managed by Democratic Services, who have received training appropriate to that role.

## Pensions Committee

2.1 The Pensions Committee is responsible for the management of the Council's Pension Fund investment portfolio.
2.2 Although not strictly Members of the Committee, in accordance with the Constitution, two representatives of the staff are appointed by the unions to attend and contribute to meetings of the Committee. These appointees have no voting rights but are present during the discussion of any exempt business.

## Children's Services Overview \& Scrutiny Committee

3.1 The law requires that the Council co-opt to this Overview \& Scrutiny Committee one representative of each of the Anglican and Roman Catholic Churches, with voting rights, to attend when issues relating to Education are being discussed. In practice, they are also able to contribute to other discussions.
3.2 In addition, the Council's Constitution provides for the co-option of three non-voting members representing governors of schools in the three sectors of education, primary, secondary and special. Again, they may attend when issues relating to Education are being discussed.
3.3 Finally, there are three non-voting members representing local teacher unions and professional associations, nominated by those organisations.

## POLITICAL BALANCE

1.1 Annex A sets out in detail the principles of political balance that the law requires the Council to conform to, and discusses the application of those rules to the current political make-up of the Council.
1.2 In broad terms, each Group of members is entitled to take seats on Committees in proportion to the total number of Members that belong to it. There is discretion as to the size of Committees and thus the total number of places available for allocation, although for reasons of practicality - not least ensuring that sufficient Members are available from each Group to cover its meeting obligations - the total number of seats (assuming that the number of Committees does not change) is always likely to be in the range 108-120 with individual Committee sizes varying from 6 to a maximum of 15 .
1.3 Within the overall number of seats available, some adjustment is needed to ensure, so far as practicable, that each Group has its due share of seats and that the allocation of seats between the Groups on each Committee reflects their respective proportions of the Council's membership.

### 2.1 There is no perfect answer.

2.2 The first step is to agree the sizes of the individual Committees; the allocation of seats to each Group then follows the formula referred to in Annex A; then finally, adjustments are required to the outcome to ensure that, overall, each Group receives its appropriate share of the total number of seats to be allocated.
2.3 The Council is free to agree different arrangements from those prescribed by law, so long as no Member votes against them. Should any such "different arrangements" be voted against, however, then a "default" position would need to be applied: in the absence of agreement otherwise, that would ordinarily mean that the sizes of Committee specified in the Constitution would have to be applied and adjustments made within that to secure the best approximation to the proportion to which each Group is entitled.

## Making the necessary adjustments

3.1 In determining where adjustments should be made to achieve the overall balance, it is necessary to consider whether there are any particular Committees on which it is more important for all Groups to be represented than others. Although highly desirable, it is clearly impossible for each Group to be represented on all Committees (all else aside, meeting commitments for individual Members would then
be difficult, if not impossible, to fulfil). Compromise is therefore essential.
3.2 Under current arrangements, the Rainham \& Wennington Independent Residents and Labour Groups have their greatest entitlement to seats on the Adjudication \& Review, Governance, Licensing, Regulatory Services and Standards Committees, which are the Committees regulating the Council's business or dealing most with the community and which have tended to have larger memberships than other Committees.
3.3 The proposed allocation of seats in Annex B has been prepared accordingly. It should be noted that the Annex assumes that Council will agree the proposals in the separate report of the Governance Committee on revising the size of the Standards Committee.

### 3.4 Annex B is considered to represent the default position.

## Area Committees

4.1 The Area Committees are not politically balanced because they are constituted under the special rules for Area Committees, with membership confined to Members in each particular Area.

## POLITICAL BALANCE PRINCIPLES

1.1 Counsel has advised that, in allocating seats on Committees to the Groups, the Council has a duty to make only such decisions as give effect, so far as reasonably practicable, to certain principles set out in the relevant legislation. As the current situation at Havering is that one Group (the Conservative Group) has an overall majority but there are several Groups and three Members who are not in any Group, the relevant principles are, in order of priority:

1. Not all of the seats on any Committee may be allocated to only one Group (note - the Cabinet is not a Committee).
2. The majority of seats on each Committee must be allocated to the Group having a majority of Members of the Council.
3. The total share of all the seats available for all of the Council main Committees allocated to each political Group must be proportionate to that Group's share of the total Council membership.
4. So far as can be done without conflicting with the other principles, the total number of seats on each Committee allocated to a political Group must be proportionate to that Group's share of total Council membership.
1.2 Moreover, in determining entitlements to seats, members who are not in a Group are disregarded, as they are not entitled to a seat on any Committee; but the proportions on which entitlements are calculated must relate to the total number of Councillors.
1.3 In practice, Committees are balanced against the overall total of Committee places and then, so far as that overall total allows, each Committee is balanced on its own. With the distribution of seats on the Council that results from the election, it is inevitable (a) that the smaller Groups will not be able to be represented on every Committee, (b) that one Group's representation on some Committees will be at the expense of another's and (c) that, with calculations made as accurately as possible, one or more Groups may have actual seat numbers that differ from their entitlements.
2.1 The Council may make arrangements different from those prescribed provided that no Member of the Council votes against those different arrangements.
2.2 To make such a decision each member of the Council must at least be sent an agenda indicating that the approval of alternative arrangements is to be considered. The agenda for this Annual Council meeting meets this requirement. To accommodate this requirement this report should be treated as giving due notice so that there is no impediment to such a proposal being made.
3.1 Once the allocation of seats to Groups in accordance with the statutory procedure is undertaken, the Council is under a duty to make appointments to each Committee so as to give effect to the wishes expressed by that Group about who is to be appointed to their allocated seats.
3.2 The "wishes of the Group" may be communicated to the Chief Executive (or the Democratic Services Manager [DSM] on her behalf) by notice in writing by the Group Leader (or on his/her behalf by a recognised deputy) and will be implemented forthwith. Changes may be effected at any time by notice to the Chief Executive (or DSM) and will be notified to all Members in the next available edition of the weekly Calendar Brief.
3.3 It should be noted that the Chairmen and Vice-Chairmen of Committees (other than the Area Committees, which make their own appointments) are appointed by Council and any change in membership affecting a Chairman or Vice-Chairman will therefore require consideration by Council, and be dealt with by formal motion.

## PRINCIPLES FOR ALLOCATION OF SEATS ON COMMITTEES

4.1 The principles of seat allocation follow the requirements of the political balance principles, using a formula that takes account of the respective sizes of the Groups and the number of seats on Committees available for distribution among the Groups.

## Basic allocation of seats

5.1 The Regulations specify that the minimum size of a Group is two Members. As seats are allocated on the basis of Groups, Members who do not belong to a Group do not have a right to be allocated any Committee seat.
5.2 Of the 54 current Members of the Council, 33 (61.11\% of the total) are Members of the Conservative Group, 13 (24.07\%) of the Residents' Group, 3 (5.56\%) of the Rainham \& Wennington Independent Residents Independent Group and 2 (3.70\%) of the Labour Group. There are three Members not in a Group (also 5.56\% of the total).
5.3 The seat entitlements of the Groups are determined by a formula using the above percentages, operating through a sequence of stages as follows:

- First, the percentage of each Group's membership of the Council is calculated to two decimal places.
- Next, that percentage is applied to the number of seats available on each Committee to determine each Group's potential entitlement to seats on that Committee. Where the resulting figure is not a whole number, it is rounded to the nearest whole number following the mathematical convention that numbers below 0.5 are rounded down, and those 0.5 or more are rounded up.

In some cases, a Group may be entitled to a seat even though, rounded down, its potential entitlement appears nil (i.e. less than 0.5 ), as there is a specific number of seats available on each Committee and no Group may have more seats on any Committee than its entitlement.

The table below shows the basic allocation on the basis of these principles to Committee sizes ranging from 3 Members to 15:

Table


Those figures are then applied to the total number of seats available on each Committee, the seats being allocated in order, highest entitlement first, until all seats have been allocated.

- Finally, fine adjustment is required to ensure that, so far as reasonably practicable, the seats allocated reflect the overall proportion of Council membership held by each Group and the numerical strength of its entitlement to seats on particular Committees. For that purpose, at this stage the seat allocation of particular Committees will be adjusted from the ideallybalanced number reached in earlier stages of the process.


## Specific allocations

6.1 For the allocation of seats on specific Committees, several permutations are possible. Although the Council's Constitution does specify particular numbers of seats to each Committee, it is expressed as being "or such other number as the Council may agree", so there is discretion as to Committee sizes.
6.2 Once the number of seats available on each Committee has been determined, the allocation of seats to the individual Groups would then need to be adjusted between the Groups to achieve, so far as possible and practicable, an allocation that gives each Group its proportionate share of seats overall while ensuring that each Committee is proportionately balanced. In practice, it will be impossible to achieve both aims without enlarging Committee memberships to an unworkable size, so a degree of compromise is required.

## ANNEX B

## RECOMMENDED SEAT ALLOCATION

1.1 Having regard to the principles of political balance and of seat allocation referred to in Appendix 1, the following allocation of seats is now recommended on the basis that, taking all factors into account, it shows a "reasonably practicable" allocation of seats and is therefore the default position.

1.2 The permutations are not perfect but follow, as nearly as practicable, the considerations and principles discussed earlier:

- All Groups are represented on the Governance, Licensing, Regulatory Services and Standards Committees
- The three largest Groups are represented on the Audit and Adjudication \& Review Committees
- The "seats differing from entitlement" are a consequence of the proportionality calculations discussed in this appendix
- Committee seats are allocated, and each Committee is balanced, as "reasonably practicably" as possible
- Because of its special nature, with representation of all Groups highly desirable, the Standards Committee is not politically balanced

## REPORT TO COUNCIL <br> APPOINTMENT OF STATUTORY LEAD MEMBER FOR CHILDREN'S SERVICES

Section 19 of the Children Act 2004, which requires local authorities to designate one of the number as "Lead Member for Children's Services", was brought into effect on 21 March 2008. The Council is, accordingly, now obliged to make such an appointment. This is the first meeting since the legislation was brought into force at which the making of an appointment can be considered.

The scope of the duties of the Lead Member as set out in the Act effectively mirrors the portfolio of responsibilities attached to the Cabinet post of Member for Children's Services, albeit that the portfolio is described using different terminology.

The Governance Committee accordingly considers that the Cabinet Member for Children's Services should also be designated as the statutory Lead Member. The designation would be by post rather than by person, so that, should the post holder change, the designation would automatically apply to the incoming Cabinet Member.

That the Committee RECOMMEND to Council:
1 That the Cabinet Member for Children's Services be designated as statutory Lead Member for Children's Services.

2 That the Assistant Chief Executive, Legal \& Democratic Services, be authorised to make all necessary consequential adjustments to the Constitution.
