4. **Details of Representations**

Representations Objecting to the Application

Seven written representation were received from members of the public who lived in the vicinity of the premises or on a transitory route from the premises.

The written representations related to the prevention of public nuisance and the prevention of crime and disorder. Residents were concerned that additional hours would lead to an increased possibility of noise nuisance and disturbance from patrons leaving the premises at an unsociable hour.

Mr Evans and Mr Borley attended the Hearing. Both residents contended that the additional hour to 1am during the week was unreasonable in a residential location, however they considered an additional hour on Friday and Saturday night to be more appropriate.

Responsible Authorities

Chief Officer of Metropolitan Police ("the Police")

A representation against the application was made by the Metropolitan Police.

The Police representation raised concerns regarding the request for a further additional hour until 1am in a predominantly residential area. The Police contended that the weekday hours currently permitted were more than sufficient for a premises in a residential location. The Police considered that it would be difficult to contest an additional hour on a Friday and Saturday night.

5. **Determination of Application**

Consequent upon the hearing held on 9 March 2007, the Sub-Committee's decision regarding the application for a variation of a Premises Licence for the Coach House was as set out below, for the reasons shown:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

In making its decision, the Sub-Committee also had regard to the Guidance issued under Section 182 of the Licensing Act 2003 and Havering's Licensing Policy.

In addition the Sub Committee took account of its obligations under s17 of the Crime and Disorder Act 1998, and Articles 1 and 8 of the First Protocol of the Human Rights Act 1998.

Non-standard timings

In addition to the use of Temporary Event Notices allowed under the Licensing Act 2003, the premises may open on 12 non-standard occasions (this

includes an annual charity fund-raising event to be held on a non-specific date in August), in line with the Association of Chief Police Officers guidelines; subject to a minimum of 10 working days' notice being given to the licensing authority and the Police for each occasion. The prior written consent of the Police shall be obtained and the police shall have absolute right to refuse any occasion. A register shall be kept at the premises in the manner required by the Police and the Licensing Authority and available for inspection by the police or an Authorised Officer of the Licensing Authority and details of each occasion shall be recorded in it including the written consent of the police. The request for removal of the embedded restrictions was denied.

7. Conditions

That, having regard to the undertakings given on behalf of the applicants, the following conditions be placed on the licence:

(a) The applicant is to ensure that the patio area at the front of the premises facing Main Road is closed off for use by patrons by 22:00 hours.

In making its decisions the Sub-Committee took account of the licensing objectives and in particular the prevention of public nuisance which it must promote in carrying out its functions. The Sub-Committee was of the view that the application has been granted to the greatest extent possible whilst promoting the prevention of public nuisance and the licensing objectives generally. The limitation on the hours sought and the conditions imposed on the licence were the minimum intervention in the applicant's right to enjoy its property that the Sub-Committee could impose whilst carrying out its functions appropriately.
