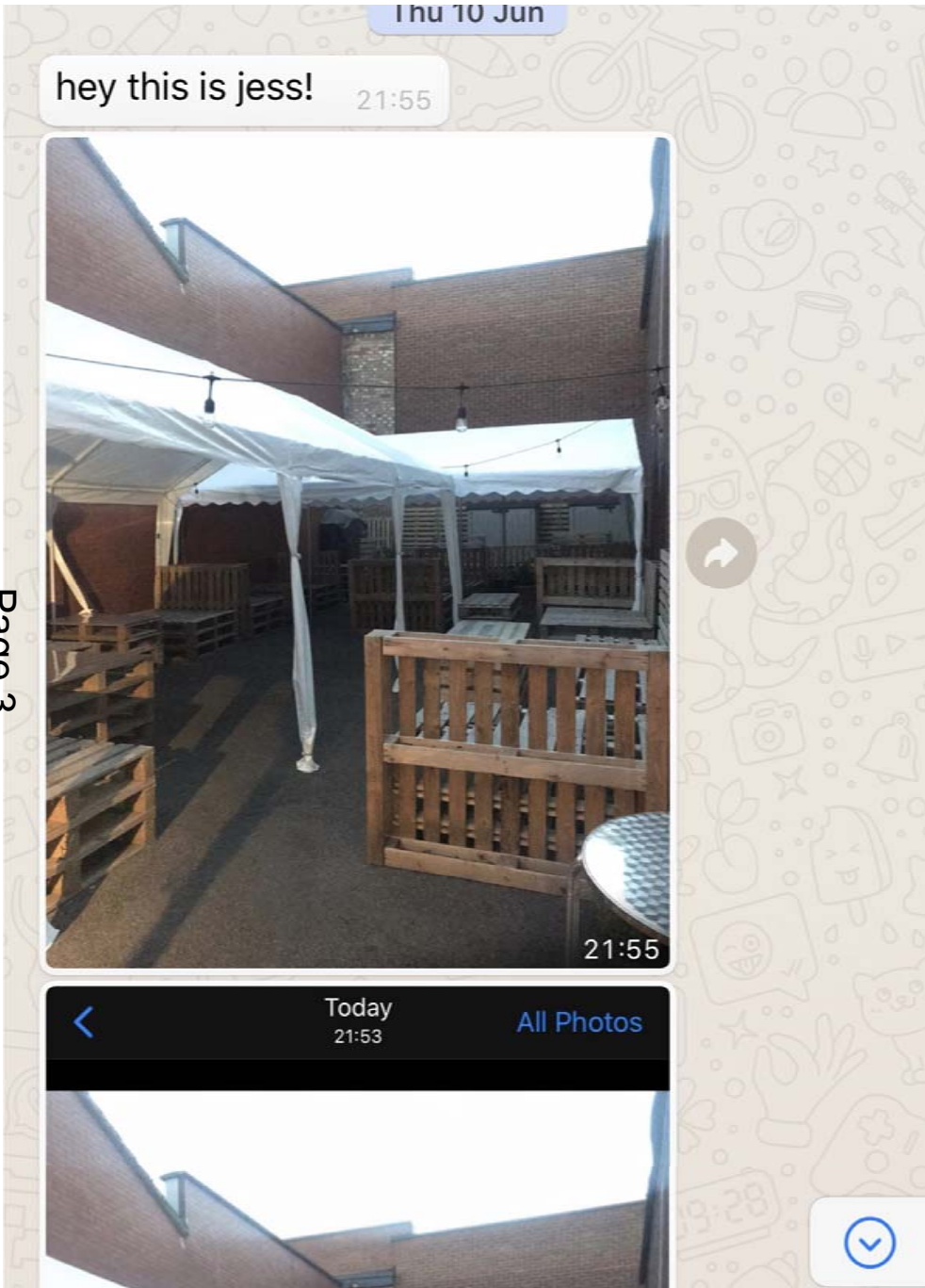

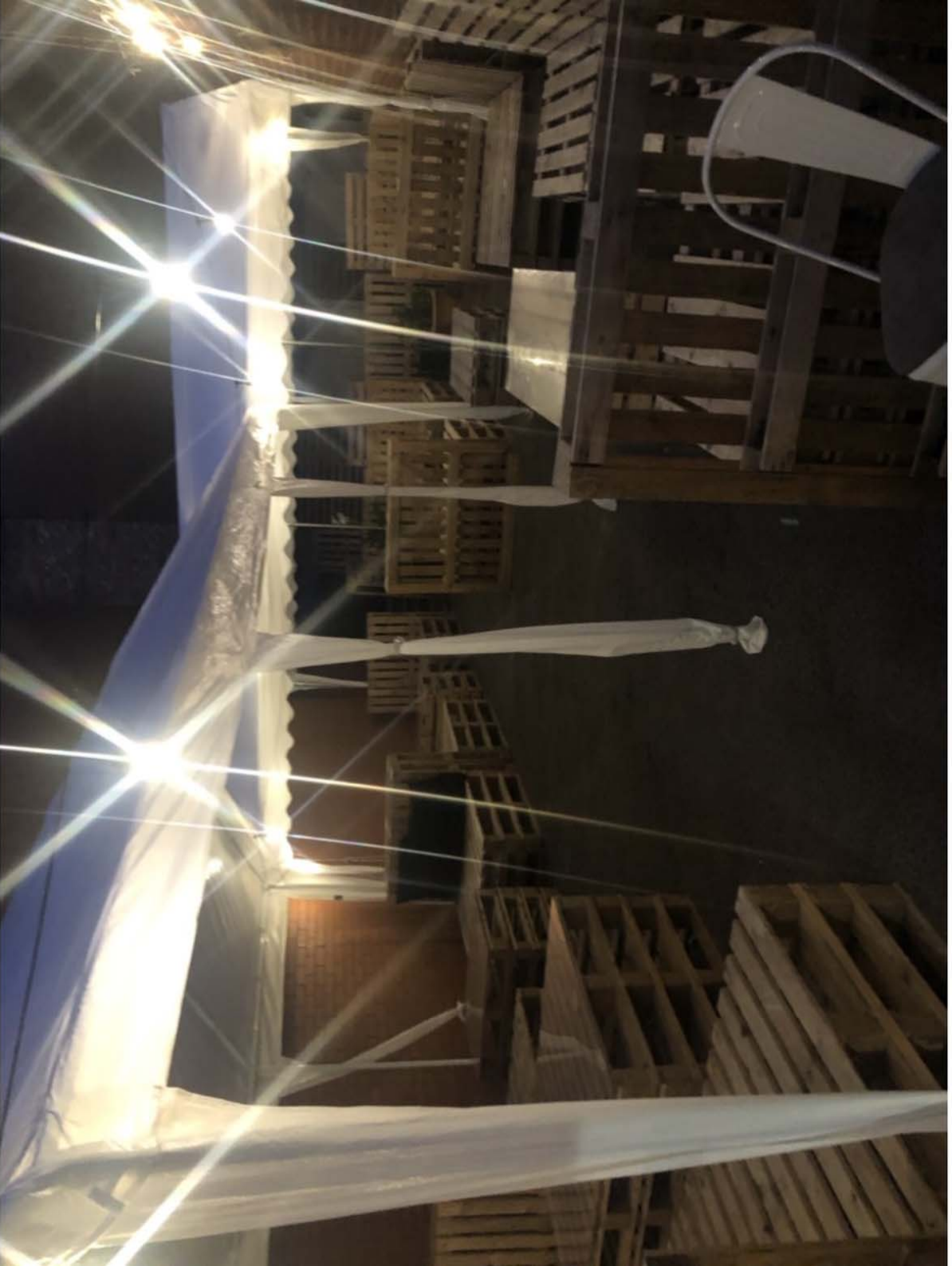


I own & operate The Halo Hairdressers at 65 Station Road, Upminster next door but one to
The Station Pantry.

I am writing to advise you that we have not been disturbed by any music noise or other noise
issues from the few booked events involving music that The Station Pantry have held since
lockdown measures eased. I am aware that the owners are currently holding certain booked
events in the rear area at the moment due to ongoing Covid restrictions, but that when these
are lifted that most events including those involving music will be held indoors.

I understand the need that small businesses like The Station Pantry have to recover after the
effects of the lockdowns and other Covid restrictions on businesses and to protect the jobs of
their employees. (Hospitality & hairdressing are two of the business sectors most badly
affected by Covid 19.)

I also understand why The Station Pantry are applying for this variation of their Licence to aid
in the recovery of their business and to enhance their existing business offer. I have no
objection to the variation of the Licence being granted and do not consider that it will increase
anti social behaviour or public nuisance, nor will it adversely affect my business. I do not
consider it will undermine the Licensing Objectives.
