SUMMARY

This report presents an update on the North East London (NEL) Joint Sexual & Reproductive Health Strategy, outlines NEL ICB engagement, and sets out proposed local action plan governance and next steps.

REPORT DETAIL

This report follows the last presentation of the draft NEL Joint Sexual & Reproductive Health (SRH) Strategy to the Havering Health and Wellbeing board in April 2024.

Recap on NEL SRH strategy

The NEL SRH Strategy builds on existing collaborative working arrangements and new opportunities arising from the establishment of integrated care systems, to present a framework for addressing shared SRH priorities and challenges across NEL.

The strategy aims to support the delivery high quality, easy access and equitable sexual and reproductive health provision across the whole of North East London, with the prevention of illness and the promotion of healthy relationships at the core of all activity.

The strategy and accompanying NEL action plan are presented across four priority areas for action:

Priority 1: Healthy and Fulfilling Sexual Relationships

Priority 2: Good Reproductive Health across the Life Course

Priority 3: High Quality and Innovative STI Screening and Treatment

Priority 4: HIV: Towards Zero and Living Well with HIV

The strategy and NEL action plan content and design has now been agreed, and the executive summary, full strategy and NEL-action plan accompany this report.

The strategy will be taken for endorsement by the Havering Cabinet in September 2024, with NEL-wide strategy launch scheduled for October 2024.

ICB involvement and sign off

A key point of discussion at the April Health and Wellbeing board was regarding the involvement of NEL ICB in strategy development.

ICB representatives, clinicians and other professional stakeholders from across the sexual and reproductive health (SRH) system were invited to participate in a series of workshops to inform strategy development. Key ICB stakeholders were also sighted on progress as members of the strategy steering group.



In a recent meeting with NEL local authority representatives, ICB colleagues involved in SHR commissioning and strategy oversight welcomed the strategy and the shared ambition of greater joint working on SRH and related services. ICB colleagues agreed to review/ comment on the strategy and action plan, with the strategy to be presented to the NEL ICB board once it has been approved via relevant local authority governance across NEL.

Proposed local governance

There is currently no existing Havering sexual health partnership group which could act as an implementation group for a local action plan.

As such, it is proposed that public health lead the formation of a small working group of key stakeholders to act as a vehicle for local action plan development and delivery. It is proposed that this group provide updates on progress via the Havering Place-based Partnership board, with frequency of updates to be agreed.

IMPLICATIONS AND RISKS

The NEL-level strategy has no direct financial implications, but may encourage and facilitate further exploration as to how commissioning of services can be optimised as to deliver economies of scale and maximise value for money within existing budgets.

Any consideration of NEL or local actions relating to the strategy which are deemed to have financial implications will be subject to the relevant organisational/partnership governance arrangements.

Developed through a combination of engagement with local health professionals and residents and local and regional data

Priority 1: Healthy and fullfilling sexual relationships



- · All young people should have access to high quality Relationship and Sex Education (RSE)
- All residents should be able to recognise whether a relationship is abusive or unhealthy
- · People in unhealthy or risky sexual relationships should be appropriately supported
- Reproductive health and wellbeing is just as important as preventing and Otreating STIs

Good reproductive health across the life course

- Residents living with HIV have access to HIV prevention and the best treatment and care
- · Stereotypes and HIV related stigma are addressed and challenged

- The strategy, action plan and ambition around greater joint working across the SHR system has been welcomed by key ICB colleagues (those with oversight of SRH commissioning), who have agreed to review/comment on the strategy and action plan.
- It has been agreed that the strategy will be presented to the NEL ICB board once it has been approved via all local authority governance
