

326 offences, of which 48% (156) of the crimes were violence related offences and 23% (75) were thefts. The violence related offences are shown on the map. 87% (135) of the violence related offences were in South Street.

GBH / ABH / COMMON ASSAULT

Street. 29 of the 136 offences were linked to the one venue. This was followed by a second (13 offences) and then another There were 136 offences which were classified as GBH (38), ABH (48), common assault (50). 120 of these were in South icensed premise with 11 offences.

25 of these offences were between Friday 2325 hours and Saturday 0440 hours. 38 of these offences were between Saturday 2325 hours and Sunday 0440 hours. There were 89 offences (65%) committed between 2325 and 0520 hours. The premises wants to extend hours from 0100 to violence related crimes were committed between 0100 and 0400 hours, within 200 metres of the venue. 35 offences during 0400 hours. There were 57 violence (GBH, ABH, common assault) offences between 0100 and 0400 hours. 42% of these top end SOUTH ST within the 3 hour period. Intelligence suggests that after the night clubs close the customers assemble the 3 hour period were in or directly outside a licensed club or pub and 7 were in take away/fast food premises. 5 were in in the streets around the fast food places. This maybe a contributing fact to the increase in violent related crimes in the 3 hour period. Several section 35 dispersal orders have been used in the area.
