Members are advised that, when considering application for a premises licence, the following options are available to them by virtue of the Licensing Act 2003, Part 3, section 35, paragraphs 3 and 4:

"Where relevant representations are made, the authority must

- (a) hold a hearing to consider them, unless the authority, the applicant and each person who has made such representations agree that a hearing is unnecessary, and
- (b) having regard to the representations, take such steps as it considers necessary for the promotion of the licensing objectives.

The steps are:

- a) modify the conditions of the licence
- b) reject the whole or part of the application

and for this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added."

The Sub-Committee will also wish to note that, if none of these steps is required, the application must be granted.

Assuming that the Sub-Committee is satisfied that a hearing is required, then the following procedural steps are recommended. The Licensing Act 2003 (Hearings) Regulations 2005 will govern the arrangements for the hearing of the application now under consideration. This report accords with the requirements of that Act and the Regulations, and in particular Regulations 21-25 (procedure at the hearing).

1. Membership of the Sub-Committee:

- 1.1 The Sub-Committee comprises three members of the Licensing Committee, with a quorum of two members. **Unless there are objections, in the absence of three members, the hearing shall proceed with the quorum of two.**
- 1.2 A members of the Licensing Committee will be excluded from hearing an application where he or she:
 - 1.2.1 has considered an application in respect of the premises in the previous 12 months as a Member of the Regulatory Services Committee; or
 - 1.2.2 is a Ward Councillor for the Ward in which the premises, subject to the application, are located; or
 - 1.2.3 is a Ward Councillor for a Ward which is likely to be affected by the application or;
 - 1.2.4 has a personal interest in the application.

2. Roles of other participants:

- 2.1 The Legal Advisor is not a party to the hearing. The role of the Legal Advisor is to provide legal advice relating to the application and submissions.
- 2.2 The Clerk is not a party to the hearing. The role of the Clerk is to record the hearing and the decisions of the Sub-Committee, and ensure efficient administration

3. Representation validation meeting:

- 3.1 Prior to this hearing, the Sub-Committee Chairman will have met the Legal Advisor and/or Clerk to determine whether further clarification is required of any issues contained in the application or any representation.
- 3.2 During this preliminary meeting no decision will have been made or discussion held regarding the substantive merits of the application or representations.

4. Location and facilities:

- 4.1 All hearings will be heard at the Havering Town Hall unless otherwise directed.
- 4.2 Interpreters will be provided by the Council on request, provided notice is given at least five working days before the hearing.

5. Notification of attendance:

- 5.1 The Chairman will enquire of the parties who is in attendance and the parties will indicate their names (and, where relevant, whom they represent). A register will be circulated before the commencement of the hearing on which the applicant, his/her advisers and companions and all interested parties (and/or their representatives) will be asked to record their attendance.

6. Procedural matters:

- 6.1 Prior to the commencement of the hearing, the Chairman of the Sub-Committee will orally inform the parties whether their applications to have certain people attend the hearing (e.g. witnesses) have been granted or refused. Note this relates to people other than those attending on behalf of a party in the capacity as a representative of the party.
- 6.2 Prior to the commencement of the hearing the Chairman of the Sub-Committee will outline the procedure to be followed at the hearing. This will normally be as follows:

Introduction of the application:

The Licensing officer will outline:

- details of the application and relevant representations received from the parties;
- relevant legislation ;
- relevant Licensing Policy; and
- the time limit in which the Council must reach a determination.

Documentary evidence:

- Documentary or other information in support of applications, representations or notices should be provided to the Clerk of the Sub-Committee at least 7 clear working days before the hearing. If this information is produced at the hearing it will only be taken into account by the Sub-Committee if the Sub-Committee and all the parties consent to its submission. Permission to have this information included in the hearing should be requested at the beginning of the hearing before any oral submissions have been made.
- Statements made by people in support of a party's representation who are not present at the hearing, must be signed by the maker, dated and witnessed by another person. The statement must also contain the witness's full name and occupation.

Representations:

- The chairman will invite each of the parties at the hearing or their representative sequentially to address the Sub-Committee and call any person/s to whom permission has been granted to appear. Each party will be allowed a maximum period of 10 minutes in which to address the Sub-Committee and call persons on his/her behalf.
- This 10 minute period is where each party has the opportunity to orally address the Sub-Committee and clarify any points in which the Sub-Committee has sought clarification prior to the hearing. This 10 minute period should be uninterrupted unless a member of the Sub-Committee or Legal Advisor considers that the speaker is making submissions that are irrelevant, frivolous or vexatious.
- Members of the Sub-Committee may ask questions of any party, at any time during the proceedings. Time taken in dealing with a Member's question will not be taken into account in determining the length of time available to the party in question to make their representation.

The sequence in which each of the parties will be invited to address the Sub-Committee will normally be in the order of:

- the Chief Officer of Police;
- the Fire Authority;
- the Health and Safety at Work Enforcing Authority;
- the Local Planning Authority;
- the Local environmental Health Authority;
- the Local Weights and Measures Authority;
- the Authority Responsible for the Protection of Children from Harm;
- a navigation or other authority responsible for waterways; and
- any other party that has submitted representations in respect of the application, certificate, notice or other matter appearing before the Sub-Committee;
- the party that has submitted the application, certificate, notice or other matter appearing before the Sub-Committee.

At the discretion of the Sub-Committee the above order may be varied.

Cross-Examination:

Where witnesses have been permitted by the Sub-Committee to speak at the hearing on behalf of a party, permission must be sought from the Sub-Committee before another party can ask the witness questions. This process of questioning is normally referred to as cross-examination. The Sub-Committee will allow cross-examination only where it is necessary to assist it in considering the representations or application.

Relevance:

Information submitted at the hearing must be relevant to the applications, representations, or notice and the promotion of the licensing objectives. The Chairman of the Sub-Committee is entitled to exclude any information it considers to be irrelevant whether presented in written or oral form. The licensing objectives are:

- The prevention of crime and disorder;**
- Public safety;**
- The prevention of public nuisance; and**
- The protection of children from harm.**

7. Failure of parties to attend the hearing:

- 7.1 If a party, who has not given prior notice of his/her intention not to attend the hearing, is absent from the hearing the Sub-Committee may either adjourn the hearing or hold the hearing in the party's absence. Where the hearing is held in the absence of a party, the Sub-Committee will still consider the application, representation or notice submitted by that party.

8. Adjournments and extension of time:

- 8.1 The Sub-Committee may adjourn a hearing to a specified date or extend a notice period except where it must make a determination within certain time limits in the following specific applications:
- Applications for conversion of existing licences where the Sub-Committee must make a determination within 2 months of the application first being received. In default of a decision being made the application will be treated as being granted;
 - Applications for variation of existing licences where the Sub-Committee must make a determination within 2 months of the application first being received. In default of a decision being made the application will be treated as being rejected;
 - Applications for conversion of existing club certificates where the Sub-Committee must make a determination within 2 months of the application being first received. In default of a decision being made the application will be treated as being granted;
 - Applications for variation of existing club certificates where the Sub-Committee must make a determination within 2 months of the application being first received. In default of a decision being made the application will be treated as being rejected;
 - Applications made by holders of justices' licences for personal licences must be determined within 3 months of the application first being

received. In default of a decision not being made within this period the application will be treated as being granted;

- Review of premises licences following closure orders where the Sub-committee must make a determination within 28 days of receiving notice of the closure order.

9. Sub-Committee's determination of the hearing:

- 9.1 At the conclusion of the hearing the Sub-Committee will deliberate in private accompanied by the Clerk and the Legal Advisor who will be available to assist the Sub-Committee with any legal problems but will not participate in any decision making of the Sub-Committee.
- 9.2 The Sub-Committee will normally make its determination and announce its decision at the end of the hearing.
- 9.3 Where all parties have notified the Sub-Committee that a hearing is not required the Sub-Committee must make its determination within 10 working days of being given notice that the hearing is not required.

10. Power to exclude people from hearing:

- 10.1 The public are entitled to attend the hearing as spectators. However, the Sub-Committee may exclude any person from the hearing including any person assisting or representing a party where:
- it considers that the public interest would be best served by excluding the public or the individual person from the hearing; or
 - that person is behaving in a disruptive manner. This may include a party who is seeking to be heard at the hearing. In the case where a party is to be excluded, the party may submit to the Sub-Committee in writing any information which they would have been entitled to give orally had they not been required to leave the hearing.

11. Recording of proceedings:

- 11.1 A written record of the hearing will be produced and kept for 6 years from the date of the determination of the hearing.

12. Power to vary procedure:

- 12.1 The Sub-committee may depart from following any of the procedures set out in this document if it considers the departure to be necessary in order to consider an application, notice or representation.

This application for a variation to a premises licence is made by Ms Hatice Sapkur under section 34 of the Licensing Act 2003. The application was received by Havering's Licensing Authority on 6th December 2011.

Geographical description of the area and description of the building

The premises is located in a parade of shops in a predominantly residential area. Park Lane is a busy 'cut-through' road linking Hornchurch to Romford. A map of the area is attached.

The current premises licence permits the provision of the following licensable activities:

Comments and observations on the application

The applicant acted in accordance with regulations 25 and 26 of *The Licensing Act 2003 (Premises licences and club premises certificates) Regulations 2005* relating to the advertising of the application. The required public notice was installed in the 16th December 2011 edition of the Romford Recorder.

The premises currently is permitted to remain open to the public until 23:00 although alcohol supplies must cease at 20:00. The applicant has not sought to extend the premises' opening hours.

In the 12 months preceding this application test purchases of alcohol were made by officers of this Licensing Authority at the premises after the current 20:00 terminal hour on two occasions; the first was on 8th December 2010 and the second was on 11th March 2011. Warning letters were issued to the premises licence holder in response.

Summary

There were twenty-nine representations against this application submitted by interested parties.

There were thirty-eight representations in support of this application submitted by interested parties. Four of these letters of support were written individually while the remaining thirty-four were a signed *pro-forma* letter.

There was one representation against this application from a responsible authority, namely the Metropolitan Police.

Details of representations

Valid representations may only address the following licensing objectives:

- The prevention of crime and disorder
- The prevention of public nuisance
- The protection of children from harm
- Public safety

Interested parties' representations

The representations against this application addressed each of the licensing objectives.

Responsible authorities' representations

PC David Fern makes representation against this application on behalf of the Metropolitan Police. PC Fern contends that the applicant has not satisfactorily addressed the additional steps she intends to take to prevent noise nuisance and anti-social behaviour. PC Fern further contends that should the application be granted as submitted the applicant's failure to satisfactorily address these additional steps will lead to further crime and disorder and public nuisance.

There were no representations from any other responsible authority.

Park lane Food Centre, 77 Park Lane, Hornchurch, RM11 1BH

With reference to the above application the Metropolitan Police make representation against the application, licence registered by Ms Hatice Sapkur.

The applicant has not satisfactorily addresses the additional steps they intend to take to prevent noise nuisance and anti social behaviour, if they were to be granted the extended hours to supply alcohol. This in turn is likely to lead to further crime and disorder and public nuisance.

The applicant did not consult with the police prior to this application being made.

- The premises are located within a predominately residential area. There are other late night convenience stores within a close proximately of less then 50 metres. Tesco's at Roneo corner is also nearby, which trades until 1000 hours. Premises are always likely to be associated with anti social behaviour the later that it is open.

The current area has reported problems with youths and anti social behaviour along with underage drinking and smoking within the proximately of the area, including the two local parks. Hylands and Maygreen.

- Police officers have acted upon reported incidents of youths causing disturbance, rowdy behaviour and harassment within the area, along with information supplied by local residents that children are in possession alcohol. There have been approximately ten recorded reports within the last four months associated with or near 77 Park Lane, RM11

- Many other issues are dealt with by the local safer neighbourhood teams and are resolved locally, including stop and account on children causing disturbance.

There are many methods to acquire alcohol and it should be noted that this is not always by irresponsible sales, theft and proxy sales made by irresponsible adults add to the challenge of controlling alcohol induced behaviour.

The added factor of availability of alcohol should also not be dismissed into the factors.

- There have been numerous objections raised by local residents at previous applications to vary the premises licence. This includes the previous hearing held this year in April 2011. Submitting a new application over the festive period could omit some residents from submitting a letter of objection with the stated time frame.

The management and compliance of the premises raises concerns for the police. It was discussed by the committee and all parties concerned upon granting the initial licence that the applicant would be allowed modest licensed hours. This in turn would allow the applicant to build up a positive business reputation to reassure those who were sceptical to his intent.

- I am aware that the local licensing authority has previously caught staff serving alcohol twice after their current licensable hours. This is within a 12 month period 01/12/2010 - 01/12/2011.
- Along with a recent incident at the premises in October 2011 involving an assault on a minor/Child, where at the time of the incident the suspect was employed at the premises. They were arrested and this resulted in a detected crime under current guidelines produced by home office.

A recent visit to the premises on 29/12/2011 by me revealed the following Not in accordance with the licence.

ANNEX 2 Condition 1 - a landline integrated security system to be installed. Mr Fazil Tubay the ex DPS informed me that they had a standard alarm only. This was not connected to a landline integrated system as required by the condition on the licence.

- There was a burglary report in March 2011, including theft of alcohol and cigarettes from the premises. The system requested on the licence would alert the alarm company/police to the incident had this been installed.

ANNEX 2 Condition 6 - a refusal book to be kept at the point of sale, made available for the police or local authority.

- At first Mr Tubay states it was lost, but then produced a diary with refusals written in the back of the diary. Last entry dated 23/12/2011 then 21/08/2011.
- This was written in Turkish; he informed me that he was going to get the new DPS to transfer it into the refusal book as he could not write in English.

- A document was produced supplied by the local authority dated 17/06/2011. This document can be used for refusals, and gives some guidance on how to log an incident. I asked him why six months later he had not completed it, there was no reply.

This is an important document to show that the premises and staff are complying with the conditions relating to under age sales and promoting licence objectives.

ANNEX 2 Condition 20 - relates to the DPS supervision of the refusal book and record that is being done, there is no clear evidence that this is being maintained.

There were also no Staff training records available, Mr Tubay stated that all staff were personal licence holders so did not require any training record.

ANNEX 2, condition 7 and **ANNEX 3, condition 1**, were pointed out to Mr Tubay, regarding training records.

ANNEX 3 condition 11 - states that the premises shall undertake to label all alcohol that is to be sold.

I asked Mr Tubay had he complied to this condition, he stated that the labels were too expensive around £350.00 to £400.00 a box. I discussed other methods using UV pens, stickers etc.

The only labels visible were yellow price stickers on bottled alcohol only.

- This condition was brought to the attention of the committee and premises license holder in a **previous hearing on 09/11/2010**.
- Police recommended that alcohol products should be labelled to show details of the premises from which it was bought. This would provide evidence of unlawful sales if the products were found commonly in the possession of persons less than eighteen years of age.
- This was also due to substantial local concern about the application, hence a condition being imposed on the licence.
- This condition was also raised in the **last hearing In April 2011**, by a resident Mr J Sims, Stating the applicant has not marked the alcohol sold on the premises in order that empty cans, smashed bottles etc, can be traced back to their shop, he believed this was one of the conditions in awarding the licence.

It was also discussed that a recent change of DPS from Mr Tubay to Mr Coban had been made. The new DPS was not at the premises however he would be that evening. The new DPS has previously worked at the premises Mr Tubay informed me that Mr Coban had worked there for some months. This did not inspire my confidence that the establishment was being properly managed under the new DPS as of 01/12/2011 considering he had work there prior to being made the DPS.

A letter of my visit will be sent to premises licence holder, and a record of the breach of conditions highlighted.

The application does not fulfil the additional steps to take to promote the licensing objectives.

The applicant states in the application, standard practices will be taken to include positive impact upon the local community and local environment and its residents at all times.

Given the issues raised in the area and the objection from Police and Local residents in the past. It is suggest that the applicant put forward their intention on how they aim to achieve this statement.

Prevention of crime and disorder:

Lists an item relating to toilets, I am unaware that the toilets are for public use and presume this is an error.

The licensee will install CCTV. This is already in place and already a condition on this licence.

I suggest the applicant consultants the home office guidelines and consider other options available in prevention of crime and disorder and matters relating to the Metropolitan police objections.

Public Nuisance; although placing a sign up advising people to leave quietly and respect the neighbours is a good start, there is no mention has to how they will monitor or ensure compliance, again conditions within the home office guidance and licensing policy can be found easily.

Protection from children:

The refusal register states and that it will be kept and maintained on the premises in the licensing objectives put forward by the applicant. This is an area the premises have not complied fully too already.

The recent assault on a minor at the premises also gives me concern.

- **The premises licence holder should of attended a child protection course, I would like to see prove that this has taken place since being granted the licence. Condition 19, - Annex 2.**

I suggest further training in child protection to be developed amongst all staff members at the premises.

The police do not support the applicant to be open any later for licensable activity and do not support the non standard timings request.

It would appear that the premises are not managed in accordance with the licence and being open for longer would contribute further to crime and disorder along with the associated problems.

Police do not wish to applying further conditions on the licence to satisfy the objections. The management have breach conditions on the licence and have not shown positive steps towards adhering to them or building there reputation in the community.

The police will continue to work with the applicant and their representative in an effort to develop the business and the community.

We have lost count of the number of times we have been woken by shouting and swearing by people congregating outside the shop, we rush to look outside in case youths are vandalising or causing damage to property which has happened in the past. This is starting to affect our sleep and why should we as home owners suffer simply because of the sale of alcohol?

With the evenings set to get brighter over the coming months, the return of all these unwanted youths is set to increase just like it did this time last year - please note that records have been kept of the trouble and can be produced at the hearing if required.

The owner claims that the 8pm restriction is affecting his business but if he is there to serve the community then surely the 'food centre' is what is needed and not the off licence. Dear Sirs,

We are writing to you with regards to the above premises and ask strongly tat the times of the licence are not extended. And since the last hearing have kept a log of incidents regarding number 77.

The Objectives

The Prevention of Crime and Disorder

We already have an Off Licence (Rose Wines) on this parade that shuts around 9pm, this is due to the fact that past behaviour has shown that a large number of youths congregate in this area and if 77 is granted an extension open consistently late every night it will add to the problem of there already being the youths hanging about/ buying/ trying to buy alcohol numerous nights of the week at this premises (77 Park Lane). This problem has increased since the opening of number 77 and do not want it to be more of a problem than it already is. In the past this has caused crime and disorder and the residential neighbourhood has worked hard to keep this area free from disorder, we do not want this statistic in this part of Havering to rise.

Past behaviour is a good indicator of future behaviour and habits. In the past we have endured 3 incidents of having our car damaged due to youths hanging around late at night in the parade of shops and feel the later licence will attract more crime and disorder, making people behave anti socially around our property and immediate area.

There has also been a robbery at the premises during the early hours last March 2011 which indicates this premises has attracted crime to the area. And even after Police warnings on 4th March 2011 involving 25 youths at the premises causing noise disturbance and other one week later there was a breache of selling outside of licensed hours, why is safety and the community being made a mockery of by this premises thinking they can do what they want, when they want for their own gain regardless of the public, others and the local residents?.

Public Safety

We do not want people gathering around this area buying drinks then heading over into local parks and then Romford making the area unsafe perhaps being approached by someone under the influence of alochol late at night it's unsafe. Many arguments, stabbings, robberies etc are committed when intoxicated and we do not want to promote that kind of culture within our vicinity.

The Prevention Of Public Nuisance

As a new business to the area you would like to try to support this premises and we did not appeal since the last hearing as were prepared to give the shop a chance. But sadly I feel this can not be done. I am not a police officer, nor do I have the equipment to invesigate, but living directly oppisite I feel that this premises is already serving after 8pm

and perhaps to those under the age of 18 and is not proving themselves to be in the interest of the residential community or managing appropriately.

Ok so the premises may have a suffering in business but surely that proves the only business being sold is that of the alcohol and sales of tobacco to youths not food, hence the name of 'Food Centre' is misleading and not serving or meeting the needs of this residential area and I feel not adhering to guidelines does not provide confidence in the premises or it's behaviour in the future if this could be happening now. I feel this because of the following.....

For example, Fri 14th Jan 2011, 15 youths boys and girls, making nuisance behaviour, shouting loudly, screaming in the street, drinking outside the shop (77), moving signs then both the owner and his wife look directly over. Already noted the same evening two youths urinating up shop fronts of the parade after leaving the ' food centre'. This walk way is used daily by residents and young children walking to school and could attract vermin.

Surely this extension being applied for in the wife's (Mrs. Supkar) name again shows something isn't right, wasn't that one of the terms that it was in husbands, name and wasn't it stated he is a 'responsible licence holder' in the report from the hearing?. He doesn't seem to be showing that, neither of them do.

Fri 11th Feb 2011

20 youths hanging around the shop, sitting on the wall of the vets causing noise and disturbance and the shop owner getting friendly, that's not responsible behaviour of that of a supposed responsible license holder.

Feb half term Tues 22nd -Fri 25th, youths every night of the week. I walked passed and was shouted abuse at for using a mobile phone, when out of view the youths moved on and the owner walked up towards the park afterwards where the youths were heading. Was this to conceal the behaviour of irresponsible sales, covering his tracks perhaps??. I do not want to spend every night looking out the window at this type of irresponsible behavior and with the lighter weather the attraction for youths is getting greater especially when applying for this extended license before the change of the clocks and it only being a few months since the last outcome.

The youths hanging about are here more nights then they are not, although they are not noisy every night it is still hard for us to relax, you never know what they are going to do, because you never know if they will cause damage to property or vehicles as some nights they're extremely noisy which is most weekends.

My partner and I both work long hours and already this is disturbing our sleep patterns, this would give us added stress, sleep deprivation eventually harm our health and general well being. There are several young families living opposite the parade and this extension would most defiantly disturb our sleep patterns, well it already is.

In the document from the details of the hearing it states

" In reply to concerns raised by objectors, the applicant representatives stated that none of the issues raised could be linked directly to the premises, that these problems already existed, and his clients application would not be adding to it".

Sadly that's not the case he is adding to it, it is happening and it can only get worse.

Since the last hearing in 2011 I have kept an Incident Diary provided by local community police and recorded examples of anti social behaviour resulting **directly** from 77 Park Lane. This is available on request and Romford community police have the original diary.

For example:

Saturday 10th Sept 2011 7.30-8.15pm 29 youths drinking, smoking, screaming, bottles left, pushing each other, disturbance, leaving litter, increased noise. (photographed)

Friday 7th October 2011,7.15-8.30pm 10-14 youths, nuisance, noise, drinking leaving litter.

Thursday 13th October 2011 around 7pm. Partner and I witnessed shop owner pushing and grabbing hold of a youth. Later on a neighbour told me that many people are frightened to go near the shop, this behaviour is a disgrace, intimidating, threatening and should'nt be happening.

Friday 21st October 2011 10pm-10.30pm 8 boys outside one being sick on the pavement outside. Was returning home with daughter and also noticed a couple being served alcohol at this time as I got out of my car.

Monday 31st October 7-11pm

Around 30-40 youths were gathered outside, police presence was most needed on this occasion and thankfully was. and if the Police were not around most of this group I feel would've stayed on the vicinity causing more disruption. There was a discussion at the last hearing of installing a mosquito alarm to deter and reduce this behaviour but nearly a year on and still nothing, not even trying to move youths on.

The above records show that even the current license of 8pm is causing the residents undue noise disturbance and we need to be protected as stated in the Licensing Policy 008 Statement of Licensing Policing 2010

The protection of children from harm

The increase people hanging around this premises most evening shows that they trying to purchase alcohol/ cigarettes, why else would they? it's not for the lovely view or the weather something is attracting them and is that the purchase of intoxicating products, not sweets or crisps as I don't see any youths hanging around the news agents in the same parade every evening.

Youths swearing and shouting is not the environment we want our young daughter or ourselves to be subjected too as we can guarantee that there will continue to be youths hanging about, it's an ideal area for them to gather as they can get alcohol, food and a park within 100 yards, we want to nip the problems in the bud before they'll get worse. To conclude I feel the premises owners haven't shown any regard to the local residents and we have no faith ever will as shown nothing has improved its gradually getting worse.


In the last few years the number of youths congregating along Park Lane has slightly decreased. The proposed longer hours will once again see many youngsters hanging around this area.

I am surprised that another application has been made so quickly by the owner, bearing in mind the fact that he had previously sold alcohol already outside of his granted licence times, and the strength of feeling from the local community, I would have felt that the owner would need to display a lot more effort over a much longer time before an extension would be granted to him?

however, working on the current application, I still hold the same if not more concerns, regarding increased possible crime and nuisance, in the area.

Tesco at Roneo Corner is permitted to sell alcohol until 10pm, the off licence on the corner of park lane/hillcrest rd only sells alcohol i believe until 9pm, if the licence is extended for park lane food centre until 11pm, it means that it will attract any one looking to buy alcohol after that time to this area, as I am a resident here I am not happy about this at all.

At the moment I have seen an increase in what i suppose would be called small crime, and disturbance, for instance rear car windscreen wipers been snapped off, along with an increase in litter, beer bottles and food wrappers in our streets and front gardens, although I am not suggesting these things are the fault of park lane food centre, an extension in licencing hours i feel can only make things worse.

As at present the government are looking at changing the price structure of alcohol sold in this country, due to the increases in drunkenness, I believe it is irresponsible to grant this licence.

Action has been taken by the council to discourage this practice e.g. removal of raised flower beds providing "seating". I have just been made aware of the application to extend the Licensed Hours at Park Lane Food Centre to 11pm and would like to submit my reasons why this application should be refused. I also know that they are still selling alcohol outside their licensed hours and think more checks should be made to stop this. They also keep the "Off Licence Open" sign illuminated until they actually close at 11pm which I do not believe should be allowed as it is inviting people in to buy alcohol at anytime.

1. I live directly opposite 77 Park Lane which is predominantly a residential area and I am concerned that what is already a fairly noisy road late at night with people returning from Romford by foot or car will become much worse, as people stop to buy alcohol, and instead of passing by will continue with their loud conversations, arguments, singing etc., or cars leaving engines running, car radios blaring as a passenger/companion pops into the shop. I already find this a problem with them staying open until 11pm, particularly in the summer when the staff stand outside the shop smoking and having loud conversations on their mobile phones. I have been forced to close my bedroom windows and even then can still hear them.
2. Parking in Park Lane directly opposite the row of shops is already a problem. During the day I understand local business rely on passing traffic, and in the evening we already have a Chinese Takeaway and The Rose Off License, which are open later into the evening. Additional cars parking on a busy but narrow stretch of road (with cars parked both sides) will increase the risk of accidents to pedestrians and road users.
3. I am also concerned that the risk of vandalism will increase. In the past 5 years I have twice had my car vandalised (the wing mirror on the pedestrian side knocked off both times) and have seen other cars in the street also affected. Since Park Lane Food Centre has been open we are increasingly seeing groups of youth hanging around quite late into the evening. One occasion a group of about 20 were outside at 9.30pm in the evening, which was quite intimidating. I fear this will increase again next summer and with alcohol available until 11pm residents will suffer from even more noise and anti social behaviour.

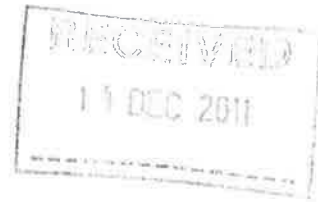
I am writing to voice my disapproval at the application to extend the license at 77 Park Lane, Park Lane Food Centre.

Please accept this letter as an objection to the application referred above. We live within 50 metres or so of the premises.

The grounds for objection are:

Potential poor control of the licence leading to increase in Crime and Disorder

The retail sale of alcohol is a specialised business. There is already existing business for retail sale of alcohol within 50 metres or so and we have already experiencing late night noise and anti social behaviour. The premises already have a licence until 8pm and have created problems with youngsters coming in the area to purchase alcohol. On number of occasion police have come to resolve the problem with youngsters and shop owner. Our concern is that those refused alcohol in either well run supermarkets or public houses will seek to buy alcohol from the applicant. Most big licensees will not serve those that they know to be unfit. Our concern is that ready access to alcohol, when others have refused service or closed, will lead to anti-social behaviour. Due to suggested hours this is likely to attract those with drinking issues particularly at times when other outlets may not be available.

Public Nuisance and Crime and Disorder due to localized consumption

There are several locations within easy reach of this outlet that are likely to serve as natural places for those who purchase alcohol to consume it. Experience has shown that those who cannot 'enjoy' licensed premises will make use of such public places. In turn, this leads to public drunkenness, noise and litter. The availability of another outlet with extensive opening hours will make the situation significantly worse. This makes the whole area a haven for anti-social behaviour.

Harm to Children

This is residential area and children also live here. There is already a premise for the sale of alcohol. Further premise for the sale of alcohol until late night would be quite unacceptable and has the potential to have an adverse effect on morale and well being of local resident children.

Increased traffic leading to Public Nuisance and reduced Public Safety

Adding another premise to sell alcohol late into the night in the area means real threat to public safety and will cause more traffic noise and dangerous driving in a built-up residential area.

We would ask you to consider our concerns very carefully. As noted above, we are writing this letter as a local resident, with three young children. Should the application be granted, our family's quality of life will be affected, as will that of many local residents.

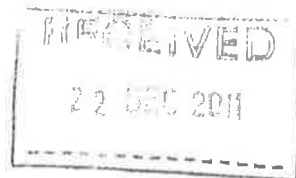

Re: - Park Lane Food Centre, 77 Park Lane, Hornchurch – alcohol licence variation application

I hereby state my case why the above application should be refused on all four licensing objectives.

Evidence of the problems with the consumption and illegal selling of alcohol to those under-age appear to have increased exponentially since the applicants gained approval to sell alcohol in the first instance – with many noisy and troublesome youths gathering outside the premises and the near locality. There has been a significant increase in graffiti, together with anti-social behaviour and vandalism.

The license holders have on many occasions disregarded the clearly laid out rules and laws that they agreed to abide to - in order for the application to initially be approved. Only recently, I have been advised that one of the license holders assaulted a young boy whilst on the premises in question – which resulted in police action. Furthermore, it is my understanding, the licence holders have been found to be selling alcohol directly to children, and I believe further evidence proves that adults have been accepting money from children – in order for the adults to buy alcohol on their behalf. I myself have been requested assistance by youths on two such occasions – leading to verbal obscenities and intimidation when I have declined to do so.

The licence holders have also been found by council officers to be selling alcohol after the hours permitted under the existing terms of the licence. Furthermore, the licence holders have also failed to 'mark up' cans / bottles of alcohol in line with the council's explicit instructions – which were put in place to ascertain from what premises these discarded cans / bottles were bought from. The licence holders have therefore failed to conduct their business in a responsible manner, and have 'ridden roughshod' through carefully laid out licensing objectives. It is therefore extremely likely that a further increase in hours selling alcohol would result in further law breaking and further anti-social behaviour.

I further note that the application – variation 'part 3', states 'extension of hours to supply alcohol off the premises' and is again stated as 'off the premises' under section 'M' on page 16 – instead of 'on the premises'. Does this mean the applicants wish to sell alcohol outside the premises or at another premises, or has this been completed incorrectly? I also note that box 'N' on page 16 has not been completed. I therefore suggest that this application be nullified until these points have been formally clarified – or a further application completed – with due diligence.

All in all, the current licence holders have I believe shown a total lack of respect and trustworthiness - to local residents, the council and police – in continuously flouting the rules and regulations as laid out, and I therefore ask for the support of the licensing committee in declining the application - until the licence holders have proved their sustained suitability to 'handle' such.






