Following further discussions with the Member Development Group, outlines of the first two planned events for Members were provided for noting by the Committee.

Members considered that the schedule for special training (e.g. to the committees for audit, equalities, pensions, licensing and planning) would need to be covered quickly although the Committee acknowledged that whilst there was no specific requirement for Members appointed to the Regulatory Services Committee to receive formal training, the changing rules governing planning made training desirable.

In addition, Members expressed a desire for the training to be given to new councillors to be separate from and distinct to that given to those Members who were returning and who had acquired experience as the Committee appreciated there would be clear advantages for both groups to receive training appropriate to reflect that differential.

Members were in agreement that the time after the local elections and before Annual Council would be a hectic one and they impressed officers with the need for those planning the programme to ensure that appropriate mandatory training was provided to those chosen by the various Groups to be Leaders and Deputy Leaders.

**SUMMARY** 

Following adverse judicial comments on the use of s.106 Town & Country Planning Act to restrict residents of new developments from having access rights to residents' parking schemes, an alternative legal provision has been identified and delegation of its use by the Head of Regulatory Services is recommended.

**RECOMMENDATIONS** 

That the Committee recommend to the Council that the following paragraph be added to Section 3.6.6 in Part 3 of the Constitution relating to the Head of Regulatory Services:

(dd) To enter into agreements under s.16 Greater London Council (General Powers) Act 1974 to restrict the occupants of buildings from having access to residents parking permits.

#### **REPORT DETAIL**

- The Council's basic policy provision for new developments is that any required parking provision should be provided on site. This is particularly so in town centres where often many existing buildings do not have any provision for on-site parking, so there is considerable pressure on existing on-street provision, particularly in controlled parking zones. On occasions developers are unable or unwilling to provide the required level of on-site parking provision.
- 2. In order to prevent occupants of the development subsequently also applying for a residents parking permit for the controlled parking zone within which the development is situated, legal agreements are entered into with developers to remove that possibility.
- 3. Previously restricting access to residents' parking permits was implemented under the provisions of s.106 of the Town and Country Planning Act 1990 (as amended) (the 1990 Act), however following adverse judicial comment on the limitation of the application of planning obligations under the Section 106(1) of the 1990 Act to restricting access to residents parking permits, it is considered that the alternative statutory provision under s.16 of the Greater London Council (General Powers) Act 1974, should be the preferred statutory provision used to implement the policy.
- 4. While most applications requiring legal agreements are considered by Committee, decisions on some small scale residential developments are delegated for determination to the Head of Regulatory Services. So that he can determine applications where a restriction on future residents having access to residents parking permits is required, rather than refer the application to Committee, it is recommended that the additional power to utilise s. 16 is delegated to him.

#### SUMMARY

The Council makes appointments to a large number of other organisations, some statutory, others voluntary.

Since the new executive governance arrangements came into force, responsibility for making some appointments has passed from this Committee to the Leader of the Council but the Constitution provides that it is for this Committee to make recommendations to the Leader.

#### **RECOMMENDATIONS**

That:

- 1 (a) That the Committee determine appointments to the organisations referred to in this report for the period until the meeting that deals with appointments for the municipal year, 2014/15 (or such other period as may be relevant in any specific case).
  - (b) That, where the appointment is executive, the Committee **RECOMMEND** to the Leader that the appointment be made.
- That, where the Council's representative (or any deputy or alternative representative where applicable) is unable to attend a particular meeting and the constitutional arrangements of the body in question so permit, that representative may mandate the Chair of the meeting to exercise a proxy vote.
- That the Council's voting rights at the General Assembly of the Local Government Association be exercised by Councillor Roger Ramsey (4 votes) and Councillor Clarence Barrett (1 vote) (or their respective nominees in the event either is unable to vote in person).

REPORT DETAIL

- 1.1 The Committee is authorised to make all appointments to other organisations (other than executive appointments, which are made by the Leader). Appointments are for the period expiring at the first meeting of this Committee in the municipal year 2015/16 (probably during the last week of May 2016), except where otherwise specifically provided.
- 1.2 Appendix 1 Executive appointments. The Committee is asked to review the appointments and to make recommendations to the Leader.
- 1.3 Appendix 2 lists the appointments made by office-held and by individual member, but are not executive. The Committee is asked to review these appointments and either confirm them or agree what changes are to be made.
- 1.4 Appointments that do not require review or renewal for the present are shown in italics. The Committee is asked to note these appointments.
- 2. Exercise of voting rights:

- 2.1 In some cases, the constitution of an organisation permits the casting of proxy votes if the appointed representative is unable to attend a meeting.
- 2.2 In order to avoid a possible loss of influence, it is the Council's usual practice to agree that, where the Council's representative (or any deputy or alternative representative where applicable) is unable to attend a particular meeting and the constitutional arrangements of the body in question so permit, that representative may mandate the Chair of the meeting to exercise a proxy vote.
- 2.3 The Committee is asked to agree to that practice continuing for the coming year.
- 2.4 The Council is entitled to 5 votes in the General Assembly of the Local Government Association. Previously, the Leaders of the Council and of the Opposition were allocated 4 votes and 1 vote each respectively.
- 2.5 The Committee is asked to confirm that this arrangement should continue.

#### 3. London City Airport Consultative Group:

- 3.1 There are several outside bodies which have member-level representation from London Councils. All nominations to outside bodies are made by the London Councils Leaders' Committee. When he was the Cabinet Member for Environment, Barry Tebbutt was appointed to represent the boroughs of Waltham Forest, Redbridge and Havering on the London City Airport Consultative Committee until April 2015.
- 3.3 Members are appointed for three years (with the exception of those for LBs Newham and Greenwich who are nominated on an annual basis), so it is likely that following the Election in May 2014 Havering will be asked to make a new appointment to replace Barry Tebbutt until April 2015.

#### 4. Thames Regional Flood Defence Committee:

- 4.1 Barry Tebbutt (Cabinet Member for Environment), was appointed via London Councils Environment Committee in November 2010 for a four year period to represent the boroughs of Barking & Dagenham, Havering and Redbridge.
- 4.2 London Councils has indicated that it appears unlikely the nomination will remain with Havering since the political balance on London Councils has changed following the Local Council elections

#### 5. North East London NHS Foundation Trust:

- 5.1 The Council makes a Non–executive appointment to the Board of Governors of the North East London Foundation Trust.
- 5.2 The representative was formerly the Cabinet Member for Individuals, but at the meeting of Governance on 12 March 2014, it was agreed that the Head of Adult Services, Barbara Nicholls should replace the Cabinet Member as the council's representative.
- 5.3 The Committee is asked to consider whether it wishes to
  - (i) **Agree** the change from Member to Officer appointment

OR

(ii) **Retain** the position as a Member appointment.

#### 6. Havering Local Strategic Partnership Board:

6.1 Following the removal of the Local Area Agreement national performance framework, it was decided that the meetings of the Havering Local Strategic Partnership would no longer be held. Member representation is therefore no longer required.
