1. APOLOGIES FOR ABSENCE

Cllr G Ford (Chair) welcomed all to the meeting.

Apologies for absence were received from Om Dhir, Kamal Siddiqui, Saddhabhaya, Dawn Ladbrook, Nasir Mubashar, Wendy Brice-Thompson, Cllr Philippa Crowder, Deborah Weston (Professional Advisor) and Terry Riches (observer).

The following members were not in attendance and no apologies had been received, Tariq Mahmood, Rabbi Lee Sunderland, Pastor Aloysius Peter, John Smailes, Luthaneal Adams and Cllr Tele Lawal.

The Chair reported that Louise Linton (Group C) had resigned from SACRE due to work and personal commitments. Members wished to thank Louise for her time and support as a SACRE member; a formal letter of thanks would be sent by the Chair.

ACTION: Chair

Julia Diamond-Conway explained that there were potentially 2 new Group C representatives, Terry Riches and Kathyrn Everitt. It was noted that formal approval would be sought for both Terry and Kathyrn to join SACRE once they had confirmed their intentions in writing.

2. NEW OR SUBSTITUTE MEMBERS

Members noted that Mr Atta Ullah-Issah would be joining the meeting representing the Ahmadiyya Muslim faith in the absence of Nasir Mubashar

3. MINUTES OF MEETING HELD ON 3 DECEMBER 2019 AND MATTERS ARISING

- 3.1. The notes of the meeting held on 3 December 2019, were agreed as a true record.
- 3.2. Matters arising from the minutes (not included elsewhere on the agenda) were noted as follows:
 - 3.2.1. <u>Havering School Improvement Services (HSIS) termly update</u>
 (minute 4.2.3, refers): The clerk confirmed that both the autumn and spring term HSIS newsletters had been distributed to SACRE members.

3.2.2. <u>Resource catalogue (minute 4.2.4, refers):</u> An update would be brought to the summer term SACRE with regards to the Resources catalogue.

ACTION: Deborah Weston

3.2.3. NASACRE Conference (minute 4.2.5, refers): It was confirmed that the link to the resources shared at the NASACRE Conference had been shared by Julia Diamond-Conway.

Jenny Fox and John Lester arrived at 6.05pm

3.2.4. Membership (minute 4.2.6, refers): Julia Diamond-Conway reported that she had contacted the Board of Deputies with regards to identifying another representative to replace Rabbi Lee Sunderland. The Board of Deputies agreed to look to identify a new member to ensure the Jewish Community were represented within the Havering SACRE. An update would be brought to the next meeting.

3.2.5. <u>Syllabus errors (minute 10, refers):</u> Kamal Siddiqui was not present to confirm if he had submitted the errors within the syllabus with regards to the Sunni Muslim faith.

4. NEW OFSTED FRAMEWORK

Members noted that at the previous meeting discussions had been held with regards to the impact of the new Ofsted framework on Religious Education (RE). As yet, there had not been any 'deep dives' into RE as part of an Ofsted within Havering however there had been nationally. Members were advised that in December NASACRE had reviewed the first 100 Ofsted reports following the introduction of the new framework and RE had been cited on a number of occasions even when RE had not been a specific focus of the inspection. A key change was evident in that Inspectors were ensuring that schools had not 'narrowed' their curriculum; schools which had proactively looked to visit and discuss different places of worship in order to make learning 'real' had received positive feedback.

SACRE Members requested whether examples could be provided of when RE had been mentioned in the Ofsted outcome report within Havering moving forward. The clerk agreed to investigate further.

5. AGREED SYLLABUS

It was noted that members had looked at feedback from teaching staff at the previous meeting in relation to whether they would welcome a new syllabus. Feedback, on the whole, had been that although difficult at first to implement teachers would prefer to retain the current syllabus. Some areas however had been identified as potential areas of development such as guidance on assessment and resource lists.

SACRE members were advised that Redbridge SACRE were also holding the same discussions regarding the agreed syllabus. Julia Diamond-Conway proposed that if their discussions were similar and were based on retaining the syllabus with some targeted improvements consideration should be given to look into joint commissioning. To make a formal decision regarding this a formal vote would be required at the next meeting.

The Chair invited members to share their thoughts around the proposal. A member questioned that if both SACREs agreed to move forward with joint commissioning who would be approached to undertake the review and improvement of the syllabus. Julia Diamond-Conway responded that there were RE Advisors/Consultants available however it would be beneficial to collaborate with RE Subject Leaders in local schools when reviewing any changes or enhancements to the syllabus. The Chair agreed that it was important for teachers to be involved so that they were more engaged with the process and the agreed syllabus.

A member shared some concern that they did not wish to agree to a joint commissioning arrangement with Redbridge without fully understanding what this model would look like. Julia Diamond-Conway reassured members that no decisions had been made and that if it was agreed to move forward a formal vote would need to take place by convening an 'Agreed Syllabus Conference' in the summer term. This conference could be incorporated into the SACRE meeting if required. Members agreed to consider joint commissioning with Redbridge should this also be their wish.

6. UPDATE ON LOCAL SCHOOL ACTIVITY

Members had received the local school activity report; there were no questions. Members were invited to contact Julia Diamond-Conway should they wish to represent Havering SACRE at the NASACRE Conference in London on 18 May.

7. NATIONAL DEVELOPMENTS IN RELIGIOUS EDUCATION

Members noted the report on national developments in RE; there were no questions.

8. SCHOOL WEBSITE REVIEWS

Members noted that in previous years SACRE had audited school websites to review the provision of RE and collective worship within Havering Schools. The Chair requested members to agree to undertake some school website audits at home in readiness for the next meeting; a list had been provided which reflected schools which had not been audited in 2017-2018 which members could put their name to. Julia Diamond-Conway agreed to send the clerk a copy of the website audit; the clerk would distribute to SACRE members.

9. ANY OTHER BUSINESS

A member questioned if those children who had won the art competition would be awarded with a certificate (or similar) on behalf of SACRE. The Chair was surprised to hear that the winners had not received an award as this had been her expectation. Members acknowledged however that the winners had been notified in December and that potentially too much time had now elapsed to present a meaningful certificate to the children. It was noted that the winners had been identified as part of Julia-Diamond-Conway's RE article in the HES spring term newsletter. Members agreed that certificates would be awarded in a timely manner following any further competitions in the future.

Members agreed that it would be nice to run an annually event, potentially at Easter time. It was agreed for members to bring ideas to the next SACRE for further discussion.

Local RE update

Subject Leaders' meetings

This term's Subject Leaders' training was delivered via a webinar rather than face to face due to Covid-19. All delegates were able to access a pre-recorded webinar and a number of resources to support planning and teaching.

Next term's Subject Leaders' meeting will be held on 29th September.

RE Syllabus Review

Julia Diamond-Conway has been in discussions with members of Havering Education Services' (HES) staff about suggested revisions to the syllabus.

Revisions considered and costs were:

Item	Quantity required	Price (to be shared by Havering and Redbridge)
Expand the 1 page unit plans into full unit plans.	9	£9 900
Expand the medium length unit plans into full unit plans.	8	£6 600
Add resource lists to each unit	17	£1 375
Update unit 2.14 which has proved unpopular in Havering schools	1	£550
Create an assessment exemplification document	1	£550
Create a document to highlight progression within the syllabus in light of the new Ofsted inspection framework	1	£1000
RE Today advisers leading a day's worth of training and a launch event (price to be deducted if all items on the list are purchased)	1	£2000

Havering has fewer maintained schools than Redbridge, so would be charged £7,334. It was hoped that by charging schools to attend the launch event, the LA could recoup much of the costs, so would be asked to underwrite the £7,334. However, in the current climate, a face to face launch day over the next few months may well be an impossibility. Havering have had to cancel all conferences at the moment and cannot confirm when these will resume.

After considering the educational landscape, funds and responses to the survey, HES is considering the revisions that seem to be the most pressing, which are:



An assessment exemplification document

A document to highlight progression within the syllabus in light of the new Ofsted inspection framework

Update unit 2.14 which has proved unpopular in Havering schools

Although these are not all of the revisions that SACRE were asking about, the lack of central funding is a key issue. Staff from HES are confident that the LA is fulfilling its statutory obligations as Havering already has a comprehensive syllabus, high-quality RE training and funds SACRE.

Open University course on religious literacy

Why Religion Matters: Religious Literacy, Culture and Diversity https://www.futurelearn.com/courses/why-religion-matters/ is a free, 4-week (12 hours) course presenting some of the latest university-level thinking on religious literacy in an accessible and interactive way. It should be easy for RE Teachers to apply these principles in their presentation of curriculum and topical discussions. The next start date for this course is 2nd November 2020. FutureLearn hosts courses provided by a number of universities and partners. It has other upcoming courses on religion, so teachers and RE professionals may like to keep their eye on this, alongside other e-learning platforms (such as EdX) which

RE teachers' engagement with research

provide courses on religions and beliefs.

Culham St Gabriel's and the Graduate School of Education, University of Exeter are collaborating on a research study exploring RE teachers' engagement with research. Culham St Gabriel's Research for RE strategy and wider discourses surround CPD, have emphasised the valuable role that research can play in teachers' professional development and practice. However, deeper understanding is needed about the range of ways RE teachers engage with research, access it, mediate it, interpret it, and use it to inform practice within school contexts. Teachers of RE in primary, middle or secondary schools in England or Wales who would like to get involved in this project should contact Samantha Brown (research assistant) at the University of Exeter at s.brown6@exeter.ac.uk. Participation would involve a virtual interview, lasting approximately one hour.

Developments in Wales

Following the Welsh Minister for Education's announcement last January of her intentions to re-name RE Religion, Values and Ethics (RVE) as well as to remove the parental right of withdrawal from the subject, Welsh Government is now consulting on proposal to make legislative changes for religion, values and ethics in the Curriculum for Wales Framework. The proposals involve making significant changes to the scope of RVE, arrangements for SACREs and Agreed Syllabus Conferences (ASCs) as well as to the expectations placed upon different types of schools.
