- using any other means for enabling persons not present to see or hear proceedings at a meeting as it takes place or later; or
- reporting or providing commentary on proceedings at a meeting, orally or in writing, so that the report or commentary is available as the meeting takes place or later if the person is not present.

Anyone present at a meeting as it takes place is not permitted to carry out an oral commentary or report. This is to prevent the business of the meeting being disrupted.

Anyone attending a meeting is asked to advise Democratic Services staff on 01708 433076 that they wish to report on the meeting and how they wish to do so. This is to enable employees to guide anyone choosing to report on proceedings to an appropriate place from which to be able to report effectively.

Members of the public are asked to remain seated throughout the meeting as standing up and walking around could distract from the business in hand.

**13 APOLOGIES FOR ABSENCE & SUBSTITUTE MEMBERS**

Apologies were received from Councillors Joshua Chapman (Ray Best substituting) and Gillian Ford (Gerry O'Sullivan substituting).

**14 DISCLOSURE OF INTERESTS**

There were no disclosures of interest.

**15 MINUTES**

The minutes of the meetings held on 22 June and 10 August were before the Committee for approval. It was noted that Councillors G Ford and Morgon were present at the meeting held on 22 June.

The minutes of both meetings were otherwise agreed as a correct record.

**16 OUTSIDE BODIES**

The Committee agreed to adopt the new procedure for appointments to Outside Bodies, as set out in the report. Appendix 1 to these Minutes lists the Non-Executive appointments that were agreed at Governance Committee and subsequently at Council on 7<sup>th</sup> September 2022.

It was agreed that details of the remaining vacancies should be circulated to all Councillors. In the event that more than one Member expressed interest in being appointed, the organisation would be invited to select the most suitable candidate. It was hoped that in this way, expertise and experience could be more closely matched with the role and purpose of the organisation.

The Committee agreed that several organisations should be removed from the list of formal Council appointments to Outside Bodies (attached as Appendix 2 to these minutes). It was noted that these organisations could still benefit from Councillor involvement and officers would continue to circulate details of any representation that was required. However, future nominations would not need to be ratified by Governance Committee and, in the unlikely event that it is required, Councillors sitting on these organisations would not be able to avail themselves of indemnity insurance cover. In addition to the organisations listed, officers were asked to clarify the position with the Havering Theatre Trust and Romford Combined Charities, to establish whether or not the Constitutions and Terms of Reference for these two bodies would allow for appointments to be made independently of the Council process.

## 17 **CONSTITUTION REVIEW**

A report presented to the committee a number of changes to the Constitution made by the Monitoring Officer under her powers as well as a series of other changes that would require the approval of full Council. The report also recommended that a cross party working group be established to undertake a full review of the Constitution.

It was noted that the proposed Constitution wording re the People Overview and Scrutiny Sub-Committee would need amending slightly at paragraph 4.4 as it was not mandatory that members of the Sub-Committee would automatically become members of the Corporate Parenting Panel.

It was hoped to complete any review of the Constitution by the end of the municipal year and periodic reviews of the Constitution would follow after that point. It was felt that this would give an opportunity to modernise the Constitution and make it clearer.

It was **AGREED**:

- 1. That the changes made by the Monitoring Officer in Appendix 1 to the report be noted.**
- 2. That the proposed changes to the Constitution as shown in appendix 2 of the report be approved and recommended to Full Council.**
- 3. That a cross party working group (“the Constitution Review Working Group”) be established with a membership as recommended in paragraph 1.5 of the report, to undertake a full review of the Constitution.**

**18 EXCLUSION OF THE PUBLIC**

It was agreed that the public should be excluded from the remainder of the meeting on the grounds that it was likely that, in view of the business to be transacted or the nature of the proceedings, if members of the public were present during these items there would be disclosure to them of exempt information within the meaning of paragraph 1 of Schedule 12A to the Local Government Act 1972.

### **SUMMARY**

The Council makes appointments to a large number of other organisations, some statutory, others voluntary.

Since the new executive governance arrangements came into force, responsibility for making some appointments has passed from this Committee to the Leader of the Council but the Constitution provides that it is for this Committee to make recommendations to the Leader.

## RECOMMENDATIONS

That the Committee **AGREES**:

- (1) The full list of Non Executive appointments to Outside Bodies attached at Appendix 1
- (2) All remaining vacancies to non-executive appointments to the organisations referred to in this report, for the period until the meeting that deals with appointments for the municipal year, 2023/2024 (or such other period as may be relevant in any specific case).

## REPORT DETAIL

- 1.1 The Committee is authorised to make all appointments to other organisations (other than executive appointments, which are made by the Leader). Appointments are for the period expiring at the first meeting of this Committee in the municipal year 2023/24 (probably during the last week of May 2023), except where otherwise specifically provided.
  - 1.2 **Appendix 1** lists the appointments made by office and by individual member, but that are not executive. The number of appointees required for each organisation is indicated in brackets.
  - 1.3 Appointments that do not require review or renewal for the present are shown in italics. **The Committee is asked to note these appointments.**
- 2. Update on the appointments process:**
- 2.1 At the meeting of Governance Committee on 24<sup>th</sup> August 2022, it was agreed that a different approach should be taken in the process for making non-executive appointments to Outside Bodies. Accordingly, Officers contacted all Members with details of roles and frequency of meetings, etc to invite expressions of interest. As a result, all vacancies have now been filled, with the exception of:
    - 2 x remaining vacancies on SACRE
    - 1 x Squirrels Heath Ward Councillor for the Durham Estate Tenant Management Association (DELTA)
    - 1 x Rainham & Wennington Ward Councillor for the Wennington Quarry Community Liaison Committee

- 2.2 Officers contacted the following organisations to confirm that any future Councillor representation would not need to be ratified by Governance Committee and, in the unlikely event that it is required, Councillors sitting on these organisations would not be able to avail themselves of indemnity insurance cover.
- Citizens Advice Havering
  - Havering Arts Council
  - Havering Association for People with Disabilities
  - Havering Bands & Majorettes Association
  - Havering Sports Council
  - Havering Theatre Trust
  - Relate North East
  - Romford Combined Charities
  - Sight Action Havering
  - Wennington Quarry Community Liaison Committee
- 2.3 The Havering Bands & Majorettes Association and Relate North East did not respond.
- 2.4 In addition, Havering Theatre Trust and Romford Combined Charities indicated that the Constitutions and Terms of Reference of their respective organisations would not allow appointments to be made independently of the Council process. These two bodies, will therefore remain on the formal list of Non Executive appointments made by Governance Committee. There are existing vacancies for both the Havering Theatre Trust, following the resignation of Councillor Christine Smith and for the Romford combined Charity since Councillor Dilip Patel has indicated he wishes to step down from the role. Expressions of interest have been invited for both vacancies and are in the process of being filled.
- 2.5 The remainder assented to the new process and details of bodies still interested to receive Councillor representation have been circulated to all Members with an invitation to contact the organisations directly

**Policy context:**

Webcasting is a means of making the Council's decision-making procedures open and accessible to its stakeholders

**Financial summary:**

Limiting the live webcasting to specific Meetings will enable costs to be met within the existing budget.

### SUMMARY

Havering Council has been 'webcasting' meetings of Full Council and Cabinet since December 2009. In response to the COVID pandemic, there was a statutory requirement to webcast all meetings; this ran from April 2020 to July 2021. Since then the council has continued to webcast all meetings pending a decision on what future webcasting provision should include.

Officers have considered options with lead members and considered which meetings should continue to be webcast, taking into account viewing numbers and costs.

Having canvassed other London Boroughs, those offering webcasting are either adopting the system currently being used at Havering, or they have an alternative supplier offering a similar spec or they have had a complete refurbishment of the rooms where Council Meetings take place.

As part of this process an options paper was presented to the Architect Design Board for consideration. Options considered were to:

- Upgrade the existing System
- Consider alternative Providers
- Use of MS Teams/YouTube
- Inclusion in the Town Hall Refurbishment Specification

Having considered the available options it appears that whilst the use of Teams is an option for Committee Rooms 1 and 2/Meeting Rooms within the Town Hall complex, it is not an option for the Council Chamber. This is because Teams is not compatible with the existing system in use in the Council Chamber, which involves having links to a Voting system, tracking cameras and Microphones. The same issue applies to the use of YouTube for webcasting meetings.

Viewing figures in Appendix 1 show that Council, Cabinet and Planning Committees generate the highest number of online views. Whilst Licensing Committee is better suited to the Council Chamber as it has the potential for a higher number of in person viewing.

## **RECOMMENDATIONS**

Following evaluation of all options the Committee agrees that:

- The current system used in the Council Chamber is upgraded, therefore improving the quality and reducing the risk of equipment failure.
- The following meetings are held in the Council Chamber:  
Council, Cabinet, Planning Committee, Strategic Planning Committee and Licensing Sub-Committees.
- All other meetings are held in meeting rooms within the Town Hall complex.

## **REPORT DETAIL**

### Introduction

1. As part of its commitment to improving engagement with local people, the Council commenced the webcasting of meetings of Full Council and Cabinet in December 2009.
2. Those arrangements remained in place until the outbreak of COVID. The Coronavirus Act 2020 introduced temporary regulations which required that all council meetings had to be broadcast whilst virtual meetings were in operation.

3. Attached in Appendix 1 are viewing figures from June 2021 – July 2022 live views and playback. The meetings of Full Council, Cabinet and Planning have the highest viewing figures.
4. The Town Hall Council Chamber has limited space to accommodate viewing public with admission granted on a first come first served basis. The webcasting arrangement has therefore enhanced the opportunity for democratic engagement.
5. The current equipment and broadcasting quality has become less reliable, and on occasion resulted in broadcasting failure in recent months. This is primarily due to the age of the equipment and requirement of a system upgrade.
6. All other meetings should be held in meeting rooms within the Town Hall complex. These meetings are likely to be more suited to a board room style set up, and would benefit from a less formal environment. This would allow for the Council Chamber to become available for other bookings, as well as reduce the burden on attendance of Democratic Services staff. These meetings will benefit from the new audio/visual system within the Town Hall, which have the facility to record meetings. Recordings will be made available on the website the following day to view.

## **IMPLICATIONS AND RISKS**

### **Financial implications and risks:**

By agreeing to the recommendations in the report these changes can be met within the existing budget.

### **Legal implications and risks:**

There is no legal obligation to webcast council meetings, either in audio or visual format.

### **Human Resources implications and risks:**

There are no HR implications and risks associated with the report.

### **Equalities implications and risks:**

There are no direct equalities implications or risks, however any provision for the webcasting of council meetings is considered to enhance Council compliance with equalities legislation and helps to promote knowledge of local democracy decision-making.
