#### **Havering SACRE, Local RE update: Autumn 2023**

This term's Subject Leader meeting was held on 21<sup>st</sup> September. The focus was on Aims of RE within the Havering Agreed Syllabus for RE.

- A. Know about and understand a range of religions and worldviews so that they can: describe, explain and analyse beliefs and practices, recognising the diversity which exists within and between communities and amongst individuals; identify, investigate and respond to questions posed, and responses offered by some of the sources of wisdom found in religions and worldviews; appreciate and appraise the nature, significance and impact of different ways of life and ways of expressing meaning.
  - B. Express ideas and insights about the nature, significance and impact of religions and worldviews, so that they can:
  - explain reasonably their ideas about how beliefs, practices and forms of expression influence individuals and communities;
  - express with increasing discernment their personal reflections and critical responses to questions and teachings about identity, diversity, meaning and value, including ethical issues:
  - appreciate and appraise varied dimensions of religion or a worldview.
  - C. Gain and deploy the skills needed to engage seriously with religions and worldviews, so that they can:
  - find out about and investigate key concepts and questions of belonging, meaning, purpose and truth, responding creatively;
  - enquire into what enables different individuals and communities to live together respectfully for the wellbeing of all;
  - articulate beliefs, values and commitments clearly in order to explain why they may be important in their own and other people's lives.

Attendees discussed the meaning of each of these aims and how they link with the information in the most recent Ofsted research review into RE. The group looked at how these aims were apparent in unit plans and started to identify them in particular plans. It was felt that this could be a worthwhile job for the group to take forward, as it would familiarise teachers with where the aims appear in the plans and would benefit all primary teachers of RE in Havering if the results were shared via the portal. Therefore, a short part of the training day at CEME in March will be devoted to this activity.

The CPD session this term will be held on 23<sup>rd</sup> October 2023. This is open to any member of staff teaching RE in primary schools rather than just subject leaders. The group have asked for a Q and A session about RE and will be invited to submit questions beforehand, although this is not a requirement. If time, the meeting will then progress to interactive methods of teaching RE in the primary classroom.

# National SACRE Updates for SACRE From RE Today / Autumn 23

#### **Open letter from over 30 Parliamentarians**

An Open Letter was published on the 18<sup>th</sup> September by the Daily Telegraph. More than 30 MPs and peers have written to the Education Secretary, highlighting that school pupils receive tokenistic religious education or none. The MPs are blaming this on a lack of trained teachers and funding for the poor quality of religious education. They argue that this lack of education leaves children ill-prepared to understand their own and others' worldviews, hindering their ability to participate in society. Link to the <u>letter</u>

#### DfE Guidance on the place of Humanists on SACREs

The DFE have produced guidance which has now been sent to local authorities. It makes clear that, in relation to committee A, it is the Local Authority who select which groups can be represented on the local SACRE and on the Agreed Syllabus Conference (ASC) and that this selection may include representatives from non-religious belief systems.

Guidance for local authorities about membership of Standing Advisory Councils for Religious Education (SACRES)

This note provides information on a recent court ruling and shares the Department for Education's (the Department) view that representatives from non-religious belief systems may be appointed to Group A of a SACRE and/or to an Agreed Syllabus Conference (ASC).

#### **Background**

SACREs are established by local authorities, as required by legislation [1], and their membership must consist of the following groups:

- •Group A: members that represent Christian denominations and other religions and their denominations who will appropriately reflect the principal religious traditions in the area;
- •Group B: members that represent the Church of England;
- •Group C: members that represent the teaching profession or other relevant associations that, in the opinion of the authority, ought to be represented; and
- •Group D: members that represent the [local] authority.

The recent legal case of *Bowen v Kent County Council* [2] (more details in the Annex) clarified that applications for Group A membership from persons who represent holders of non-religious beliefs should be considered in the same way as applications from those who represent holders of religious beliefs.

In the Department's view, the non-religious beliefs adhered to by the person to be appointed must be analogous to a religious belief. To be "analogous", the non-religious beliefs must, in accordance with case law under the European Convention of Human Rights and the Human Rights Act 1998, attain the necessary level of cogency, seriousness, cohesion, and importance to attract protection under the Convention Rights. The final decision on appointment of persons to a SACRE or ASC is a matter for local authorities. This may include consideration of whether such a representative would help ensure that the relevant traditions and beliefs in the local authority's area are appropriately reflected in Group A.

#### Recruitment crisis in teaching and especially in secondary RE

A campaign to attract a new generation of RE teachers has been instigated with teaching groups, religious organisations and parliamentarians stressing the importance of the subject for preparing students for life in modern Britain. As of January, UCAS data show that teacher recruitment for all subjects is down 22% from last year. However RE stands out, being down a third of applicants from the last recruitment cycle. The shortage of religious education (RE) teachers has been highlighted in a Religion Media Centre briefing. Link to webinar below:

The recruitment campaign – entitled 'Beyond the Ordinary' - draws attention to the academic and knowledge rich approach of the subject to life's big questions, and will seek to attract a set of talented graduates up to the task of getting young people to grips with the complex nature of modern belief.

The RE council is campaigning for the government to create a national plan to support high standards in RE provision and bursaries to encourage new teachers.

Question for SACRE: Do we know what this problem is like in our Secondary schools? How can we find out more?

#### NATRE analysis of GCSE and A level Religious Studies data: National and regional variations

The reports linked to below cover GCSE and A level RS in both England and Wales and reveal many similarities and some differences between the two nations in relation to trends over time. It is clear that the removal of the short course from performance tables has had a devastating impact on the number of children leaving school with a qualification in Religious Studies. In many cases, the loss of the short course has coincided with an increase in the number of schools reporting zero hours of timetable time for RE in year 11 in the school workforce data. At A level, entries have remained fairly stable over recent years in England but in Wales, there is a step decline, of around 33% since 2020. The reasons for this need further investigation.

#### For example:

A level West Midlands % A\*-C 2023 76.7 % (Nat 79%) Uptake in West Midlands 2.4% (Nat 1.88%) GCSE West Midlands % Grade 9-4 2023 69.9% (Nat 72.2%) GCSE Uptake West Midlands 27.2% (National Average 25.7%)

## NATRE provide evidence at Education Select committee enquiry session

NATRE, along with 3 other subject associations, were invited to speak to a session of the Education Select Committee to support their enquiry into Recruitment and retention of teachers. Deborah Weston, NATRE Research Officer and Chair of the RE policy unit (Joint group made up of NATRE, REC, RE Today), gave evidence in the two hour session.

Deborah Weston is quoted:

'Deborah Weston, research officer at the National Association of Teachers of Religious Education, told MPs that "schools are very inflexible places". She said that the "pressures on headteachers are so significant in terms of accountability...that there's a nervousness about taking people on part time". Ms Weston also argued for an increase in the provision of part-time training to become a teacher, arguing that this could boost recruitment and retention.'

#### **RE at the Party Political conferences**

In late September and Early October, teams of teachers from NATRE joined representatives from the Religious Education Council of England and Wales (REC), Culham St Gabriel's and RE Today to attend the Labour, Conservative and Liberal Democrat party conferences.

At the party conferences, they shared the importance of high-quality RE for all pupils in all schools, talking about the need for a national standard in the subject, sharing constituency data related to RE with MPs, SACRE members, local councillors and party members and talking about what high-quality RE looks like in Primary and Secondary classrooms.

## Training, networking, and other support

#### Global Neighbours: school awards from Christian Aid

The Global Neighbours accreditation scheme is an award scheme for schools run by the charity Christian Aid, in partnership with the Church of England Education Office. It is open to all primary schools and has recently expanded into secondary schools too. The scheme has been has been running for five years and celebrates the development of global citizenship and courageous advocacy in schools. Its aim is to encourage a deeper understanding of the world and for young people to be empowered to engage with and respond to global issues.

Schools can apply for a bronze, silver or gold award. To achieve accreditation, schools must demonstrate how they are fulfilling criteria relating to:

- Leadership, vision and values
- Teaching and learning
- Collective worship and spiritual development
- Pupil participation in active global citizenship
- Community engagement

#### RE Connect Teacher Fellowship Programme

This programme is designed to help deepen teachers' understanding and confidence for exploring the environmental crisis through the lens of religions and worldviews in RE. The programme is not just about getting ideas, but also enhancing your teaching practice and professional network around this theme.

After a successful pilot of the programme in 2021-22, RE:Connect will be running again from September 2023, thanks to a grant from the Culham St Gabriel's Trust. There are places for **up to 10 teachers** of RE (primary and secondary) on the 6 month teacher fellowship programme.

The initiative is run by Dr Jeremy Kidwell, Associate Professor in Theological Ethics at the University of Birmingham and Dr Ian Jones of St Peter's Saltley Trust, with input from experienced primary and secondary specialists, environmental scientists, climate activists and academic researchers in religion and environment.

The programme offers opportunities to:

- Deepen subject knowledge on the intersection of religion and ecology
- Work with cutting-edge subject specialists on religious ethics/practice, ecology, and climate change policy
- Work as part of a supportive and dynamic team to create and trial new approaches and resources for teaching on this theme
- Become a champion for teaching and learning on religion and environmental crisis

The Teacher Fellowship Programme involves monthly workshops from Autumn 2023 to Spring 2024, with tasks to undertake between workshops. Programme sessions will include one fully-funded weekend residential and 6-8 online evening sessions (roughly one per month). There is no cost of participation to the teacher or their school and Fellows receive a bursary of £500 to cover costs of participation plus travel expenses to enable attendance at in-person sessions.

Foreword

#### Overview of the work of SACRE

Since 1988, each Local Authority (LA) has been required by law to have a Standing Advisory Council for Religious Education (SACRE).

The remit of a SACRE is principally to oversee the Religious Education (RE) and collective worship within the authority principally to:

- advise Havering Council upon matters connected with religious worship in community schools and
  in foundation schools which do not have a religious character. Religious education in these schools
  is to be given in accordance with the Agreed Syllabus;
- advise Havering Council on teaching methods, choice of materials and teacher training in religious education and collective worship;
- require Havering Council to review the locally agreed syllabus for religious education at least every five years.

The reporting period of the 2022-2023 report starts from September 1<sup>st</sup> 2022 and runs to August 31<sup>st</sup> 2023.

SACRE met on four occasions during the academic year 2022-2023, Thursday 29<sup>th</sup> September 2022 (virtual meeting), Tuesday 22<sup>nd</sup> November 2022 (face to face meeting at Ardleigh Green Junior School), Monday 6<sup>th</sup> March 2023 (face to face meeting at the Catholic Church of Christ the Eternal High Priest) and Wednesday 21<sup>st</sup> June (face to face meeting at the Romford Evangelical Free Church). All meetings were quorate with the exception of 22<sup>nd</sup> November and minutes for these meetings are available on the Havering Council website

#### **Section 2: Religious Education**

#### The Locally Agreed Syllabus and RE in schools

RE is not part of the national curriculum. Each LA is required to produce an Agreed Syllabus for RE. Each LA is required to begin reviewing the current Agreed Syllabus within five years of its production. During this academic year, the new Agreed Syllabus was launched with a half day training event for teachers at CEME on 7<sup>th</sup> October 2022. Havering has once again produced its syllabus alongside Redbridge and teachers from both boroughs were in attendance. It is expected that schools required to teach the syllabus will implement the new one by September 2023.

Whilst the new syllabus is similar to the last one, it has a larger suite of resources including a full unit plan for each suggested key question, resource lists for each unit, exemplification and progression documents. The unit plan for unit 2.14 has proved unpopular with Havering schools in the past, so whilst the key question has remained the same, the unit plan was rewritten with the help of teachers from Ardleigh Green Junior School and Branfil Primary School. During the training day, teachers were reminded of the main features of the syllabus and introduced to the new resources.

#### Standards and monitoring of RE

During this year, SACRE began to monitor RE through the use of school websites. Members were able to manage this task outside of SACRE meetings.

For the first year since the pandemic, this academic year was the first in which SACRE was able to scrutinise data from exams sat in the summer of the previous year. This was triangulated with the school workforce data.

At present, the results from 2023 are unvalidated. Please see appendix A for the unvalidated results from 2023.

#### Teacher training materials and advice for schools

This year saw six virtual twilight CPD sessions for RE in primary schools. Three of these were designed for Subject Leaders and three for all staff delivering RE, although Subject Leaders were the biggest audience at all six sessions. HES also provided a face to face Subject Knowledge Enhancement day for primary leaders of RE which took place at CEME and focused on intent, implementation and impact of RE.

All meetings give attendees the opportunity to network and receive updates. Main themes for each meeting are chosen in collaboration with attendees at the previous sessions.

Main themes for Subject Leader meetings:

Autumn term – Ways of Knowing in RE (linked to the latest Ofsted Research Review of RE)

Spring term – Implementation of the new Local Agreed Syllabus and activities for retrieval in the RE classroom

Summer term – Designing tasks to show progress and understanding

Main themes for RE CPD meetings:

Autumn term - Teaching RE with Confidence

Spring term – Encouraging questioning in RE

Summer term - Engagement in RE

The Associate RE Adviser provides support by phone and email and is able to visit schools on request.

#### Other information

There were no formal complaints to SACRE about RE during the year.

#### Advice given to the Local Authority

Advice was given to the local authority around the new RE agreed syllabus and which documents should be made available to teachers.

#### **Section 3: Collective worship**

#### Standards and monitoring of Collective Worship

As far as HSIS and SACRE are aware, schools remain compliant. There has been no indication otherwise in quality assurance reports, network meetings of Ofsted reports. HSIS is also recommending to governing bodies that governors ask schools about Collective Worship. In order to enable governors to do this in an informed manner, a training session on Collective Worship for governors (to which SACRE members are invited) will take place at the start of the next academic year.

No determinations have been requested in the year 2021-2022. SACRE is working to ensure that a procedure for determinations in Havering schools is drafted and can be sent to the LA for improvement or adoption.

#### **Teacher training provided**

No training on Collective worship has been provided in 2021-2022.

#### Other information

There were no formal complaints to SACRE about collective worship during the year.

#### **Advice to the Local Authority**

Advice was given to the Local Authority that training could be provided to governors on Collective Worship and a publication on Collective Worship in Havering could be provided to schools.

#### Section 4: Links with other bodies

#### **National Bodies**

Havering SACRE are pleased to be linked with national bodies and receive national updates from Julia Diamond-Conway our RE adviser.

Havering SACRE has links with NASACRE and has received feedback from the NASACRE annual conference. It regularly utilises NASACRE's self-evaluation toolkit.

Information from NATRE and the REC has been used in meetings and shared with schools where appropriate.

#### Local bodies

Chelmsford Diocese provide excellent support to SACRE and we are pleased to have its RE Lead Schools Adviser as a member of committee B.

Local places of worship are well represented on SACRE.

#### Section 5: SACRE involvement in the Local Area

#### Governor and head teacher links

This year, the decision has been taken to involve governors more fully with the monitoring of Collective Worship and ensure that they have a good understanding of this. Therefore a training session is being organised for governors in Havering schools during the next academic year.

#### Advice on community issues

The RE adviser regularly gives advice on speakers coming into schools and visits to places of worship locally.

#### Section 6: Managing the SACRE and partnership with the Local Authority (LA)

#### Professional and administrative support

During the reporting period, clerking of SACRE was undertaken by Michelle Morgan of Havering Governor Services.

The Local Authority provided funding to support SACRE activity 2021 -2022 by contracting with RE Today Services of an RE Consultant for up to 6 days during the year. These days include attending SACRE meetings, writing statutory annual report, providing national updates and information and first response consultancy.

Julia Diamond-Conway from RE Today continued in the role of RE consultant.

Susan Sutton, Education Quality and Effectiveness manager holds responsibility for SACRE support and liaises with the RE consultant.

#### **Training**

Teacher representatives have attended Network meetings, CPD meetings and a CPD day. One representative gave feedback from NASACRE's annual conference so that all could benefit. #### **Finance**

The LA allocated £4200 for support to SACRE from the RE Consultant. £600 was allocated for clerking. £105 was utilised on NASACRE membership. It should be noted that the Local Authority spent more widely on Religious Education during the reporting period with money being allocated to primary Subject Leaders' Network meetings, CPD twilight meetings and a CPD day for those leading RE in primary schools.

## Agenda Item 7

#### **Havering SACRE Determination Form Plan**

Havering SACRE is aiming for a succinct form which will include:

- 1. An explanation of the law for ease of reference. This will also give definitions of the terms Collective Worship, Assembly and Reflection. As part of the explanation of the law, the information will be shared that a determination lasts for 5 years and then the school needs to reapply, however, Havering SACRE understands that schools may have reasons for reapplying beforehand if they wish their determination to be altered in some way, and this is acceptable.
- 2. **A flowchart** to show the process, including expected timeframes.
- 3. **A checklist** so schools can make sure they have collected all the evidence they need and finished all the groundwork before filling in the application form.
- 4. **The application form** itself. Most questions should be in the form of tick boxes unless evidence needs to be submitted or reasons given. If reasons need to be given, space should be left for this on the form. Space could be left here for worldviews and language spoken at home here. A note should be on this form, advising schools that determination is a serious request.
- 5. **Instructions for SACRE members** who attend meetings with school staff re determinations or go on visits to schools re determinations.

Prior to the meeting, SACRE Members had received the following documentation to use as a reference when considering a determination process for Havering:

- Determinations: Putting a system in place for your SACRE Lesley Prior.
- Determination process London Borough of Ealing SACRE.
- Seeking a determination process London Borough of Lewisham SACRE.

Members worked in groups to review the information provided and share with the group any particular aspects that could be incorporated into the Havering process. A summary of the feedback received was provided below:

- A determination would last for 5 years however concern was shared that local demographics might change significantly over that period and, therefore could there be an option to change prior to the end of this period?
- Was there a possibility that schools were already just doing what they wanted in terms of collective worship, without seeking a formal determination? JDC advised that governors would be able to ascertain this as part of their monitoring. Previously HSIS (Havering School Improvement Service) had asked schools as part of their quality assurance meetings about collective worship, however this had discontinued post Covid.
- SACRE Members reiterated the importance of having a succinct process. It would be beneficial to include an explanation of the law as part of the request form, for ease of reference.
- Schools would likely access the documentation via the Havering Education Services portal.
- SACRE Members liked the checklist format and the flow chart.
- Consideration needed to be given for those, where English might not be their first language.
- The procedure should include expected timeframes for each stage of the process.
- It needed to be clear that seeking a determination was a serious request and contrary to law. JDC reiterated that Havering maintained schools followed the Agreed Syllabus which included learning about a number of different religious faiths. The determination was linked to collective worship and not the curriculum.
- SACRE Members recommended asking parents about the language spoken at home, from there; schools would have a greater idea of their religion. SN advised that parents born in the UK were more likely to be happy for their children to learn about all religions. Those parents who had moved from certain countries where the nature of that country allowed just one religion, might find it most daunting to allow their children to experience other religions.
- The procedure would be based on the request from the school, however it would be prudent to seek the views of parents.

 The procedure should include SACRE Members visiting the school to meet with staff and ask further questions about their consultation completed with stakeholders.

SACRE Members felt reassured that they had enough information to form their own process. An update would be brought to the next meeting.

9.1. The Chair discussed the situation regarding using the Town Hall as a SACRE venue. Unless Members could meet from 5pm to 7pm, there would be a cost for using the Town Hall, for which there was no budget.

- Romford Baptist Church
- Hylands Primary School
- Pentecostal Church

Dates for the next academic year would be shared after which venues could be confirmed. It was agreed that offering a hybrid option would be explored where technology allowed.
