1. APOLOGIES FOR ABSENCE

Apologies for absence had been received from George Prinn, Dawn Ladbrook, Marlene Wylie, and Dr John Lester.

Absence from the following Members was noted: Om Dhir, Sansar Narwal, Kamal Siddiqui, Rabbi Lee Sunderland, Nasir Mubashar, Luthaneal Adams, Bal Degun, Kathryn Everitt, Terry Riches, Councillor Garrard, and Councillor Ruck.

2. NEW OR SUBSTITUTE MEMBERS

There were no new or substitute Members in attendance.

3. MINUTES OF MEETING HELD ON 21 JUNE 2023 AND 9 NOVEMBER 2023 AND MATTERS ARISING

- 3.1. The minutes of the meeting held on 21 June 2023 were received and agreed as a true record. The minutes had been discussed at the previous SACRE, however, were not approved as the meeting was inquorate.
- 3.2. The minutes of the meeting held on 9 November 2023 were received and agreed as a true record.
- 3.3. Matters arising from the minutes, not included elsewhere on the agenda, were as follows:
 - 3.3.1. <u>Minute amendments, minute 3.1 refers:</u> The clerk confirmed that amendments were made to the Minutes as requested.
 - 3.3.2. <u>Collective Worship (Minute 3.2.2, refers):</u> Training had been provided on 31 January 2024. JDC advised that following the session she had been invited into 2 schools to deliver a session on Collective Worship. The clerk would collate any feedback.

- 3.3.3. <u>Survey re specialist RE teachers (Minute 5, refers):</u> SACRE Members did not discuss the proposed survey.
- 3.3.4. <u>Annual Report 2022-2023 (Minute 6, refers):</u> Approval had been received regarding the Annual Report.
- 3.3.5. <u>Working group (Minute 8, refers):</u> KVC reported that there had not yet been the opportunity to meet with MW and JL to discuss the determination process. JDC made the

recommendation that more SACRE Members could volunteer to join the working party; the Chair confirmed that she would be happy to support. A SACRE Member asked for some terms of reference for the working party. JDC agreed to draft a briefing document.

- 3.3.6. <u>Website monitoring (Minute 9, refers):</u> The clerk confirmed that a reminder had been sent regarding the website audits.
- 3.3.7. <u>Art competition (Minute 10, refers):</u> As the meeting was being held virtually, it was agreed that example resources relating to the art competition/exhibition would be brought to the next meeting.

ACTION: JDC

3.3.8. <u>Time of the next meeting (Minute 12, refers)</u>: The time and venue for this SACRE meeting had been amended to reflect Ramadan and enable colleagues to break fast at the appropriate time.

4. UPDATE ON SCHOOL ACTIVITY

SACRE Members received the report on the Local Activity.

JDC reported that excellent feedback had been received following the RE Subject Leader training that had been held earlier in the day.

SN referred SACRE Members to a BBC programme she had featured on where she had led a school assembly on Ramadan. A copy of the link would be shared.

ACTION: HGS

JDC advised that the BBC were in the process of uploading RE clips onto their website such as BBC Bite size and BBC Teach. It was noted that the ERA (Education Recording Agency) were normally able to source old clips if requested.

5. NATIONAL DEVELOPMENTS IN RELIGIOUS EDUCATION

SACRE Members received the report on national developments.

Referring to the Ofsted national findings listed in the report around the teaching of RE in schools, SACRE Members were disappointed to see that many schools were failing to meet the statutory requirement to teach RE to all pupils in all year groups and that pupils were not being taught enough

substance to prepare them to engage in a complex, multi-religious and multi-secular society. A SACRE Member highlighted that with the current conflicts ongoing around the world, the need to encourage discussion amongst young people about different faiths was needed more than ever. It was questioned if the lack of teaching of RE was related to the need for more resources. JDC responded that RE was a subject that was fitted in around the core subjects. At secondary level, even if not taken at GCSE level, pupils should still have Religious Studies, however again, it was often not seen as a priority subject or was referred to as 'life skills' and not explicit enough to be classed as RS.

JDC reported however that Havering did offer quality CPD for RE Subject Leaders and that she provided 1 full day and 6 twilight sessions per year. It was noted that local feedback had been given following Ofsted Inspections, where Subject Leaders had received a 'light dive' into RE and had been able to demonstrate how their pupils had made progress.

A SACRE Member questioned what could be done if schools were not fulfilling their statutory duty. JDC replied that a national contents standard document had been produced to ensure that there was a consistent standard in teaching nationally. Both leading political parties had also stated that education in general would be reviewed following the General Election.

A SACRE Member questioned if Havering was providing enough funding to support the teaching of RE in schools or whether there was a declining standard due to lack of resources. JDC responded that, in terms of CPD and revising the Agreed Syllabus, she felt that Havering was providing adequate funding. However, NASACRE had recently put out a FOI (Freedom of Information) to all Local Authorities and part of the reason was to ascertain the level of funding allocated to RE. It was noted that Havering SACRE did not have a specific budget, however money had always been provided in the past when requested, such as for training. It was anticipated that, once NASACRE had collated the information, Havering would be somewhere in the middle in terms of funding.

A SACRE Member questioned if there was a youth equivalent for the Havering Inter Faith Forum. JDC replied that Newham, for example, had 2 ongoing projects where they had a Youth SACRE and another was Young Ambassadors. It was noted that the roles differed with Youth Ambassadors visiting primary schools to talk about their faiths. Havering SACRE Members might decide to visit Newham to see these projects in action. JDC suggested that establishing a youth project might be an alternative to the previously discussed art competition. This would be considered further at the next meeting.

6. EXAM AND SCHOOL WORKFORCE DATA

A SACRE Member sought clarification on whether the data showed an improvement compared with the previous year however comparative data was not available to scrutinise.

JDC described the triangulation process where SACRE Members would look to compare the number of workforce data hours against the number of pupils taking RE at GCSE level alongside feedback from the website audits; if the evidence suggested low engagement, then SACRE could write to the school to offer support in how to improve. At times, different terminology used by schools meant that it might look as though RE was not covered whereas it may actually be included under 'philosophy and ethics, for example. The Chair and JDC would look at the content of the letters outside of the meeting.

7. HAVERING SACRE ACTION PLAN

SACRE Members reviewed progress against the Havering SACRE Action Plan noting the 3 key objectives:

- Objective 1: Support and monitor quality and standards of Religious Education in Schools
- Objective 2: Monitor Collective Worship and develop protocols
- Objective 3: Improve SACRE impact and effectiveness

SACRE Members acknowledged that although good progress had been made, there remained a number of outstanding website audits that had yet to be completed. A copy of the template, alongside the list of allocated schools to specific members, would be resent out for reference.

ACTION: HGS

It was noted that plans were in place to establish a formal determination process for Havering schools.

SACRE Members were encouraged to attend the free training that was shared via email and included in the papers for the meeting. JDC also encouraged SACRE Members to volunteer their time to come along to Subject Leader meetings as this would help inform teachers and also raise the profile of Havering SACRE.

It was noted that the Collective Worship training had been delivered to which governors had been invited; feedback from discussions at Governing Board meetings would be shared once collated.

JDC suggested that SACRE could look to add more teachers onto its membership; new members could be offered a mentor to give them some additional support.

The Chair advised that she had attended a new SACRE Member webinar led by NASACRE, which had been very useful. It was agreed to have training as a standing item on agendas to give Members the chance to feedback on any sessions attended.

ACTION: HGS (for the agenda)

It was agreed that Havering SACRE were making good progress on the action plan.

JDC highlighted that the NASACRE Conference this year had been scheduled for 20 May 2024. JDC encouraged a SACRE Member to come forward and attend the conference on behalf of Havering, and to feedback what they had experienced at the next meeting. Interested parties were asked to advise the clerk by 15 April 2024 if they would like to attend.

8. SACRE SELF EVALUATION

A copy of the review document completed in June 2022 had been included within the pack, however it was agreed that it was time to review again to see where progress had been made. It was agreed to complete this at the summer term meeting. The outcomes would be used to drive the Havering SACRE Action Plan for 2024-2025.

9. DETERMINATION PROCESS

Those interested in the joining the Working Party would advise the clerk by 15 April 2024.

10. SCHOOL WEBSITE MONITORING 2023-2024

SACRE Members were thanked for completing the website audits; a reminder would be sent out regarding those which remained outstanding.

11.ART COMPETITION/EXHIBITION

As discussed at the previous meeting, although the art competition previously led by SACRE had produced some outstanding work from local schools, feedback was that it was challenging fitting it into an already full curriculum. It had therefore been suggested that a future event would need to be built into the curriculum so that it was not additional work. SACRE Members had agreed that the event could include artwork, poetry or indeed any item of reflection relating to a particular theme. JDC added that another activity could be for schools to have a big display of a particular unit of work which would show off what had already been done; this might also increase the profile of RE in schools. Schools could then be asked to send in a photo of their displays.

A SACRE Member referred back to the idea of establishing a Youth SACRE or Youth Ambassadors, especially as the demographic within Havering had changed significantly; it was important for young people to be able to discuss issues from an educated and informed perspective. It was however acknowledged that this would be a longer-term project. JDC was encouraged to hear enthusiasm for these roles however reiterated that training would need to be put in place for these roles.

It was agreed that SACRE would look to start a creative initiative from September 2024 and that JDC would start to communicate the display focus with Subject Leaders. At the end of the year, it would be possible to make an anthology of the work completed and share as good practice. A prize for the best displays could also be considered.

With regards to the Youth SACRE/Ambassadors, the first step would be to arrange to visit Newham to get a real understanding of the roles. This would be discussed at the next meeting.

Pastor Aloysius Peter and Councillor David Taylor left the meeting at 6.30pm due to other commitments.

12. ANY OTHER BUSINESS

NS thanked SACRE colleagues for changing the meeting venue and time to accommodate Ramadan; all SACRE Members had been supportive of this change.

13. DATE OF THE NEXT MEETING

The date of the next meeting was confirmed as Tuesday 2 July at 6pm. The clerk welcomed SACRE Members to come forward with any offers of venues for future meetings.

1. APOLOGIES FOR ABSENCE

SACRE Members reflected on the sad passing of Rabbi Lee Sunderland who had reached out and worked alongside a number of other faiths. SACRE Members held a minute's silence in remembrance. Apologies for absence had been received from Stephanie Ellner, Ruth Everett, Marlene Wylie, Cllr Tumilty and Dawn Ladbrook.

As there were no Group B (Church of England) representatives in attendance, the meeting was not quorate and therefore any decisions would be deferred to the next meeting.

In the absence of Cllr Tumilty, Dr J Lester chaired the meeting.

Congratulations were passed onto Mr T Mahmood for his recent recognition by being awarded an MBE.

Absence from the following Members was noted:

2. NEW OR SUBSTITUTE MEMBERS

There were no new or substitute Members in attendance.

3. MINUTES OF MEETING HELD ON 19 MARCH 2024 AND MATTERS ARISING

3.1. The minutes of the meeting held on 19 March 2024 were received and agreed as a true record. The minutes however, would need to be ratified at the next meeting due to being inquorate.

ACTION: HGS

- 3.2. Matters arising from the minutes, not included elsewhere on the agenda, were as follows:
 - 3.2.1. <u>Collective Worship (Minute 3.3.2, refers):</u> The clerk confirmed that the governor discussions regarding Collective Worship were currently being collated, and would be brought to the next meeting.

ACTION: HGS

It was noted that training on Collective Worship had been provided for governors and Headteachers; JDC advised that since then, she had been invited into 2 schools to support them to develop their Collective Worship provision.

3.2.2. <u>Working group (Minute 3.3.5, refers):</u> A briefing document on the determination proves had been sent out following the previous meeting as discussed.

- 3.2.3. <u>BBC programme link (Minute 4, refers):</u> A copy of the link to Sidra Naeem's assembly on Ramadan featured on the BBC had been shared.
- 3.2.4. <u>School letters (Minute 6, refers):</u> JDC advised that school letters would be sent out once the monitoring had been completed, and evaluated.
- 3.2.5. <u>Website audits (Minute 7, refers):</u> The Clerk confirmed that the template and the list of schools had been shared.

4. UPDATE ON SCHOOL ACTIVITY

SACRE Members received the report on the Local Activity.

S Naeem reported that Harold Wood Primary School and Rise Park Junior School, had invited herself and T Mahmood to visit them to lead a session on Eid.

JDC referred to the report and advised that Havering Subject Leaders have received 3 CPD sessions; the meeting in May had focused on the published Ofsted report into Religious Education. The next session would include a discussion on non-religious World Views.

5. NATIONAL DEVELOPMENTS IN RELIGIOUS EDUCATION

SACRE Members received the report on national developments.

The report provided a summary of the key outcomes of the Ofsted subject report into Religious Education titled 'Deep and Meaningful?' which was published on 17 April 2024. The report included recommendations not only for schools, but syllabus writers and the Government. The report also included examples of good practice in order to provide clarity to schools. JDC explained that the RE Subject Leaders had gone through the technical definitions included within the report so that they were effectively able to reflect on about their own school's RE provision.

It was questioned if there were any actions required of the LA highlighted within the report. JDC explained that the report did include recommendations around CPD, however Havering already provided 6 twilights and 1 full days' worth of CPD for subject leaders.

JDC agreed to present to the group at the next meeting with regards to the report.

ACTION: JDC

It was questioned if Religious Studies remained an option for undergraduates at university; JDC confirmed that there remained degree options. There was now a bursary available if learning to teach RE, however the funding was not as much as some other subjects and therefore attracted a smaller number of students.

A SACRE Member asked if there was a national decrease in religion. JDC responded that the census data had shown that there was a reduction in people who had a religious world view, however the BBC had reported that there had not been a reduction in interest in religious programming. It was felt that anecdotally, there had been a drop in formal religiosity, but a definite increase in people identifying as being spiritual in some way. There was also a wider number of different faiths and therefore, it was even more important for people to be understanding of each other's beliefs.

6. EVALUATION AND MONITORING

It was noted that the Chair had made the suggestion to have a general discussion, on how SACRE could look more broadly, or creatively to build better relationships with schools so that the monitoring of RE, was more effective and meaningful.

K Siddiqui advised that SACRE Members used to go into schools, observe the teacher, and advise schools on how best to teach about their faith. JDC explained that this was a time where LAs had full time RE Advisors, and part of their role was to train SACRE Members on how to undertake school visits; this was no longer the case and SACRE Members would no longer be welcomed into schools in that capacity. At the time, all schools were also maintained schools, and therefore there was greater jurisdiction from the LA regarding such visits. JDC stated that if this was a route that Havering SACRE wished to pursue, they would need to invest in training and visit other SACREs (such as in Bedford), which had more experience in this. It was acknowledged that not all SACRE Members would have the time to visit schools due to other commitments.

It was agreed that for many schools, without having an established, trusted relationship, having SACRE Members coming in to comment on their RE provision would not be welcomed, and might see the visit as an intrusion. It was suggested that another way to build relationships might be to invite school staff to a SACRE meeting to share their good practice as an opportunity to celebrate their school.

SACRE Members discussed the option to organise a 'youth interfaith' day or 'youth conference' where pupils and teachers from multiple schools would be invited to attend and learn about different Worldviews through various activities. It was suggested that all activities could be based on a common value, such as respect, or light (as examples).

Regarding venue, J Fox advised that the Salvation Army in Romford may be able to host the day, depending on availability.

JDC suggested inviting pupils from Year 5 and Year 8.

A working group would meet to discuss the details further, and bring an update to the next SACRE. JDC also offered to help if needed as she had organised a number of similar days.

ACTION: Dr J Lester / W Brice-Thompson / S Naeem and K Van Coevorden

Cllr McArdle advised that she would be happy to speak with Havering Changing, regarding potential funding for the project.

7. DETERMINATION PROCESS

It was noted that the working party had not had the opportunity to meet. It was agreed that JDC would contact SACRE Newham to see if they would be happy to share their process which, once tweaked to suit Havering, could be adopted.

8. YOUTH PROJECT

JDC reported that RE Subject Leaders had been enthusiastic about the display idea which had been drafted by Ruth Everett. SACRE Members in the summer term 2025 could look at the displays submitted. It was suggested that the Romford Recorder could be advised of the project to help raise the profile of RE and SACRE.

JDC would approach Newham to see if Havering SACRE could visit their Youth SACRE.

9. TRAINING FEEDBACK

No training had been undertaken since the previous meeting.

National RE Updates for SACRE Autumn 2024 For Havering SACRE

Calls for a National Plan for Religious Education

The Religious Education Council of England and Wales (REC) and the National Association for Teachers of RE (NATRE) have now called on the new Education Secretary, Bridget Phillipson MP, to introduce a National Plan for RE that provides a fair allocation of resources and prioritises the subject as part of Labour's plans to recruit more specialist teachers.

RE has recently seen a restoration of the teacher training bursary, but a shortage of specialism in schools remains a challenge given the long-term growth of the subject. The number of those recorded as teaching RE has remained roughly the same since 2011 at 16,200, while those delivering Geography and History lessons has risen by 1,700.

The Ethics Cup

Saint Andrew's University are offering secondary schools the opportunity to participate in The Ethics Cup. Unlike traditional debating tournaments, pupils are asked to prepare to simply discuss a particular case with the other competing teams on the day of competition. The cases are not presented in a resolution format, there is no requirement for the teams to disagree with each other, and the competition is not won by proving the other team wrong. Each team is instead asked to craft its own position with as much nuance as judged appropriate. It is a collaborative discussion with a panel of three judges awarding points for insight, thoughtfulness, and civility.

This allows the pupils to put forward their own genuine beliefs, formed through prolonged thought and investigation, rather than a constructed polemic prescribed by the competition.

RE Teaching in English Secondary Schools

The school workforce data is sourced from the annual school census which is submitted by schools in England to the DfE in November. Not every school completes the census each year however the data demonstrates who teaches RE in schools.

44% of teachers of RE have a post A Level qualification in the subject, compared to 80.3% for English, 76.6% for mathematics and 78.5% for History.

There has been an increase in the number of teaches of the other humanities subjects, history and geography between 2011 and 2023, however, the number of teachers of RE has remained static in the same period.

In response to a parliamentary question about how many RE lessons were taught by a teacher with another specialism, 51% of RE lessons were taught by teachers with another specialism, compared to 27% for history and 28% for geography.

A Level Religious Studies steady in England but a decrease in Wales

The overall trend in A level entries for Religious Studies over the last 5 years has been steeply downward in Wales but fairly stable in England.

Since 2020 entries in Wales have fallen by 37% from 1126 to 702. During the same period, entries in England, remained fairly stable with a fall of just under 0.5% from 14,564 to 14,499.

Even though the trend for entries in England is downwards, this is within a context where most Humanities subjects have experienced a fall in entries and most science, technology, engineering and maths subjects have seen an increase. It is worth noting that financial incentives for schools will have boosted these entries including the advanced maths premium scheme and a number of schemes established to boost science learning in schools.

Of the Humanities, Religious Studies in England was one of the smallest decreases between 2023 and 2024 at 1.3%.

Religious Studies remains a popular GCSE despite specialist teacher recruitment challenge

The number of students taking full course Religious Studies in England and Wales at GCSE has remained stable at 233,288 following a 0.5% rise in entries from 2023 making it one of the most widely studied humanities at GCSE.

223,034 students took RS GCSE (full course) in England, an increase of 0.3%. In Wales 10,254 students took the subject, an increase of 6.4%. For the third year running, the number of students taking a GCSE short course rose in England, this year by 9.5% to 20,627. In Wales however, entries fell by 27.1% to 2,201.

This is despite an ongoing challenge in recruiting specialist teachers amidst a gulf in government funding.

OCR Review – Striking the Balance: A Review of 11 – 16 curriculum and assessment in England

Oxford, Cambridge and RSA have published a report into the content of the curriculum at Key Stages 3 and 4 and the role and form of assessment including SATs and GCSE qualifications. The review was chaired by Charles Clarke and draws focus to four key areas

- Reducing the assessment burden
- Digital assessment and learning
- English and maths at 11–16
- Curriculum evolution at 11–16

The research was undertaken with over 2000 teachers and students at a variety of events as well as working with education specialists to draw the conclusions for each of the four areas.

Commentary in the section of the report on curriculum evolution points to an over-crowded curriculum in which some subjects have been overlooked due to a focus on EBacc subjects, there is reference not only to the creative subjects but also physical education and the following comment is made in relation to religious education

'Another important aspect of the evolution of the curriculum is the teaching of religion and belief in schools. This remains a statutory requirement often honoured, outside faith schools, in the breach rather than the observance.' – page 74

It is made clear in the report that although it is not necessary for all pupils in a school to follow the subjects contained within the EBacc there is a strong move within schools for pupils to study these as EBacc uptake is an accountability measure of school performance. The review calls for an independent curriculum authority to oversee the changes to the sector and to ease the examination burdens placed on students in Year 11 through a wholesale review of the processes and purposes of assessment in the education sector.

Overview of the work of SACRE

Since 1988, each Local Authority (LA) has been required by law to have a Standing Advisory Council for Religious Education (SACRE).

The remit of a SACRE is principally to oversee the Religious Education (RE) and collective worship within the authority principally to:

- advise Havering Council upon matters connected with religious worship in community schools and in foundation schools which do not have a religious character. Religious education in these schools is to be given in accordance with the Agreed Syllabus;
- advise Havering Council on teaching methods, choice of materials and teacher training in religious education and collective worship;
- require Havering Council to review the locally agreed syllabus for religious education at least every five years.

The reporting period of the 2023-2024 report starts from September 1st 2023 and runs to August 31st 2024.

SACRE met on three occasions during the academic year 2023-2024, Thursday 9th November 2023 (hybrid meeting – virtual attendance or Romford Baptist Church), Tuesday 19th March 2024 (virtual meeting) and Tuesday 2nd July 2024 (face to face meeting at Nelmes United Reformed Church). All meetings were quorate with the exception of 2nd July and minutes for these meetings are available on the Havering Council website

The Locally Agreed Syllabus and RE in schools

RE is not part of the national curriculum. Each LA is required to produce an Agreed Syllabus for RE. Each LA is required to begin reviewing the current Agreed Syllabus within five years of its production. Havering's new Agreed Syllabus was launched in October 2022. From September 2023, all schools for whom delivering the Agreed Syllabus is statutory requirement should have fully implemented the new one.

The Agreed Syllabus, and accompanying resources, including expanded plans for all units for Key Stage 1 and Key Stage 2, can be accessed by Havering schools via the Havering Education Services portal.

Standards and monitoring of RE

Teacher training materials and advice for schools

This year saw six virtual twilight CPD sessions for RE in primary schools. Three of these were designed for Subject Leaders and three for all staff delivering RE, although Subject Leaders were the biggest audience at all six sessions. HES also provided a face-to-face Subject Knowledge Enhancement day for primary leaders of RE which took place at CEME and focused on the aims of RE in Havering, RE and Ofsted, diversity within worldview traditions and leading RE effectively.

All meetings give attendees the opportunity to network and receive updates. Main themes for each meeting are chosen in collaboration with attendees at the previous sessions.

Main themes for Subject Leader meetings:

Autumn term – Aims of RE within the Havering Agreed Syllabus

Spring term – Personal knowledge in RE

Summer term – Ofsted's Religious Education subject report

Main themes for RE CPD meetings:

Autumn term – RE 'surgery', facilitating discussion in your RE classroom

Spring term – cREative RE – thinking skills in the RE classroom.

Summer term – cREative RE – using art, photographs and statistics to bring RE to life.

During this academic year, the associate RE Adviser has provided support by phone and email and was able to visit schools on request.

Other information

There were no formal complaints to SACRE about RE during the year.

Advice given to the Local Authority

Whilst formal advice was not given to the Local Authority, SACRE continues to work closely with the Local Authority to ensure that all pupils receive high quality Religious Education.

Section 3: Collective worship

Standards and monitoring of Collective Worship

HSIS is asking governing bodies to ensure their schools are fulfilling statutory duties regarding Collective Worship. In order to enable governors to do this in an informed manner, a training session on Collective Worship for governors and schools (to which SACRE members were invited) took place on 31st January.

Determinations

No determinations have been requested in the year 2023-2024. SACRE is working to ensure that a procedure for determinations in Havering schools is drafted and can be sent to the LA for improvement or adoption.

Teacher training provided

Training was provided free of charge to all schools in January 2024. Two schools have requested and received time for their Collective Worship leaders to work with the Associate RE Adviser in order to ensure that they have systems in place to provide meaningful Collective Worship for all pupils on a daily basis.

Other information

There were no formal complaints to SACRE about collective worship during the year.

Advice to the Local Authority

SACRE advises the Local Authority to ensure that a determination process is in place and that SACRE is willing to design a form for schools to complete if seeking a determination.

Section 4: Links with other bodies

National Bodies

Havering SACRE are pleased to be linked with national bodies and receive national updates from Julia Diamond-Conway our RE adviser.

Havering SACRE has links with NASACRE. It regularly utilises NASACRE's self-evaluation toolkit.

Information from NATRE, Ofsted and the REC has been used in meetings and shared with schools where appropriate.

Local bodies

Chelmsford Diocese provide excellent support to SACRE and we are pleased to have its RE Lead Schools Adviser as a member of committee B.

Local places of worship are well represented on SACRE and regularly used as venues for SACRE meetings. Two places of worship have volunteered to host next year; one for a SACRE meeting, the other for a Youth Interfaith Conference.

It has been suggested that Havering SACRE contact the Romford Recorder to report on a project which it hopes to run next year, encouraging schools to raise the profile of RE through wall displays.

A member of Committee D is investigating whether Havering Changing can be involved in the Youth Conference.

Section 5: SACRE involvement in the Local Area

Governor and head teacher links

Governors are being asked to be more fully involved with the monitoring of Collective Worship. To ensure that they have a good understanding of this, a training session was delivered on Collective Worship which was attended by Governors and Head Teachers.

Advice on community issues

The RE adviser regularly gives advice on speakers coming into schools and visits to places of worship locally.

Section 6: Managing the SACRE and partnership with the Local Authority (LA)

Professional and administrative support

During the reporting period, clerking of SACRE was undertaken by Michelle Morgan of Havering Governor Services.

The Local Authority provided funding to support SACRE activity 2023 -2024 by contracting with RE Today Services of an RE Consultant for up to 6 days during the year. These days include attending SACRE meetings, writing statutory annual report, providing national updates and information and first response consultancy.

Julia Diamond-Conway from RE Today continued in the role of RE consultant.

Susan Sutton, Education Quality and Effectiveness manager holds responsibility for SACRE support and liaises with the RE consultant.
