Protocol for members of the public wishing to report on meetings of the London Borough of Havering

Members of the public are entitled to report on meetings of Council, Committees and Cabinet, except in circumstances where the public have been excluded as permitted by law.

Reporting means:-

- filming, photographing or making an audio recording of the proceedings of the meeting;
- using any other means for enabling persons not present to see or hear proceedings at a meeting as it takes place or later; or
- reporting or providing commentary on proceedings at a meeting, orally or in writing, so
 that the report or commentary is available as the meeting takes place or later if the
 person is not present.

Anyone present at a meeting as it takes place is not permitted to carry out an oral commentary or report. This is to prevent the business of the meeting being disrupted.

Anyone attending a meeting is asked to advise Democratic Services staff on 01708 433076 that they wish to report on the meeting and how they wish to do so. This is to enable employees to guide anyone choosing to report on proceedings to an appropriate place from which to be able to report effectively.

Members of the public are asked to remain seated throughout the meeting as standing up and walking around could distract from the business in hand.

Members are advised that, when considering an application to vary a premises licence, the following options are available to them by virtue of the Licensing Act 2003, Part 3, section 35, paragraphs 3 and 4:

"Where relevant representations are made, the authority must

- (a) hold a hearing to consider them, unless the authority, the applicant and each person who has made such representations agree that a hearing is unnecessary, and
- (b) having regard to the representations, take such steps as it considers necessary for the promotion of the licensing objectives.

The steps are:

- a) modify the conditions of the licence
- b) reject the whole or part of the application

and for this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added."

The Sub-Committee will also wish to note that, if none of these steps is required, the application must be granted.

Assuming that the Sub-Committee is satisfied that a hearing is required, then the following procedural steps are recommended. The Licensing Act 2003 (Hearings) Regulations 2005 will govern the arrangements for the hearing of the application now under consideration. This report accords with the requirements of that Act and the Regulations, and in particular Regulations 21-25 (procedure at the hearing).

1. Membership of the Sub-Committee:

- 1.1 The Sub-Committee comprises three members of the Licensing Committee, with a quorum of two members. Unless there are objections, in the absence of three members, the hearing shall proceed with the quorum of two.
- 1.2 A members of the Licensing Committee will be excluded from hearing an application where he or she:
 - 1.2.1 has considered an application in respect of the premises in the previous 12 months as a Member of the Regulatory Services Committee; or
 - 1.2.2 is a Ward Councillor for the Ward in which the premises, subject to the application, are located; or
 - 1.2.3 is a Ward Councillor for a Ward which is likely to be affected by the application or;
 - 1.2.4 has a personal interest in the application.

2. Roles of other participants:

- 2.1 The Legal Advisor is not a party to the hearing. The role of the Legal Advisor is to provide legal advice relating to the application and submissions.
- 2.2 The Clerk is not a party to the hearing. The role of the Clerk is to record the hearing and the decisions of the Sub-Committee, and ensure efficient administration

3. Location and facilities:

- 3.1 All hearings will be heard at the Havering Town Hall unless otherwise directed.
- 3.2 Interpreters will be provided by the Council on request, provided notice is given at least five working days before the hearing.

4. Notification of attendance:

4.1 The Chairman will enquire of the parties who is in attendance and the parties will indicate their names (and, where relevant, whom they represent). A register will be circulated before the commencement of the hearing on which the applicant, his/her advisers and companions and all interested parties (and/or their representatives) will be asked to record their attendance.

5. Procedural matters:

- 5.1 Prior to the commencement of the hearing, the Chairman of the Sub-Committee will orally inform the parties whether their applications to have certain people attend the hearing (e.g. witnesses) have been granted or refused. Note this relates to people other than those attending on behalf of a party in the capacity as a representative of the party.
- 5.2 Prior to the commencement of the hearing the Chairman of the Sub-Committee will outline the procedure to be followed at the hearing. This will normally be as follows:

Introduction of the application:

The Licensing officer will outline:

- details of the application and relevant representations received from the parties;
- relevant legislation;
- relevant Licensing Policy; and
- the time limit in which the Council must reach a determination.

Documentary evidence:

- Documentary or other information in support of applications, representations or notices should be provided to the Clerk of the Sub-Committee at least 5 clear working days before the hearing. If this information is produced at the hearing it will only be taken into account by the Sub-Committee if the Sub-Committee and all the parties consent to its submission. Permission to have this information included in the hearing should be requested at the beginning of the hearing before any oral submissions have been made.
- Statements made by people in support of a party's representation who are not present at the hearing, must be signed by the maker, dated and witnessed by another person. The statement must also contain the witness's full name and occupation.

Representations:

- The chairman will invite each of the parties at the hearing or their representative sequentially to address the Sub-Committee and call any person/s to whom permission has been granted to appear. Each party will be allowed a maximum period of 10 minutes in which to address the Sub-Committee and call persons on his/her behalf.
- This 10 minute period is where each party has the opportunity to orally address the Sub-Committee and clarify any points in which the Sub-Committee has sought clarification prior to the hearing. This 10 minute period should be uninterrupted unless a member of the Sub-Committee or Legal Advisor considers that the speaker is making submissions that are irrelevant, frivolous or vexatious.
- Members of the Sub-Committee may ask questions of any party, at any time during the proceedings. Time taken in dealing with a Member's question will not be taken into account in determining the length of time available to the party in question to make their representation.

The sequence in which each of the parties will be invited to address the Sub-Committee will normally be in the order of:

- the Chief Officer of Police;
- the Fire Authority;
- the Health and Safety at Work Enforcing Authority;
- the Local Planning Authority;
- the Local environmental Health Authority;
- the Local Weights and Measures Authority;
- the Authority Responsible for the Protection of Children from Harm;
- a navigation or other authority responsible for waterways; and
- any other party that has submitted representations in respect of the application, certificate, notice or other matter appearing before the Sub-Committee;
- the party that has submitted the application, certificate, notice or other matter appearing before the Sub-Committee.

At the discretion of the Sub-Committee the above order may be varied.

Cross-Examination:

Where witnesses have been permitted by the Sub-Committee to speak at the hearing on behalf of a party, permission must be sought from the Sub-Committee before another party can ask the witness questions. This process of questioning is normally referred to as cross-examination. The Sub-Committee will allow cross-examination only

where it is necessary to assist it in considering the representations or application.

Relevance:

Information submitted at the hearing must be relevant to the applications, representations, or notice and the promotion of the licensing objectives. The Chairman of the Sub-Committee is entitled to exclude any information it considers to be irrelevant whether presented in written or oral form. The licensing objectives are:

The prevention of crime and disorder;
Public safety;
The prevention of public nuisance; and
The protection of children from harm.

6. Failure of parties to attend the hearing:

6.1 If a party, who has not given prior notice of his/her intention not to attend the hearing, is absent from the hearing the Sub-Committee may either adjourn the hearing or hold the hearing in the party's absence. Where the hearing is held in the absence of a party, the Sub-Committee will still consider the application, representation or notice submitted by that party.

7. Adjournments and extension of time:

- 7.1 The Sub-Committee may adjourn a hearing to a specified date or extend a notice period except where it must make a determination within certain time limits in the following specific applications:
 - Review of premises licences following closure orders where the Sub-committee must make a determination within 28 days of receiving notice of the closure order.

8. Sub-Committee's determination of the hearing:

- 8.1 At the conclusion of the hearing the Sub-Committee will deliberate in private accompanied by the Clerk and the Legal Advisor who will be available to assist the Sub-Committee with any legal problems but will not participate in any decision making of the Sub-Committee.
- 8.2 The Sub-Committee will normally make its determination and announce its decision at the end of the hearing.

8.3 Where all parties have notified the Sub-Committee that a hearing is not required the Sub-Committee must make its determination within 10 working days of being given notice that the hearing is not required.

9. Power to exclude people from hearing:

- 9.1 The public are entitled to attend the hearing as spectators. However, the Sub-Committee may exclude any person from the hearing including any person assisting or representing a party where:
 - it considers that the public interest would be best served by excluding the public or the individual person from the hearing; or
 - that person is behaving in a disruptive manner. This may include a
 party who is seeking to be heard at the hearing. In the case where a
 party is to be excluded, the party may submit to the Sub-Committee
 in writing any information which they would have been entitled to
 give orally had they not been required to leave the hearing.

10. Recording of proceedings:

10.1 A written record of the hearing will be produced and kept for 6 years from the date of the determination of the hearing.

11. Power to vary procedure:

11.1 The Sub-committee may depart from following any of the procedures set out in this document if it considers the departure to be necessary in order to consider an application, notice or representation.

This application to vary a premises licence is made by Star Pubs Trading Limited under section 34 of the Licensing Act 2003. The application was received by Havering's Licensing Authority on 25th September 2025.

Geographical description of the area and description of the building

The Drill Hotel is located at the intersection of Brentwood Road and Slewins Lane. The premises has parking space available for approximately twenty cars. A beer garden is located to the rear of the property. There are commercial and residential properties in the immediate area.

The application is to permit the following amendments to the licence:

- To extend all licensable activities permitted internally to 00:00 Monday to Thursday and 01:00 Friday and Saturday. (NB These hours do not include the shed bar which will continue to operate under the existing permitted hours, i.e. Monday to Thursday 10:00 to 23:00, Friday and Saturday 10:00 to 00:00 and Sunday 12:00 to 22:30.)
- To permit the licensable activities authorised by this licence to continue on New Year's Eve until the end of permitted hours on New Year's Day, i.e. thirty-nine hours from 10:00 on 31st December until 01:00 2nd January.
- To increase the terminal hours the premises closes to the public following the above changes to Monday to Thursday 08:00 to 00:20 and Friday and Saturday 08:00 to 01:20.
- To add the following condition to the licence:

Notices will be displayed at all exits reminding customers to leave the area quietly and respecting the needs of local residents.

Summary

- 4. Customers are to be shown off the premises and encouraged to disperse in an orderly manner.
- 5. Alcohol is permitted to be supplied from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day.

Prominent clear notices shall be displayed at the premises about the supply of alcohol to minors and the relevant offences involved.
- 9. A person aged less than 18 years of age must only be permitted on the premises when accompanied by a responsible adult (a person over 18).



Summary of Objection: Objection to an application for a variation to a premises licence as if granted likely to undermine the licensing objectives of the prevention of crime and disorder and public nuisance.

Policy Considerations:

12. Licensing Hours

- 12.1 When dealing with new and variation applications the Licensing Authority may give more favourable consideration to applications with the following closing times: Public Houses and Bars 23:00 hours Sunday to Thursday Midnight Friday and Saturday Nightclubs 01:00 hours Sunday to Thursday 02:00 hours Friday and Saturday Restaurants and Cafes 23:00 hours Sunday to Thursday Midnight- Friday and Saturday Off licences 23:00 Monday to Sundays Hot food and drink supplied by takeaways, fast food premises Midnight- Sunday to Thursdays 01:00 Friday and Saturday Hotel residents only 24 hours sale of alcohol for on sales only
- 12.2 Consideration will also be given to the type of area that the premises is located in with regulated activities normally being permitted until 23.30 in residential areas and 00.30 in mixed use areas.
- 12.3 The above hours are a guide and each application will be considered on it's own merits.
- 12.4 The above hours are intended to guide applicants on the Licensing Authority's expectations when preparing their operating schedules.
- 12.5 For applications within the above hours there is no presumption that the application will automatically be granted in all cases where a relevant representation has been made. If no representations are received, the application will be granted by the licensing authority

under delegated powers.

- 12.6 Applicants who wish to provide licensable activities outside the hours specified above should ensure where relevant the operating schedule specifies detailed measures to militate against crime, disorder and public nuisance etc. taking into account:
- The location of the premises and the character of the area in which they are situated
- The proposed hours during which licensable activities will take place
- The adequacy of the applicant's proposals to prevent crime and disorder and prevent public nuisance
- Whether customers have access to public transport when arriving at or leaving the premises
- The proximity of the premises to other licensed premises in the vicinity and the hours of operation of those other premises policies and proposals for the orderly dispersal of customers.

17. Noise

- 17.1 The Licensing Authority is committed to protecting the amenity of residents and businesses in the vicinity of licenced premises, particularly when late hours have been sought. Where relevant representations are received, the Licensing Authority will request appropriate restrictions or controls on the licence to support the prevention of undue noise disturbance from licensed premises.
- 17.2 The Licensing Authority will seek to balance the protection of residents from undue disturbance against noise and the activity that is the natural by-product of people going about their business, entertainment or leisure.
- 17.3 The Licensing Authority expects that premises intended for the provision of noise-generating licensable activities are acoustically controlled and engineered to a degree where the noise from the premises when compared to the ambient noise level will not cause undue disturbance. The Licensing Authority recognises specific difficulties associated with premises structurally linked to would be licensed premises and the limit of sound insulation performance that can be achieved. In some circumstances licensed premises adjoining residential properties may not be appropriate.

Representation

This representation against the application is primarily based on the fact that the premises is situated within a residential area and the public nuisance licensing objective is likely to be undermined.

The Authority recognises that the premises is on a busy roundabout and close to a mixeduse commercial area, however, there have been issues in the past with patrons congregating in the area upon egress causing noise nuisance to neighbours.

The authority also recognise that the current tenants are good operators and have a good working relationship with the council. Unfortunately, the location does lend itself to being a premise with a presence in the late night economy. The commercial value of trading later has to be balanced with the needs of local residents reflected in the local licensing policy.

The hours requested sit outside the recommended policy hours for licensed premises in a residential area. The current licence already authorises licensable activities until 00:00 on Friday and Saturday nights.

Any further extension of hours is likely to increase noise nuisance, specifically from regulated entertainment and live music. Whilst residents in the vicinity may have become accustomed to the current noise levels, any extension could cause additional disturbance. The background noise levels from traffic would be lower at 01:00hrs and as a result the noise from those levels would be heard more acutely.

Dispersal from the premises would also be later. It is conceivable that a customer could get their last order at 01:00hrs, exit the premises at 01:20 and congregate externally, awaiting a taxi or speaking to friends before departing. Whilst the request for later hours for licensable activity is until 01:00, there is a risk that disturbance and nuisance could continue far beyond those hours.

Considering the risk of undermining the crime and disorder licensing objective, with increased hours of the sale of alcohol comes higher levels of intoxication. This can impact on an individual's decision making abilities and become a risk factor in issues of anti-social behaviour and violence.

It can cause customers to be louder and more boisterous, again having the potential for disturbance to residents. Previous incidents at the premises have been at dispersal where fights have occurred in the street.

Conclusion
The Licensing Authority respectfully requests that the licensing sub-committee refuse the extension of licensable activities at the premises as it is against the recommendations with the Authority's policy hours and is likely to undermine the licensing objectives.

Dear Sirs

I refer to the recent application for a variation to the premises licence at The Drill, to extend the hours of the premises licence until 00.00 hours Monday-Thursday and 01.00 hours Friday and Saturday. I am assuming that the terminal hour on a Sunday will remain until 22.30 hours. I am commenting on the application regarding the Prevention of Public Nuisance.

Whilst I appreciate that the use of the shed bar will continue to be used under the hours permitted by the current licence (until 23.00 hours Monday-Thursday and 00.00 Friday and Saturday, 22.30 Sunday) I have concerns regarding the proposals, particularly around the use of the beer garden (irrespective of the time of closing of the shed bar) and the noise from customers as they leave the premises in the early hours of the morning.

I note that the current conditions indicate that a Public Nuisance Policy is to be agreed between the premises licence holder/DPS and the Environmental Health team at the Council. I cannot find any records that this has agreed by the Council, and would be grateful if a copy of this agreement can be provided. I would also be grateful if you could provide details of the noise limiter installed and used at the premises.

I note that music and speakers are not to be provided to the external areas of the venue (as required by the current licence) which does address some of my concerns, however it does not address the concerns that I have regarding customer noise in the outside areas (particularly in the summer months) until the early hours will cause a public nuisance to those neighbouring residents. This from the front of the pub (facing Tesco and the flats above the shops opposite the venue on Brentwood Road), as well as those properties on Slewins Lane, which overlook the beer garden. No measures to address these concerns have been put forward, to ensure that customer noise does not cause a public nuisance.

Similarly, as customers leave and congregate as they leave, in what is a predominantly residential area in the early hours of the morning, residents will be affected by this noise.

My final concern is that the proposed hours are in excess of the Council's licencing policy, of 23.00 hours Sunday-Thursday, and 00.00 hours Friday and Saturday. No specific measures have been made to address these concerns.

I do appreciate that the Environmental Health team have not received any complaints in the last year regarding the premises, and this could indicate that the pub is well run, and is complying with the licencing objectives, however the extension of hours will inadvertently increase the noise in the area in the early hours, primarily from customer noise. Whilst I do appreciate that the current conditions of the licence will remain, the control of customer noise has not been adequately addressed, and the application is at odds with the Council's licencing policy. As such I am unable to support the requested application.

I would welcome any comments you may wish to make, and additional measures to be added to the operating schedule to address these concerns. In order for me to address any comments you may wish to make before the consultation period ends, I would welcome your comments by 17 October 2025.

Police acknowledge receipt of a Premises Licence Variation Application for the Drill Brentwood Road Romford RM25TD which we received by email on the 25th September 2025.

The application states the venue wish to extend the hours for regulated entertainment & the supply of alcohol to:- Monday, Tuesday, Wednesday, Thursday till 0000 hours & Friday & Saturday till 0100 hours

The applicants states the **opening hours** will be:- **Monday**, **Tuesday**, **Wednesday**, **Thursday** 0800 - 0020 hours & Friday & Saturday 0800 - 0120 hours

On behalf of the Commissioner of Police of the Metropolis, consideration has been given to this application and Police object to the application under the following licensing objectives:-

The prevention of public nuisance & the prevention of crime and disorder

The Drill Public House is located within a predominantly residential area, surrounded by private dwellings & small local businesses. The premises currently benefits from a licence permitting the supply of alcohol & regulated entertainment until 2300 hours Monday to Thursday, midnight Friday & Saturday & 2230 hours on Sunday. These hours are consistent with other similar premises located in residential areas & reflect the area's quiet, residential character.

Whilst the premises is generally well managed, Police have concerns that an extension of trading hours to 0120 hours is likely to have an adverse impact on the local community and undermine the above licensing objectives.

Extending the supply of alcohol until 0100 hours will extend the consumption period and may lead to increased levels of intoxication potentially resulting in disturbances & crime & disorder. This will in turn cause the safety of the public to be at risk because of violent crime & the injuries associated with such offences. Intoxication, particularly from alcohol, is frequently associated with violent crime.

Previous experience in Policing has established drunkenness can reduce inhibitions, impair judgment, and increase aggression, making individuals becoming more violent likely.

At around 0015 hours on Christmas Day in 2022 patrons from the venue were involved in a large scale physical altercation in the street (report 5422534/22 refers & attached as appendix I). Whilst Police acknowledge this isn't a regular occurrence it does none the less demonstrate that violent offences involving intoxicated patrons have occurred at such hours.

The area surrounding The Drill is not a late night economy zone and lacks the infrastructure such as permanent door staff presence, external CCTV coverage & taxi ranks to safely support premises operating until 0120 hours.

The proposed extension will likely result in increased disturbance to local residents, including noise from customers leaving late at night with some possibly loitering in the area, patrons waiting for taxis, car doors slamming & raised voices. An increase in toxication can result in patrons becoming louder, some using foul language which may cause a nuisance to nearby residents.

Later hours can increase the likelihood of incidents involving intoxicated persons especially when patrons disperse into quiet residential streets. The Police are concerned that operating until 0120 hours could place additional demands on emergency services during a period of reduced staffing and coverage.

If the sub-committee were minded to grant the application Police would seek additional conditions around a requirement for permanent SIA-licensed door supervisors to be employed & the use of an ID scan machine to prevent crime & disorder from occurring.

In conclusion The Drill Public House is situated in a residential location that is not designed to support late-night premises. The proposed extension of regulated entertainment & the supply of alcohol until 0100 hours would likely lead to increased noise, nuisance, and disorder, and is therefore not considered appropriate for the setting.

Police believe that maintaining current hours strikes a fair balance between the interests of the business and the rights of residents to quiet enjoyment of their homes.

Accordingly, the Police cannot support the application & respectfully request that the Licensing Sub-Committee refuse the application.
