| Consideration of consultation and representation period | <p>An initial consultation was carried out from 19/06/2017 -21/07/2017. The responses received during this initial consultation period were considered before a decision was made to publish a statutory notice regarding the proposal for this school. The statutory notice was published 22/09/2017 and launched the four week representation period which ended on 20/10/2017.</p> <p>3 comments / objections were received during the representation period. Responses to these have been addressed in the formal consultation report.</p> <p>All stakeholders have had a fair opportunity to express their views. The process of consultation has been conducted satisfactorily and all the statutory requirements have been adhered to.</p> |
| Education standards and diversity of provision | <p>Mead Primary is a good and popular school. The recent Ofsted noted that the early years provision at the school is good, acknowledging that while many children start school with skills and knowledge below what is typical for their age; they make good progress. An expansion of the nursery provision at this school would create an opportunity for more children to benefit from the consistent good quality of teaching already existing in the early years provision at this school.</p> <p>It also noted that the proportion of children reaching a good level of development has increased every year and children are well prepared and confident to start in Year 1 and the most able pupils make good progress throughout the years and across the range of subjects. Disadvantaged pupils and those who have special educational needs or disabilities make good progress from their starting points and are well supported.</p> <p>The increase in places at the school including the changes being made to the additional resource provision (ARP) reserved for pupils with autistic spectrum disorder</p> |

| | <p>and/or communication and complex needs will allow more local families to access the diversity in provision and already good standard of education being delivered.</p> <p>The expansion will also provide an opportunity for the school to recruit a broader level of expertise and specialisms within its staff, which will in turn enhance the teaching & learning, enabling children to continue to make excellent progress.</p> |
| Demand | <p>The objective of the proposal is to provide much needed additional school places in the Harold Hill planning area by enlarging the premises of Mead Primary School in response to an increasing demand for school places.</p> <p>The birth rate in the Harold Hill area has increased by 39% between years 2010/11 and 2015/16. It is one of the planning areas that is experiencing rapid growth in pupil numbers and long term pressure of demand on school places due to in year mobility and new housing growth. The area is currently showing a deficit of funded 2, 3 & 4 year old early years places with the projected increase of 0-4 year olds over the next five years.</p> <p>In addition, the growth in children with complex Communication and Interaction and SEMH needs in Havering over the next five years is projected to increase by 20%. Therefore the re-designation of the current ARP and increase in places will help meet the demand for places from pupils with Autistic Spectrum Disorder and/or Communication & Complex Needs.</p> <p>The decision to permanently expand the school will provide an additional 30 places each year, starting in reception. This will help ensure that there are sufficient places to address demand and reduce the pressure experienced by other schools in this planning area.</p> |
| School size | <p>The nursery expansion will provide an additional 22FTE places for 3 and 4 year olds</p> |

| Travel and accessibility | <p>This proposal will not extend journey times, increase transport costs, or result in too many children being prevented from travelling sustainably due to unsuitable walking or cycling routes as the expansion will be carried out on the school's existing site.</p> <p>In addition, the expansion is being proposed as there is a projected increase in demand for additional school places from within the local area where the schools are located- the expansion will enable the school to meet the demand for school places from the local community. All school users will be encouraged to access the schools via sustainable modes of transport.</p> <p>The ARP will be a self-contained unit which will be sufficiently spacious; to provide for the needs of up to 12 pupils with supported spaces made available for some timetabled activities and any other requirements.</p> <p>The expansion will be undertaken with full accessibility compliance.</p> |
| Funding | <p>The local authority has allocated a budget of £3.625million for this expansion project agreed as part of the London Borough of Havering 2017/18 capital programme. This includes the costs for the 1FE expansion, the newly redesignated ARP and nursery expansion.</p> |
