## Part A - Report seeking decision

## DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

That having considered the information contained in this report, the Assistant Director for Environment authorises the removal of existing speed tables in Hornchurch Road between Grosvenor Drive and Elmhurst Drive, Hornchurch following complaints from the local residents. The proposals are shown on drawing attached in appendix 2 of this report.

## **AUTHORITY UNDER WHICH DECISION IS MADE**

To authorise the creation, amendment and removal of disabled persons' parking bays and footway parking bays and at any time waiting restrictions at bends and road junctions

## STATEMENT OF THE REASONS FOR THE DECISION

This report deals with the removal of existing speed tables in Hornchurch Road and it provides the background information on it's original installation and the post implementation problems that the residents have subsequently been experiencing.

- 1.0 Background
- 1.1 In October 2016, the Highways Advisory Committee considered a report (Agenda item 5) on proposed safety improvements in Hornchurch Road as part Hornchurch Road Accident Reduction scheme.
- 1.2 The proposals had identified accident remedial measures such as installing speed tables at various locations and provision of speed tables at existing and new zebra crossings primarily aimed at reducing the traffic speeds and accidents at prime locations along the Hornchurch Road, between Albany Road and Lyndhurst Road. The scheme was implemented in early 2017 and it was funded by Transport for London through the Local Implementation Plan allocation for 2016/17 Accident Reduction Programme.

- 1.3 As the highway works were completed, occupiers in the immediate vicinity where the speed tables were installed in Hornchurch Road between Elmhurst Drive and Grosvenor Drive had complained that they were experiencing ground borne vibrations as vehicles travel over these profiles. They have complained that the speed tables have detrimental effect on their health such loss of sleep, increase in pollution etc.
- 1.4 Officers had visited the site to identify if there any other sources which could possibly generate vibrations such as loose manhole covers, sunken utility trench or pot holes. There were none identified on site, therefore, it was confirmed that the raised tables are the main source for generating vibrations when traffic travels over them.

### 2.0 Outcome of the public consultation

165 letters were posted to the local occupiers in Hornchurch Road (part), Harrow Drive, Elmhurst Drive and Grosvenor Drive. Furthermore, the proposals were advertised in the local press, in accordance with the Provisions of the Highways (Road Humps) Regulations 1999 to remove the speed tables.

In addition, to the above the local Ward members were also notified.

Only 12 responses were received of which 8 respondents are in agreement for the removal of the speed tables whereas 4 respondents have objected to the removal i.e. the speed tables to remain. The responses have been analysed carefully and the results are included in appendix 1 of this report.

### 3.0 Recommendations

That the existing speed tables are removed as advertised and consulted. The proposals are shown in the drawing attached in appendix 2 of this report.

### Staff comments and conclusions

On receipt of the complaints from the occupiers of Hornchurch Road, between Elmhurst Drive and Grosvenor Drive, staff had visited the site to establish the origin of the problem. Consideration was also given to identify if the other associated sources such as loose manhole covers, sunken utility trench potholes etc were generating the ground borne vibrations, however, there were none identified.

The speed tables were installed with a view to reduce traffic speeds and road accidents, however, time will confirm if the removal of the measures has been justified. The speed tables particularly close to the junctions with Elmhurst Drive and Grosvenor Drive have assisted traffic exiting from these side roads.

The removal of the speed tables will improve the quality of lives of those residents who had been subject to detrimental effects arising from the speed tables over a considerable period of time.

The locations of the existing speed tables are shown on drawing attached in appendix 1 of this report.

### OTHER OPTIONS CONSIDERED AND REJECTED

Consideration was given to lower the existing speed tables but the measures were rejected as alteration is not financial justified.

### PRE-DECISION CONSULTATION

A Public Notice under the Highways Act 1980 and in accordance with the provisions of the Highways (Road Humps) Regulations 1999 was advertised in the local press for the removal of the existing speed tables.

### Part B - Assessment of implications and risks

### **LEGAL IMPLICATIONS AND RISKS**

Many aspects of highway schemes require consultation and the advertisement of proposals before a decision can be taken on their introduction.

Where a scheme is selected to proceed, then such advertisement would take place and then be reported in detail to the Committee so that a recommendation may be made to the Cabinet Member for Environment.

With all requests considered through the Schedule, a formal set of Recommendations and a record of the Committee decisions are required so that they stand up to scrutiny.

### FINANCIAL IMPLICATIONS AND RISKS

This report is asking the Assistant Director for Environment the removal of existing speed tables in Hornchurch Road between Elmhurst Drive and Grosvenor Drive.

The estimated cost for removal of the speed tables is £0.0115m. The funding for carrying out the works will be met from the Capital Budget allocated for the Highways Improvement Programme (A3000).

The costs shown are an estimate of the full costs of the scheme, should all proposals be implemented. It should be noted that subject to the agreement of the Assistant Director for Environment – as regards to actual implementation and scheme detail. Therefore, final costs are subject to change.

This is a standard project for Street Management and there is no expectation that the works cannot be contained within the cost estimate. There is an element of contingency built into the financial estimate. In the unlikely event of an overspend, the balance would need to be contained within the overall Environmental Capital



NOTICE IS HEREBY GIVEN that under the Highways Act 1980 and in accordance with the provisions of the Highways (Road Humps) Regulations 1999 the Council of the London Borough of Havering ("the Council") proposes to remove the existing speed tables at the following locations:

i) Hornchurch Road, outside property No. 96.

**Note**: the existing zebra crossing will be retained.

ii) Hornchurch Road junction with Grosvenor Drive.
