Part A - Report seeking decision

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

The Council is seeking to appoint a festive lighting supplier who will provide festive motifs, installation and removal of designated lamp columns in specified locations within the borough for Christmas 2020.

We are looking to award a four month contract which would cover the festive period and end in January following the removal of the lights. The contract will start at the beginning of October and installation will commence mid-November. The reason the contract will begin prior to installation is due to the fact I need to liaise with the Supplier to create a work plan and schedule prior to installation.

With the advice from Procurement, we undertook a Request For Quotation process to award a four month contract,

The supplier which scored the highest in the process was Blachere Illuminations. Their total contract value is £61,287.

Breakdown of scoring:

The technical score - 81 The price score - 100

Total score - 94.3

STATEMENT OF THE REASONS FOR THE DECISION

The supplier Blachere Illuminations received the highest score. Their submission was robust and well documented, and each question was answered with a comprehensive and qualified response submitted in terms of detail and relevance to all the technical questions we asked. The company also provided great examples of contracts in other local authorities, with the costs and duration of the contracts and what was included in all the contracts (storage, removal etc.).

They have also received very good feedback from a variety of stakeholders they have worked with.

OTHER OPTIONS CONSIDERED AND REJECTED

The alternative option is to have no festive lights and in the borough. This option has been rejected due to the fact that the Festive Lights compliment the borough's Town Centres for the duration of the Christmas period.

LEGAL IMPLICATIONS AND RISKS

- The Council has a "general power of competence" under Part 1 Chapter 1 of the Localism Act 2011 which gives it the same power to act as that of an individual, subject to other statutory provisions limiting or restricting its use and the recommendations in this report are compatible with the exercise of those statutory powers.
- 2. This report seeks approval of the outcome of the request for quotes process that was undertaken so as to procure Christmas Lightings throughout the borough for the Christmas period.
- 3. The value of the contract (£61,287.00) is below the EU-set thresholds for regulated procurements and a Request for Quotations (RFQ) procedure conducted via the Council's e-tendering suite (Capital E-Sourcing) is prescribed by Rule 9.8 of the Council's Contract Procedure Rules (CPR) as the procurement route to follow.
- 4. From this report, the RFQ process has been conducted, Blachere Illuminations has emerged as the successful bidder, and the Council's CPRs have been complied with.
- 5. The contract award should be entered in Contracts Finder.

FINANCIAL IMPLICATIONS AND RISKS

The contract cost of £61,287 would be funded from the existing Marketing and Events budget (A22035), private contractors payments for supplies and services (651780.6113). This budget is currently earmarked to fund the cost of the festive lights and Christmas trees.


