# Part A – Report seeking decision

#### DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

To review the impact of providing a free bulky waste collection to shielding customers (now updated to "clinically extremely vulnerable" customers), and continue this free service in light of the newly imposed government lockdown. Review once lockdown has ceased.

## AUTHORITY UNDER WHICH DECISION IS MADE

The Council Constitution states: 2.5 The following Functions may be delegated to individual Cabinet members by the Leader.

(j) To consider and recommend plans in respect of the portfolio allocated.

# STATEMENT OF THE REASONS FOR THE DECISION

Customers are currently able to book a bulky waste collection with Havering Council, at a cost of £43 for up to 3 items, and £11 for each additional item. It subsequently costs the Council £28.12 per collection for Serco to carry this out. In total, 2329 bookings were received in 2019/20, totalling approximately £0.040m surplus for Havering.

A free collection for NHS shielding customers was introduced along with the reinstatement of bulky waste collections at the beginning of June. It was employed in order to allow customers that were shielding and unable to leave the house an option for free disposal of bulky waste items. The initiative was to be reviewed in September 2020.

NHS shielding officially ended nationally on 1<sup>st</sup> August 2020. Since then, the Council has continued to receive enquiries from customers that had previously been shielding, although there has been no requirement to shield for 3 months. It is recognised that there will be residents continuing to self-isolate due to concerns related to the spread of Covid-19, and the Government is now advising residents classified as clinically extremely vulnerable to self-isolate again.

The cost to the Council for running this free service is £28.12 per collection. Between June and August, 168 free collections were carried out at a cost of £4,724 to the Council. Due to an increase in paying customers during the same period, no reduction in the overall nett income was experienced. Going forward, external factors may influence the number of customers, for example the second lockdown and further shielding requirements, and whether the Reuse and Recycling Centre remains open during any such lockdown. This is likely to have a direct impact on the Council's nett income.

#### Recommendation:

#### Continue the free service for an extended period

Havering's Public Health service considers that provision of this service would assist with helping to protect the Borough's most vulnerable residents by helping them to avoid unnecessary travel. This is particularly pertinent now that a second government-imposed lockdown is upon us. The cost of this is largely dependent on whether Gerpins Lane Reuse and Recycling Centre (RRC) remains open or not. If closed, with more paying customers using the service this would help nett off any additional expenditure from providing a free service to clinically extremely vulnerable customers, as is the case for Table 1 (see Finance section). Without this, it would likely come at an additional cost to the council of approximately £0.001m per month (£1,000). Previously, the NHS shielding list was used to determine if a customer was eligible for a free collection and a further list is now available highlighting customers considered extremely vulnerable, with residents having received a letter to advise them to shield. The RRC currently remains open.

### OTHER OPTIONS CONSIDERED AND REJECTED

#### Discontinue this service and revert to all residents being required to pay

This would include removing all reference to this from the Council's website and stipulating that all customers will be required to pay for their bulky waste collection. It should be noted that Havering's Public Health service recognise that there will be residents that are self-isolating for medical purposes and as such the Council has a duty to protect these residents so far as is practicable.

# Part B - Assessment of implications and risks

## LEGAL IMPLICATIONS AND RISKS

This report is seeks approval to continue the free collection of bulky waste for clinically extremely vulnerable residents in light of the new lockdown measures introduced by the Government from 5 November until 2 December 2020.

The Council has an existing contract with Serco for the provision of waste collection and recycling services which includes the collection of bulky waste in furtherance of its role as a waste collection authority with a duty to collect household waste under section 30(3) of the Environmental Protection Act 1990. However, there is no duty to collect household waste to a prescribed frequency. Under the Controlled Waste Regulations 2012, domestic bulk items are considered household waste, albeit a type for which a charge may be applied for collection.

During the first lockdown, the government made regulations compelling certain people who are particularly vulnerable to catching the virus to self-isolate/shield and a number of initiatives were put in place to make it easier for them to abide by this, one of which was the offer for free bulky waste disposal. Although compulsory shielding ended on 1 August, the Council is now seeking to extend the free disposal of such waste in light of the new lockdown imposed by the Government until 2 December, taking into account those residents now considered clinically extremely vulnerable.

In the current circumstances and as long as the Council continues to carry out its statutory duty, there should be no legal risk to the Council if it continues to deliver the free bulky waste disposal service to these residents.

# FINANCIAL IMPLICATIONS AND RISKS

Table 1 indicates the likely costs should the delivery of this free service be continued.

The cost of this is largely dependent on whether Gerpins Lane Reuse and Recycling Centre (RRC) is open. If closed, and more paying customers use the service the additional income would help mitigate any expenditure from providing a free collection service to clinically extremely vulnerable customers, as is the case for Table 1. Without an increase in paying customers, it is anticipated to give rise to additional cost to the council of c£0.001m per month, based on an average monthly customer count of 80-90. The RRC currently remains open.

Havering outsources its waste collection services to Serco, and regardless of the number of customers, Havering expects all collections to be carried out safely and to schedule.

In addition, the Council is also committed to improving the quality of life and wellbeing for all Havering residents in respect of socio-economics and health determinants.

The Government-instigated lockdown to combat the spread of Covid-19 may have previously had a disproportionate impact on those residents self-isolating or shielding at home. This means that they would not have been able to visit Gerpins Lane Reuse and Recycling Centre, where items can be disposed of for free, whilst the TCL reuse charity that customers can utilise to collect reusable goods had suspended operations. Therefore, these customers would have had no choice but to pay for a collection, particularly if they have no family or friends able to assist in removing the items.

The recommendation from Government is for clinically extremely vulnerable people to continue shielding / self-isolating during the second national lockdown. Therefore, the opportunity does not exist for these residents to take their items free of charge to Gerpins Lane RRC without risk to their health. As such may have no other outlet for disposing of this waste. Whilst TCL Reuse Centre offer free collections of bulky goods, these are only for goods that are in a reusable condition.

Havering's public health team considers that provision of this service would assist with helping to protect the Borough's most vulnerable residents.

## HEALTH AND WELLBEING IMPLICATIONS AND RISKS
