Policy context:	The Council's High Needs Strategy 2017-22, set out ambitious and realistic objectives to ensure Havering's provision is the first choice for children and young people with high needs and their families. The Strategy also recognises that children with Social, Emotional and Mental Health difficulties (SEMH), alongside those with Autistic Spectrum Disorders (ASD) are increasing in numbers and will require specialist intervention supported in a specialist-resourced provision.	
Financial summary:	This report seeks authorisation to award a construction contract in the sum of £595,428.61. Further details are provided in the body of the report.

#### DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

To agree to award a contract for the design and build of the extension to an existing ARP facility with associated external works at Clockhouse Primary School, to Valuegrade Ltd at a value of £595,428.61, with an estimated commencement date of September 2021. The contract length is anticipated to be 42 weeks.

#### **AUTHORITY UNDER WHICH DECISION IS MADE**

#### 3.3 Powers of Members of the Senior Leadership Team

Members of the Senior Leadership Team (SLT) have delegated authority to act as follows within the assigned service service/portfolio of responsibilities, subject to the general provisions and limitations set out in section 3.1 above.

#### **Contract powers**

(b) To award all contracts with a total contract value of between £500,000 and £5,000,000 other than contracts covered by Contract procedure Rule 16.3.

#### STATEMENT OF THE REASONS FOR THE DECISION

The purpose of the contract which is subject to this decision is to provide an extension to the existing ARP provision at Clockhouse Primary School, providing an additional 8 places and a number of 20 in total. The proposed form of contract to be the JCT Design & Build Contract 2016 with the Council's Supplemental Amendments.

Approval to commence tender was given on 3<sup>rd</sup> March 2021.

Since the Executive Decision to approve this procurement route, a tender exercise has been carried out based on a JCT Design and Build contract through the Fusion portal. In line with the Council's Contract Procedure Rules (CPR), the list of tenderers was sought from Constructionline, and seven suppliers were invited to submit bids. The construction market remains highly competitive at this point in time.

During the tender exercise seven contractors were invited to tender and five returned a priced offer. One bidder declined to tender due to ongoing work commitments. One contractor was unable to tender due to an internal administrative error on their part. The quality level of the bids in the tender was satisfactory. Further details of the tender process (including the price and scoring information) are set out in **Appendix 1**, attached to this report. As a result it is proposed to appoint the Contractor with the highest scoring compliant bid to undertake the works, namely Valuegrade Ltd.

### OTHER OPTIONS CONSIDERED AND REJECTED

Doing nothing would lead to the Council losing the approved departmental funding for the project and the school would be unable to provide the additional places required for the expanded ARP.

#### PRE-DECISION CONSULTATION

#### **Key Executive Decision**

Consultation has taken place with a number of relevant key stakeholders. In addition to this, consultation has taken place with the finance, legal and the Strategic Procurement Unit. Local residents were also consulted via the Planning Process (Planning permission granted 9<sup>th</sup> February 2021, reference P1898.20) and members were invited to approve the scheme as part of the Cabinet/ Full Council process.

#### Part B - Assessment of implications and risks

#### LEGAL IMPLICATIONS AND RISKS

Section 1 of the Localism Act 2011 grants Local Authorities a General Power of Competence, allowing it to do anything that an individual may do, provided there are no statutory constraints, and that it either furthers its functions or benefits the Local Authority's area.

The Local Authority is a Contracting Authority for the purposes of the Public Contract Regulations 2015 (PCR). The value of the contract is the below the works contract threshold of £4,733,252, therefore this Contract is not caught by the Regulations. However, the Local Authority must still be mindful of the general principles of procurement as set out in the PCR, namely that it must treat economic operators equally, without discrimination, and act in a transparent and proportionate manner.

The Local Authority is electing to use the JCT 2016 Design and Build Standard Terms and Conditions for this Contract in compliance with the Local Authority's Contract Procedure Rules (CPR Rule 13)

The Local Authority has a fiduciary and best value duty to safeguard its resources. As detailed in the report, Council Officer's consider the awarding of the Contract to Valuegrade achieves compliance with these duties. Undertaking a PCR complaint procurement process via Constructonline further ensures that these duties are met.

All Contracts with a value above £150,000 along with any collateral warranties must be executed under seal, this provides the Local Authority with a limitation period of twelve years. The conclusion and execution of the contract should be carried out by Legal Services.

The successful contractor is required to provide a performance bond.

For the reasons set out above, the Council may if minded agree the recommendation for the entering into the Contract as detailed in Part A of this report.

#### **Risks**

As with most capital schemes, there is a risk that the scheme could overspend due to issues arising during the build process, this risk is mitigated via a contract administration procedure as set out within the JCT Design and Build 2016 (with Amendments) that provides constant

monitoring and final cost forecasting. Any issues arising can be funded from the client contingency sum.

There exists a risk of delays as with any major building project, but this will be mitigated by a scrutinised critical path programme issued to the Contract Administrator and all the shareholders and reviewed against the on-site progress at four weekly and ad hoc meetings.

As with all contracts there is a risk to contractor delivery/continued operation. However the contractor selection process has partly mitigated this risk, along with careful project management in the future.

Covid-19 constitutes a risk to the delivery of any construction contract (supply chain disruption). Brexit also constitutes a risk to the delivery of any construction contract (supply chain disruption).

The extension to the existing ARP provides increased places at the school for SEND pupils within the community and improved facilities for the existing pupils. This will positively impact the pupils' school experience by improved quality of the building and classrooms.

New teaching staff will be required to facilitate the department alongside the existing.

The construction of the extension has been planned such that the children will be impacted as little as possible by the noise, however provision has been made when required to move those directly impacted by the development when the internal remodelling works are carried out. This is fully considered within the contractor's programme. In addition a section of the elevation has been designated for the school to interact in the build in the form of an art project post completion, allowing a sense of ownership by the pupils.

Construction traffic and general noise mitigation has been considered within the planning application and the appointed contractor will strictly adhere to these requirements.
