# Part A – Report seeking decision

#### DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

1. To agree to request an additional Mobile Testing Unit (MTU) from the Department for Health and Social Care to be located in the car park of the Gallows Corner Tesco's.

# AUTHORITY UNDER WHICH DECISION IS MADE

Council Constitution, Part3, Section 3.2, Powers of the Chief Executive. (c) To carry out the functions of the Council for civil aid and emergency planning and to take any action, including incurring expenditure, in connection with an emergency or a disaster in the borough.

# STATEMENT OF THE REASONS FOR THE DECISION

#### 1. Background

The UK is currently experiencing a fourth wave of infection going into the Christmas months with expert modelling suggesting cases rates will rise exponentially. This wave is being driven by a more transmissible strain of coronavirus named Omicron.

The public are asked to take a PCR test when symptomatic to identify whether the individuals is infected with coronavirus. To encourage high uptake of symptomatic testing it is important that residents have as easy access to testing as possible with minimal geographical or financial barriers.

As highlighted in previous decision papers<sup>12</sup>, the Council have worked to ensure there is ample symptomatic testing infrastructure within the borough to provide for residents. Since January 2021, the borough has 4 permanent local testing sites (LTS) and 1 MTU strategically placed around the borough.

On 17<sup>th</sup> December, a previous ED was drawn up with cabinet briefed about deploying a 2<sup>nd</sup> MTU in Rainham Tescos car park on Viking Way. This current ED will enable Havering to have a third MTU in the borough to help manage symptomatic testing demand.

#### 2. Rationale

The new wave of infection has now reached incidence rates which are above what has been seen before and it anticipated to increase further, thus increasing the demand for symptomatic testing in the borough. During the winter 2021 wave of infection, infrastructure in the borough regularly reached 100% utilisation for daily testing.

It is now recommended that further testing infrastructure is sought to manage anticipated demand in the area. The recommended action is to request an additional MTU from the Department for Health and Social Care.

Considering the geographical placement of infrastructure and cases rates across the borough it is recommended this MTU is placed in the North East of the borough.

#### 3. Placement of MTU

The recommendation is to place the MTU in the Tesco Superstores Car Park based on Gallows Corner, Romford. This Tesco superstore have agreed to accommodate the MTU in the car park until the end of January 22 and longer if necessary.

This builds on the current relationship the Council has with Tesco's whereby the same store allows our Covid Response teams to distribute home testing kits from the front of the store as part of our pop up initiative.

# 4. Operational Detail

The costs of setting up and running the site are covered by the national testing programme.

The site location costs are covered by the Tesco Superstore with the store enabling a specific location to be reserved for the MTU. The MTU operates in a manner to leave nothing behind at the end of each day, therefore, the space will need to be reserved.

The Council is required to provide toilet facilities specifically for the MTU teams, this cost is  $\pounds720$  per month. The Council will also deploy signage to ensure residents are aware of the location, this cost is estimated to be  $\pounds1000$  as a one off cost. The toilet facilities will remain on site overnight and will be secured within Heras fencing.

The deployment for the MTU is in line with need but as a minimum is expected to be two months, the council has put a side costs of up to £5000 to fund the deployment. These funds will be covered through the COMF budget.

# OTHER OPTIONS CONSIDERED AND REJECTED

Do not request additional facilities – this is not recommended as it is assessed that additional facilities are required to meet projected increased demand.

# PRE-DECISION CONSULTATION

The Leader of the Council has been kept informed of the requirements from the Secretary of State and the local governance structure as well as our plans to utilise these sites.

# Part B - Assessment of implications and risks

#### LEGAL IMPLICATIONS AND RISKS

The Council has power to establish the additional testing facility in discharge of its duties under various statutes including the Health and Social Care Act 2012 and the Civil Contingencies Act 2004.

The land upon which the testing and toilet facilities will be placed is owned by Tesco, which consents to its use. A licence arrangement should be entered into in respect of the car park area used.

# FINANCIAL IMPLICATIONS AND RISKS

The majority of costs of setting up and running the Test site will be covered by the DHSC.

The council will cover costings such as signage and toilets at a one off and monthly payment respectively with an estimated cost of £5000 for it's full deployment time. These one off costs will be covered by the contingency allocation within the COMF budget.
