RLH The victim of this report is in a serious condition in RLH. The trauma team have generated a crime report for GBH 5409227/22 ND CID were informed of this incident by the RLH trauma team as they were not satisfied by the conflicting accounts given regarding the circumstances surrounding how the victim became to be in his condition. There is first mention of a physical altercation involving the victim, there is a cousin who stated the victim was pushed and the officers state they spoke to security who say the victim just jumped and there are no offences. I was passed this information as the ET DS and want to establish the facts of what occurred. We have made contact with the venue and they

state the manager is not available at this moment in time to
download CCTV. The staff have been told for the manager to get in touch
with CID as a matter of priority as CCTV needs to be viewed, it needs to
be confirmed how the victim became to be at the bottom of the
stairs with injuries where scans confirm he has fractures to his eye socket
