Update on injury 2cm cut on one side the arm with a 1 cm cut the other side. CID informed.

How can we be sure that the person presenting is the victim? Can this be confirmed by CCTV at location or could this be unrelated/coincidental? If this isn't our victim we need to conduct hospital checks.
 2. How did victim get to hospital? Hospital CCTV to be reviewed to find out whether a vehicle was used to transport the victim. Consideration for more witnesses/victims.
 3. Victim unwilling. Consideration to arresting him for Affray once he

large has received treatment, given that he was involved in a reported
scale fight. We may be able to identify more people involved if
arrested, e.g phone downloads etc.
There is no scene as it appears that the ground has been doused
with water.
