EA400 Video footage received via email from METCC of male being attacked by door staff outside the Rising Sun public house - appears to be punched and kicked to the ground losing consciousness. Undated footage is circulating online and a CRIS possibly exists and found in TIB list 5413126/21 - however multiple reports re. fights at the establishment over the BH weekend. Press enquiries received as rumours circulating about victim's conditions online and LI tasked to identify whether or not the offence is known about and whether anyone matching description of male pictured has received medical treatment and investigate as far as possible - DETERMING WHEN THE OFFENCE OCCURRED. Actions of door staff are excessive and they should be arrested & interviewed about the matter - licensing will also need to be made aware of the incident. LI AND CH INSP FISH MADE AWARE.
