Police were called by security at the Rising Sun to a large fight involving 20 people in the venue. Officers arrived on scene and all waring parties had been separated and walked off in opposing directions prior to police arrival. **REDACTED** was sat on a bench outside the pub and had various facial injuries and a bruise under his eye. LAS were called for him. He said that he was the victim of a random unprovoked attack in the pub. He described the suspect as an Albanian male, 6 feet tall, with a neat kept beard. He was unable to give much of a description as the victim had been drinking heavily. He was left in the care of family and his girlfriend awaiting LAS.
