Officers spoke to the victim who stated the video of the assault had been circulating on social media and numerous friends and family has been contacting him regarding the footage being circulated. The Rising Sun Pub posted a reply on their facebook page which has since been removed, due to negative comments of the pub and the video being circulated on social media.

There has been numerous incidents regarding this pub with disorder and has become a community issue, where the local community are unhappy and that this could escalate into more of an issue with other people attending the premises. CID was contacted at the home address and stated the injuries were not GBH as he only needed to attend RLH as the stitches needed to be inside his mouth, even though the victim lost consciousness and the community issues rising from this incident.

The victim stated he was pushed away from the pub by one bouncer after being refused entry
