Many residents of Shepherds Hill and nearby Phillida Rd living in the surrounding area of Array and Bayou, request a review of this license in relation to Public Safety, The Prevention of a Public nuisance and the prevention of crime and disorder.

This review has the support of local councillors, and local residents. Please find attached letters of support for this review from residents who are continually affected by Arrays licencing hours.

We ask this licence is reviewed now required as the impact has been ongoing for a protracted period of time – over 18 months, and we believe that we have been misled as to the use of the premises and the amount of previously issued licences have led to confusion as to the validity of the times and use in respect of content of the recent applications. We have also been previously informed that the extended opening hours were referred to as “Grandfather rights” but the timings noted within the historic documents from the previous ownership and the changes made in recent applications made by the Array do not correlate.

Many local residents have been continually affected and harassed by the anti-social behaviour of Array customers as they arrive from approx. 10pm and then leave the premises up to 2am.and occasionally much later than this.

Array runs 2 venues out of this venue.

Array and Bayou. The venue offers Shisha/smoking inside their venue and the venue turns into a nightclub on Friday, Saturday and Sundays with DJ's. Their social media states you can dance the night away.

The venue numbers appear to increase from approximately 10pm onwards with customers arriving later on in the evening attending the ‘club’ and combining with the clients already at the restaurant.

The anti-social behaviour, abuse of neighbours and inconsiderate/illegal parking of Array customers occurs generally due to the customers attending the venue late and gets increasingly worse up to and when they are leaving the venue in large numbers from 1.30am.

. On 12<sup>th</sup> August 2021 this venue was granted an even later licence on Thursday – Sundays and was extended to 1.30am. There was no consultation with any of Array neighbours and this has further exacerbated the problem of the noise nuisance and antisocial behaviour.

The licencing team have advised they posted a notice outside the venue and in the Romford recorder to advise of the licensing hours BUT this was at the start of the complete lockdown, when we were unable to leave our homes unless for essential purposes as per government guidelines. How could we residents have picked up a copy of the Romford Recorder or walked along in search of notices outside venues.

This venue has been granted a license when it was impossible for the local community to find out about it and object. This license was granted without consideration for the area where Array sits or the residents who live all around Array and is not acceptable to us residents.

Many of the residents within Shepherds Hill and Phillida Rd are enduring on an almost daily basis Array customers leaving the premises, shouting, screaming at each other, revving their cars up in the car parks, sounding their horns on leaving the premises, urinating and defecating in the street, vomiting outside our homes and in our front gardens, on returning to their vehicles shouting and playing music extremely loudly and continuing the party outside our homes and snorting cocaine – off their car bonnets on occasion.

There have been multiple large brawls, verbal altercations and fights at the venue that have ended up in the car park and beyond. There is security at the venue which has been mainly ineffective. The problems of noise and nuisances such as shouting, swearing, brawling, the revving of car engines, playing of loud music within the confines of the premises and the car park overspill onto the street and on occasion has ended in residents gardens.

The noise nuisance results in Arrays neighbours for a large radius not being able to rest at home and or being woken up several times a week from late night to early morning. Some of our community who live

around and near Array are extremely fearful of leaving their properties after dark due to the threats we have received from Array customers. Many of us neighbours have politely requested that car owners refrain from parking on the cross over outside of their properties, leaving their vehicle on the grass verges leading to a torrent of verbal abuse and advised to call the police or even worse. CAD numbers have been supplied.

This venue sits within a 360-degree position to houses and homes on all sides. Please see attached area map showing this. We suggest this venue has inappropriate licencing times for the area and inappropriate parking for the venue they have built. The extensions they have built are not as per their planning approval and have resulted in the venue being much larger without adequate parking. Their basic human right to a peaceful life has been taken away. They should have a right to expect a peaceful life and to be able to have regular night's sleep.

Some of the activities of the Array clients and licence owner have had direct negative and accumulative impact on the general well-being on many of its neighbours, leading to mental health issues, stress, sleep deprivation, with some finding it necessary to relocate to other parts of their homes to avoid the night-time disturbances and anti-social behaviours of Array clients when arriving and departing the premises, and in many cases long after the venue is officially closed. This, in itself presents another issue as the security team have left the venue leaving the nuisances that should had been reduced or controlled and have been allowed to continue unabated for quite some considerable time and in multiple instances until 0500 hours the next day.

Multiple residents have been harassed by Array customers and Array staff. At least three neighbours have been verbally abused by Nadir Gul – one of the venue owners and license holder. One example being on 19/06/2022 when a neighbour asked the venue for 3 illegally parked cars to be moved (all confirmed Customers of Array). The council advised us in writing that the venue would assist us in asking their customers to move if their customers were parked on our drives or illegally. Within 10 minutes of having asked the venue to move the 3 cars Nadir Gul was aggressively knocking on multiple residents doors to find out who had asked for the 3 cars to be moved that were illegally parked. A neighbour came out of her property as he reached their home and was about to knock to ask what was going on. Nadir had 6 henchmen with him, this was very threatening and menacing and was totally unwarranted. There was also a 4x4 vehicle with more men in it staring at these residents and men standing on either end of the road. The resident filmed this verbal assault and has submitted to the police. The Police have advised they will caution Mr Gul for this. He told the resident he hated the locals, and to shut her f\*\*king mouth. Mr Gul said he would do whatever he wanted. He knows where we live. The residents felt extremely threatened and their safety was and is at risk.

The local residents feel they get very different treatment from Array staff and Management to the what they tell the council authorities.

The brawls, fights and antisocial behaviour has affected public safety on numerous occasions with Police CAD numbers collated for multiple examples across a range of residents and incidents. From the video evidence collated, it is clear that a lot of alcohol etc has been consumed and we feel the amount of time this venue is licensed to supply alcohol is making the noise nuisance and antisocial behaviour worse.

Array offers Shisha and smoking inside the venue which again was a breach of their licence. To get around a council inspection Array now open the roof on the back, which has increased the noise nuisance and light nuisance. The neighbours all around are now troubled weekly by the live music, recorded music, thumping bass and the sounds and smells of hundreds of customers partying and smoking. Array is licensed for Indoor activities only. This is a breach of their license.

Cabs and cars start turning up any time from 1am to pick people up from the venue, bibbing and shouting for their customers.

This venues licencing hours we feel are inappropriate for where the venue is located and has deprived the neighbours of a half mile radius of a peaceful life and being able to get a nights sleep in their own homes.

We ask that the license is re-assessed with a view to amend the closing time to 11.00pm, which we feel is a reasonable compromise on behalf of the residents of Shepherds Hill and Phillida Road which are most affected roads in the immediate vicinity.

The residents lives have been blighted for too long as a result of the licensing hours.

Yes. 6 residents went to Array on Saturday 6<sup>th</sup> Feb 2021 and had a meeting with the management at Array. Kem Centinay, Nadir Gul and Kems father were in attendance.

We explained we are all neighbours but the noise nuisance, regular fights and antisocial behaviour and parking problems were not acceptable.

At this meeting Nadir was aggressive and Kem and his father calmed him down. Nadir recalls that meeting as 'talking very nicely to us'. We were a small group of neighbours with a lady in her 80's, and we were asking for their help to make our lives bearable. We explained we would much rather sort this out together.

Kem and his Father told us in the main whatever we wanted to hear and we left hopeful.

Customers had to book, no walk ins etc. Within 24 hours of that meeting they launched Bayou as a walk in venue. That night was one of the worst nights we had experienced in our area for antisocial behaviour of their customers. We realised we had been lied to on every aspect of that meeting.




