Section 31 (Local Government Act 2003) Grant Determination Letter for the Biodiversity Net Gain Grant 2022/23: Grant No. 31/6499

This Determination is made between:

- (1) The Secretary of State for Environment, Food and Rural Affairs and**
- (2) The local authorities listed at Annex A.**

Background

Biodiversity net gain (BNG) is an approach to development that leaves biodiversity in a measurably better state than before. This means protecting existing habitats and ensuring that lost or degraded habitats are compensated for by enhancing or creating habitats that are of greater value to wildlife and people.

The Environment Act 2021 includes provisions that make the achievement of 10% biodiversity gain mandatory for most developments under the Town and Country Planning Act 1990. The requirement is due to come into force in November 2023 after a transition period.

Purpose of the Grant

The purpose of this grant is to provide funding to the local authorities in England listed at Annex A, towards expenditure lawfully incurred or to be incurred by them in the transition period.

The grant is intended to further support local planning authorities in their preparations for the introduction of mandatory BNG. Any further funding for this purpose, beyond this period, would be confirmed in due course.

Grant amounts

The grant covers the 12-month period from 1 April 2022 to 31 March 2023.

- Total funding allocated for 2022/23 is a maximum of £10.55 million.

Further funding for the remainder of the transition period for the period 1 April 2023 – 31 October 2023 will be confirmed in due course but is expected to be a maximum of £6.16 million (provisional). This will be followed by further new burdens funding following commencement of the requirement in November 2023.

The funding allocated for 2023/24 is provisional as it relates to a future financial year, but would only change in exceptional circumstances. Defra will confirm this early in the 2023/24 financial year. This funding will also be ring-fenced for the purposes of delivering mandatory biodiversity net gain from November 2023.

The grant amount for each local authority includes:

- 1) One off set up and preparation costs – core tasks in the transition period including familiarisation with guidance and adjustment of existing processes and systems to accept net gain data from the metric/biodiversity gain information.
- 2) Preparation for BNG assessment - an amount per authority to prepare to assess biodiversity gain plans from November 2023. Higher or lower future demand is estimated using the number of planning applications over a 3-year historical average. Authorities are grouped. Defra will keep this allocation under review as evidence of BNG practice becomes available, and in line with the New Burdens Doctrine.

Local authorities have been placed in one of two bands based on element 2, with the amount per authority listed at Annex A.

This grant is subject to conditions, which can be found at Annex B.

Purchase orders for 2022/23 will be distributed to local authorities once the grant conditions have been accepted. Local authorities will then need to invoice against their purchase order to claim their grant.

REVENUE grant determination (ring-fenced)

Biodiversity Net Gain Grant GRANT DETERMINATION 2022/2023: No 31/6499

The Secretary of State for Environment, Food and Rural Affairs (Rt Hon Thérèse Coffey MP) (“the Secretary of State”), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the Biodiversity Net Gain Grant Determination 2022/2023 [No31/6499].

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them to make the preparations necessary to apply a minimum 10% increase in biodiversity to planning permissions (unless otherwise exempt) granted under the Town and Country Planning Act 1990 from November 2023.

Determination

3) The Secretary of State determines as the authorities to which the grant is to be paid and the amount of grant to be paid, the authorities and the amounts set out in Annex A.

Grant conditions

4) Pursuant to section 31(3) and 31(4) of the Local Government Act 2003, the Secretary of State determines that the grant will be paid subject to the conditions in Annex B.

Treasury consent

5) Before making this determination in relation to local authorities in England, the Secretary of State obtained the consent of the Treasury.

UK Government Branding

6) The Grant Recipient shall at all times during and following the end of the Funding Period:

6.1 comply with requirements of the Branding Manual in relation to the Funded Activities; and

6.2 cease use of the Funded by UK Government logo on demand if directed to do so by the Authority.

7) **Branding Manual** means the HM Government of the United Kingdom of Great Britain and Northern Ireland 'Funded by UK Government branding manual' first published by the Cabinet Office in November 2022 and is available at:

Annex B

GRANT CONDITIONS

1. The funding must only be used by the local authority between 1 April 2022 and 31 March 2023 to deliver measures that prepare for applying at least a 10% biodiversity net gain, as introduced in the Environment Act 2021, to planning permissions (unless otherwise exempt) granted under the Town and Country Planning Act 1990.

2. An authority must confirm agreement to the condition by 30 March 2023 and provide evidence of spend incurred against the condition during this period to SM-Defra.NetGain@defra.gov.uk by 30 March 2023. A template for returns is attached at Annex C.

3. The Chief Executive and Chief Internal Auditor of each of the recipient authorities are required to sign and return to the team leader of the Biodiversity Net Gain Team of the Department for the Environment, Food and Rural Affairs a declaration, to be received no later than 30 March 2023, in the following terms:

“To the best of our knowledge and belief, and having carried out appropriate investigations and checks, in our opinion, in all significant respects, the conditions attached to Biodiversity Net Gain Grant No 31/6499 have been complied with”.

4. If an authority fails to comply with any of the conditions and requirements of paragraphs 1 and 2, the Secretary of State may-

- a. reduce, suspend or withhold grant; or
- b. by notification in writing to the authority, require the repayment of the whole or any part of the grant.

5. Any sum notified by the Secretary of State under paragraph 4(b) shall immediately become repayable to the Secretary of State.

6. Subject to paragraphs 4 and 5, if there are funds left over at the end of the financial year they may be carried over into the next financial year. Funds carried over should be accounted for in a Biodiversity Net Gain ring-fenced reserve. All the conditions that apply to the use of the grant will continue to apply to any funds carried over. However, where there are large underspends the department reserves the right to reduce allocations in future years.
