Part A – Report seeking decision

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

This Executive Decision seeks approval to:

Installation of Disabled Persons Parking Bays

- a) **Taunton Road** installation of a disabled persons parking bay outside No.20
- b) **Camborne Avenue** installation of a disabled persons parking bay outside No.45
- c) Manor Road, Romford installation of a disabled persons parking bay outside Nos.1 to 8 Heritage Court
- d) Hillrise Road installation of a disabled persons parking bay outside No.267
- e) Wantz Lane installation of a disabled persons parking bay outside No.23
- f) Dagnam Park Drive installation of a disabled persons parking bay outside Nos.219-225

Installation of Personalised Disabled Persons Parking Bay from existing Disabled Persons Parking Bays

- g) Brookway installation of a personalised disabled persons parking bay outside No.3
- h) Waycross Road installation of a personalised disabled persons parking bay outside No.47
- i) Maple Street installation of a personalised disabled persons parking bay outside No.11

Removal of a Disabled Persons Parking Bay

- j) **Margaret Road outside No.17** removal of a disabled persons parking bay as no longer needed.
- k) **Roseberry Gardens outside No.61** removal of a disabled persons parking bay as no longer needed.
- I) **Paines Brook Way outside No.82** removal of a disabled persons parking bay as no longer needed.

Extension of No Waiting At Any Time Restrictions/ Waiting Restriction

- m) **Swanbourne Drive** extend the no waiting 'At any time' restrictions on Swanbourne Drive to the rear of Nos.2 and 4 Hitherwood Close and outside No.47 Swanbourne Drive on the bend.
- n) **Broadway, Rainham -** extending the existing no waiting 'At any time' restrictions outside St Helens and St Giles Church in the Broadway, Rainham and extend the existing waiting restriction Monday to Saturday 8.30am to 6.30pm on Broadway opposite St Helens and St Giles Church.

Installation of No Waiting At Any Time Restrictions

- o) **Sowery Avenue and Wells Gardens** installation of no waiting 'At any time' restrictions on the junction of Sowrey Avenue and Wells Gardens.
- p) Morecambe Close and South End Road installation of no waiting 'At any time' restrictions on the junction of Morecambe Close and South End Road
- q) **Squirrels Heath Lane** installation of no waiting 'At any time' restrictions on the new entrances and joining them up with the existing no waiting 'At any time' restrictions.

Removal of Pay & Display Bays and Installation of Waiting Restriction

r) **Park Drive, Romford –** removal of three of the existing pay and display bays and replace them with a waiting restriction Monday to Saturday 8.30am to 6.30pm, in line with the existing restriction.

Removal of Residents Permit Parking Bay and Installation of Waiting Restriction

s) **Claremont Road –** removal of a residents permit parking bay on Claremont Road outside Nos 45/47 and replace it with a waiting restriction Monday to Friday 8.30am to 6.30pm in line with the existing restriction

(s) To authorise minor alterations to traffic management orders to enable implementation of approved proposals or continuation of traffic management schemes.

(u) To authorise the creation, amendment and removal of disabled persons' parking bays and footway parking bays and at any time waiting restrictions at bends and road junctions

STATEMENT OF THE REASONS FOR THE DECISION

The proposed minor parking schemes (detailed previously and drawings shown in the following parts to this report) have been designed to introduce disabled parking provisions across the borough and improve road safety, access and traffic flow for all road users around bends and junctions. The proposals have been reviewed for general accessibility and impact on existing parking provision.

Installation of Disabled Persons Parking Bays

Requests have been received by local residents supported by Occupational Therapy for the installation of disabled persons parking bays at the following locations:

a) Taunton Road outside No.20 (as shown on drawing reference Taunton Road)

b) Camborne Avenue outside No.45 (as shown on drawing reference Camborne Avenue)

- c) Manor Road, Romford outside Nos.1 8 Heritage Court removing a resident permit parking bay (R03 Zone)
- d) Hillrise Road outside No.267
- e) Wantz Lane outside No.23
- f) Dagnam Park Drive outside Nos.219 225

Schemes Officers have assessed and explored all options to locate a disabled persons parking bay facility in support of the requests. As it has not been possible to provide a parking facility within the confines of the respective properties, therefore it has been decided that the introduction of disabled persons parking bays (as shown on the respective drawings) would be justified.

No objections were received to the formal consultation. Officers therefore recommend to the Assistant Director of Public Realm approval of the installation of a disabled persons parking bay at each location as referenced above, as advertised.

Installation of Personalised Disabled Persons Parking Bay from existing Disabled Persons Parking Bays

Requests have been received from residents that have had disabled persons parking bays installed to change them to personalised disabled persons parking bay as other blue badge holders were using this facility which was initially installed for this resident. These requests are supported by Occupational Therapy due to the needs of the residents. These are in the following locations;

- g) Brookway outside No.3
- h) Waycross Road outside No.47
- i) Maple Street outside No.11

Schemes Officers have assessed these locations and support the change to personalised disabled persons parking bays (as shown on the respective drawings) would be justified.

No objections were received to the formal consultation. Officers therefore recommend to the Assistant Director of Public Realm approval of the installation of a personalised disabled persons parking bay from an existing disabled persons parking bay at each location as referenced above, as advertised.

Removal of a Disabled Persons Parking Bay

j) Margaret Road outside No.17

Requests have been received by residents to remove a disabled persons parking bay outside No 17 Margaret Road and reinstate the permit parking area Monday to Friday 8am to 6.30pm (GP5 Zone) as this bay is no longer required.

k) Roseberry Gardens outside No.61

Requests have been received by residents to remove a disabled persons parking bay outside No.61 Roseberry Gardens and reinstate a footway parking bay as this bay is no longer required.

I) Paines Brook Way outside No.82

Requests have been received by residents to remove a disabled persons parking bay outside No.82 Paines Brook Way as this bay is no longer required.

No objections were received to the formal consultation. Officers therefore recommend to the Assistant Director of Public Realm approval for the removal of the disabled persons parking bay at each location as referenced above, as advertised

Extension of No Waiting 'At Any Time' Restrictions / Waiting Restrictions

m) Swanbourne Drive (as shown on drawing reference Swanbourne Drive)

A request was received from a Ward Councillor to extend the no waiting at any time restrictions on Swanbourne Drive to the rear of Nos.2 and 4 Hitherwood Close and outside No.47 Swanbourne Drive on the bend to improve road safety.

Officers have visited this location and recommend extending the no waiting 'At any time' restrictions on the apex of the bend. These proposals will improve road safety and sight lines for all road users.

No objections were received to the formal consultation. Officers therefore recommend to the Assistant Director of Public Realm approval for the extension of the no waiting 'At any time' restrictions in Swanbourne Drive as advertised.

n) Broadway, Rainham (as shown on drawing reference Broadway, Rainham)

A request was received from a Ward Councillor and the church following the relocation of a pedestrian crossing to amend the existing restrictions around the church to enable alighting from vehicles in this location.

Officers have visited this location and recommend extending the existing no waiting 'At any time' restrictions outside St Helens and St Giles Church in the Broadway, Rainham. Officers also recommend extending the existing waiting restriction Monday to Saturday 8.30am to 6.30pm on Broadway opposite St Helens and St Giles Church as advertised.

Installation of No Waiting 'At any time' Restrictions

o) Sowery Avenue and Wells Gardens

A request was received from the Ward Councillors to prevent obstructive parking on the junction of Sowery Avenue and Wells Gardens.

Officers have visited this location and recommend installing no waiting 'At any time' restrictions on the junction. These proposals improve road safety and sight lines for all road users.

No objections were received to the formal consultation. Officers recommend to the Assistant Director of Public Realm approval for the installation of the no waiting 'At any time' restrictions on the junction of Sowery Avenue and Wells Garden as advertised.

p) Morecambe Close and South End Road

A request was received from the Ward Councillor to prevent obstructive parking on the junction of Morecambe Close and South End Road.

Officers have visited this location and recommend installing no waiting 'At any time' restrictions on the junction. These proposals improve road safety and sight lines for all road users.

No objections were received to the formal consultation. Officers recommend to the Assistant Director of Public Realm approval for the installation of the no waiting 'At any time' restrictions on the junction of Morecambe Close and South End Road as advertised.

q) Squirrels Heath Lane

A request was received from the developer and Schemes Officer for no waiting 'At any time' restrictions on the new entrances to this new development to prevent obstructive parking replacing the existing waiting restriction (Monday to Saturday 8.00am to 6.30pm).

Officers have visited this location and recommend installing no waiting 'At any time' restrictions on the new entrances and joining them up with the existing no waiting 'At any time' restrictions on the junction with Elvet Avenue. These proposals are to improve road safety and sight lines for all road users.

No objections were received to the formal consultation. Officers recommend to the Assistant Director of Public Realm approval for the installation of the no waiting 'At any time' restrictions on the new entrances on Squirrels Heath Lane, as advertised.

Removal of Pay & Display Bays and Installation of Waiting Restriction

r) Park Drive, Romford

A request was received from a resident following a vehicle crossover application to remove three existing pay and display bays outside No.29 Park Drive in order for a vehicle crossover to be installed.

Officers have visited this location and recommend removing three of the existing pay and display bays and replacing them with a waiting restriction Monday to Saturday 8.30am to 6.30pm in line with the existing restriction.

No objections were received to the formal consultation. Officers recommend to the Assistant Director of Public Realm approval for the amendment to the pay and display bays and replacing them with the waiting restriction as advertised.

Removal of Residents Permit Parking Bay and Installation of Waiting Restriction

s) Claremont Road

A request from a resident following a vehicle crossover application to remove a residents permit parking bay on Claremont Road outside Nos.45/47.

Officers have attended site and recommend removing the existing residents permit parking bay (R03 Zone) and replacing it with a waiting restriction Monday to Friday 8.30am to 6.30pm in line with the existing restriction.

No objections were received to the formal consultation therefore Officers recommend to the Assistant Director Public Realm approval for the removal of the residents permit parking bay and replacing it with a waiting restriction as advertised.

OTHER OPTIONS CONSIDERED AND REJECTED

Officers have explored whether it would be possible for residents who require a disabled parking bay to provide a parking facility within the confines of their respective properties but this would not be possible and has been rejected as an option.

The option not to progress these schemes was considered but rejected. Officers consider the need to provide road safety, traffic flow, sight lines and access around these locations, which outweighs the loss of the general parking provision. The Council has obligations under the Road Traffic Regulation Act (1984) to secure the expeditious, convenient and safe movement of vehicular and other traffic (including cyclists and pedestrians) and to provide suitable and adequate parking facilities on and off the highway.






Taunton Road – Disabled Bay




Camborne Avenue Disabled Bay




Manor Road Disabled Bay






Margaret Road Removal of Disabled Bay




Roseberry Gardens Removal of Disabled Bay












Swanbourne Drive Extension of No Waiting 'At any time' Restrictions




Broadway, Rainham Extension Of Waiting Restrictions




Sowery Avenue & Wells Gardens No Waiting At Any Time Restrictions




Morecambe Close and South End Road No Waiting At Any Time Restrictions

Part B - Assessment of implications and risks

LEGAL IMPLICATIONS AND RISKS

Here Officers seek approval for various schemes that include the installation of a disabled persons parking provision, personalised disabled persons parking provision, removal of pay and display bays, removal of disabled persons parking provisions, extension of waiting restrictions, removal of residents permit parking bay and no waiting at any time restrictions around junctions and bends that pursuant to the Council's Constitution requires an executive decision by the Assistant Director for Public Realm.

The Council's power to make an order regulating or controlling vehicular traffic on roads is set out in Part I of the Road Traffic Regulation Act 1984 ("RTRA 1984") with the power to designate parking places set out under part IV of the RTRA 1984.

Before an Order is made, the Council should ensure that the statutory procedures set out in the Local Authorities Traffic Orders (Procedure)(England & Wales) Regulations 1996 (SI 1996/2489) are complied with. The Traffic Signs Regulations & General Directions 2016 govern road traffic signs and road markings.

Section 122 RTRA 1984 imposes a general duty on local authorities when exercising functions under the RTRA. It provides, insofar as is material, to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway. This statutory duty must be balanced with any concerns received over the implementation of the proposals.

In considering any responses received during consultation, the Council must ensure that full consideration of all representations is given including those which do not accord with the officer's recommendation. The Council must be satisfied that any objections to the proposals were taken into account.

In considering any consultation responses, the Council must balance the concerns of any objectors with the statutory duty under section 122 RTRA 1984.

FINANCIAL IMPLICATIONS AND RISKS

The estimated costs of £0.010m which include advertising costs and implementing the proposal as described above and shown on the attached plan will be met from the 2023/24 Schemes revenue budget.

This is a standard project for Schemes and there is no expectation that the works cannot be contained within the cost estimate. In the unlikely event of an overspend, the balance would be contained within the overall Highways budget.

Background/context:

The following schemes are designed to provide a disabled persons parking bay for the resident of the property, following an assessment of their needs by Occupational Therapy on;

- a) Taunton Road
- b) Camborne Road
- c) Manor Road
- d) Hillrise Road
- e) Wantz Lane
- f) Dagnam Park Drive

The following schemes are designed to provide a personalised disabled persons parking bay for the resident of the nearby property following issues with other blue badge holders using the current facility on;

- g) Brookway
- h) Waycross Road
- i) Maple Street

The following schemes are designed to remove a current disabled persons parking bay as they are no longer needed on;

- j) Margaret Road
- k) Roseberry Gardens
- I) Paines Brook Way

The following scheme is designed to improve access and prevent obstruction on;

m) Broadway, Rainham

The following scheme is designed to improve access, road safety and sight lines near the junction or on the bend on;

- n) Swanbourne Drive and Wells Gardens
- o) Morcambe Close and South End Road
- p) Squirrels Heath Lane

The following schemes are designed to allow access to vehicle crossover facilities on;

- q) Park Drive (removing some pay and display bays)
- r) Claremont Road (removing a residents permit parking bay)

Who will be affected by the activity?

The resident whom the disabled bay is meant for should have the benefit of have a parking space close to their property after an assessment by Occupational Therapy. Further to this, other Blue Badge Holders can also use the bay, if it is available.

Residents of the road might be disadvantaged by the introduction of the Disabled Parking Bay, as its installation will reduce the amount of available parking space in the road by one space, for them and their visitors.

The resident whom the personalised disabled bay is meant for should have the benefit of having a guaranteed parking space close to their property as they will be the only ones able to use it. Other blue badge holders will be disadvantaged as they will not be able to use this facility and they will have to find alternative parking.

The installation of the no waiting at any time restrictions around the junction and on the bend will improve sight lines, road safety and prevent obstruction.

These restrictions will impact on the parking capacity for residents and their visitors but blue badge holders can park on the no waiting at any time restrictions for up to three hours.

The installation of no waiting at any time restrictions will aid larger vehicles (emergency services and Council vehicles) and have street cleaning benefits.

Vehicles will not be able to park on the no waiting at any time restrictions, however they can still load and unload goods and alight passengers.

Removal of disabled persons parking bays will increase parking capacity for non blue badge holders. There is no current need for a disabled persons parking bay in these locations.

Removal of the pay and display bays will affect the parking capacity as road users will have to find alternative parking provision. The removal of these pay and display bays will allow this resident access to their vehicle crossover which means they will always have somewhere to park off street.

The removal of a residents permit parking bay will allow access to an off street parking facility for this resident but resident permit holders of the road maybe disadvantaged as it will reduce the amount of available parking space in road for them and their visitors.
