STATEMENT OF THE REASONS FOR THE DECISION

The Romford BID Boundary runs within the Ring Road of Romford town centre and premises within the BID boundary are used by Havering Council. The Council's electoral services have instructed an external ballot company to hold a ballot of eligible businesses within the BID area as required by regulation 5 of the Business Improvement Districts (England) Regulations 2004 (BID Regulations) and in accordance with the rules for ballots set out in schedule 2 of the BID Regulations. As premises used by Havering are within this area the Council will have the option to vote on the continuation of the BID.

Havering Council is supportive of the Romford BID and acknowledges the benefits that the BID has generated for the town. As part of the re - ballot process the BID have produced a proposal that illustrates their achievements over the previous five years and their aims and objectives for the next term of the BID. The proposal has been reviewed and approved and Havering Council supports the continuation of the BID for a second term.

OTHER OPTIONS CONSIDERED AND REJECTED

The option not to vote for a second term for the Romford BID has not been considered as this would contravene Havering Council's position that the BID has benefited the businesses of Romford.

PRE-DECISION CONSULTATION

The BID proposal for a second term has been reviewed and approved and Havering Council is assisting in the coordination of the BID re ballot.
