Part A - Report seeking decision

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

The SLT Lead is recommended to agree to terminate the tender for a contract via a mini competition from CCS framework RM6068 Lot 1 for the reasons set out in this report.

AUTHORITY UNDER WHICH DECISION IS MADE

Part 3 Section 3.3 – Powers of Members of the Senior Leadership Team

General powers

(a) To take any steps necessary for proper management and administration of allocated portfolios.

STATEMENT OF THE REASONS FOR THE DECISION

This report is for approval to cancel the wired and wireless remediation tender.

This tender is for wired and wireless remediation for all Newham and Havering buildings.

This procurement was aiming to: survey all Newham and Havering buildings; rewire all buildings which have old Cat 5 data cabling with Cat 6A STP cabling and; place wireless access points in the best position to provide comprehensive Wi-Fi coverage in all areas of all buildings.

The tender was published on 24/10/22 and the Council received responses on 21/11/22. The Council held an initial moderation meeting on 14/12/22 but required further clarification from suppliers so held a second moderation meeting on 17/01/23 after receiving responses from suppliers on 06/01/23.

Three suppliers responded to the tender and the Council did have a preferred supplier but this contract is dependent on awarding the network refresh tender which we are cancelling. We will include this piece of work in one of the new network refresh projects.

The network refresh projects are:

- A new network. Local Area Network (LAN); Wide Area Network (WAN) and Wi-Fi solution. When the Council develops the new specification, this will include the wired and wireless remediation.
- Upgraded data centre solution including software and hardware
- Cloud infrastructure to support our move to the cloud
- All 3 projects include operational support (hardware or licensing and design) for 5 years.

This tender and the network refresh were for a solution for both boroughs. Since the Council started the tender process, the decision has been made to split OneSource and move ICT back into the 2 separate boroughs – Newham and Havering.

As the approach to returning ICT back into the boroughs has yet to be determined, there is a level of uncertainty around the best time to split the technical infrastructure that will be needed to support the two boroughs. The Project board considered whether the best approach would be to go ahead with the approach to upgrade a single network and split the network later, or to proceed with 2 separate tenders and split the network early on.

The councils will agree the strategic approach to splitting OneSource and the approach for all key projects by mid-June and the Project Board are advising the decision maker to pause the strategic elements of the network refresh until then (in flight projects relating to fibre upgrades will continue as these are Borough specific).

When the Council has made a decision, it will proceed with the urgent work on the new network which will include wired and wireless remediation.

The new tender will ensure a quality led approach to ensure the solution meets the councils' requirements.

OTHER OPTIONS CONSIDERED AND REJECTED

We considered doing nothing however, that would lead to hardware failure and we would not be able to support the organisation's IT requirements.

We considered continuing with the procurement but the Council would not realise value for money with the current approach.

Part B - Assessment of implications and risks

LEGAL IMPLICATIONS AND RISKS

- In accordance with section 55(1)(b), the Council can make a decision not to award a
 contract for which there has been a call for competition, as long as it informs each
 candidate and tenderer as soon as possible once the decision has been reached. The
 decision to abandon a procurement exercise must be consistent with the general
 principles of transparency and equal treatment.
- 2. Provided that the Council complies with these requirements, it can make a decision not to award a contract.

FINANCIAL IMPLICATIONS AND RISKS

It is anticipated that the new approach will cost less than the original estimate of £0.4 million which was set aside from within the network infrastructure overall capital budget of £8.457 million (split £4.513 million Havering and £3.944 million Newham). This is because it is anticipated that the new approach will be catering for a network which is primarily wireless. The original business case catered for more cabling than required for a wireless infrastructure.

There are no revenue implications for this work in so far as no spend has been committed in relation to this tender to date outside of officer time for which there is a budget.

There are no further cost implications for cancelling this procurement.
