## Part A – Report seeking decision

#### DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

The London Borough of Havering has secured significant grant funding from the Greater London Authority in order to acquire properties to be used as short-term accommodation for refugee families. After the initial period of three years, the property can be re-let in accordance with the allocations policy, as general needs housing.

**48 Trowbridge Road, Romford, RM3 8YW** has been identified as a property to repurchase under the scheme. It is a 3 bed, flat and the property meets the criteria as set by the report and Buy Back scheme procedure.

After consideration of an independent valuation report and knowledge and expertise of the Council's property services it is recommended that the Council purchases this property.

The recommended action is to purchase the property at a price of **£260,000.00** (excl. all standard additional costs). This price accords with valuation produced by the surveyor acting for the Council.

#### AUTHORITY UNDER WHICH DECISION IS MADE

Powers of Members of the Senior Leadership Team under Part 3, Paragraph 3.3 of the Council's Constitution "Financial Responsibilities":

(a) To incur expenditure within the revenue and capital budgets for their allocated portfolio as approved by the Council, or as otherwise approved, subject to any variation permitted by the Council's contract and financial procedure rules.

(b) To oversee the delivery of programmes agreed by Council and Cabinet.

#### STATEMENT OF THE REASONS FOR THE DECISION

The purchasing of 48 Trowbridge Road, Romford, RM3 8YW will have the following benefits for the Housing Revenue Account (HRA):

- The additional stock will help to sustain HRA rental income.
- Provide additional unit of accommodation to house those in need.
- Enable GLA grant to be obtained for up to 40% of the purchase cost.

#### OTHER OPTIONS CONSIDERED AND REJECTED

Option: To not purchase the property.

Reason for Rejection: This has been rejected as not purchasing will not give the Council the opportunity to increase housing stock and will not enable us to apply a proportion of the time-limited GLA grant funding.

There is a current requirement for properties that are purchased to either have an EPC with a minimum of a 'D' rating or that a 'D' rating can be achieved. The final decision is with Senior Management as it may be beneficial to acquire leasehold properties below the minimum rating to make it easier to arrange the required energy improvement works to leasehold blocks.
