Part A - Report seeking decision

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

This report seeks approval to adopt and publish Havering's Local Heritage List.

What is a Local List?

Local heritage listing is intended to highlight heritage assets which are of local heritage interest in order to ensure that they are given due consideration when change is being proposed to the assets or the built environment in which they are located.

Heritage assets range from sites and buildings of local historic value to those of the highest significance, such as World Heritage Sites (NPPF, para 189).

A Local Heritage List (or "Local List") is a means for communities and local planning authorities to identify heritage assets that are valued as distinctive elements of the local historic environment. It provides clarity on the location of assets and what it is about them that is significant, helping to ensure that planning policy and individual decisions on planning applications properly takes account of the desirability of their conservation. Whilst local listing provides no additional planning controls, the fact that a building or site is on a local list means that its conservation as a heritage asset is a material consideration when determining the outcome of a planning application.

Consultation on the Local List

Consultation on draft criteria took place from 29th June 2023 to 10th August 2023. This consultation asked residents for their input on how we should assess sites for inclusion on the Local List. Previously, no criteria was in place for Havering's Local List. Introducing criteria is in line with Historic England advice, and makes Havering's Local List evidenced and robust.

The new Local List criteria was approved on 20th September 2023.

Following this, a nominations consultation took place from Thursday 21st September to Thursday 21st December 2023, where residents could submit sites they thought should be added to Havering's Local List. The Council received 138 nominations.

An initial assessment removed nominations that were already protected assets, assets put forward multiple times, and assets that had no historical interest. This left 62 assets to be fully assessed using the new criteria and pro-forma.

Of these, 29 assets were not recommended for addition to the list after a full assessment (see appendix 2), and 33 assets were recommended for inclusion in the new Local List.

Current entries on the Local List were also assessed against the new criteria. From this assessment, 13 sites have been removed from the Local List. For the full assessments of the assets removed from the list, see appendix 3.

Overall, Havering's Local Heritage List now has 182 assets.

Updating the Local List

There is no defined way that authorities must review their Local Lists and subsequent nominations that are suggested by the community outside of formal nomination periods.

It is suggested that a review of nominations takes place every three years at a minimum. If the number of assets nominated exceeds 10, a formal review of them will take place. If the number is below 10, they will roll over to the next assessment year.

The assets will be assessed against the adopted criteria to determine if they should be added to the list.

Protection of Locally Listed Assets

Being on the Local List is a material consideration in planning decisions and therefore provides protection to local assets. Officers are considering ways to further protect assets on the Local List, such as an article 4 direction.

Recommendation

It is recommended that

- 1. The updates to Havering's Local Heritage List, as detailed in this report, are approved and adopted; and
- 2. A copy of the updated Local Heritage List (appendix 1 of this report), is published on the Council's website

STATEMENT OF THE REASONS FOR THE DECISION

The NPPF states that "Local planning authorities should maintain or have access to a historic environment record. This should contain up-to-date evidence about the historic environment in their area and be used to:

- a) assess the significance of heritage assets and the contribution they make to their environment; and
- b) predict the likelihood that currently unidentified heritage assets, particularly sites of historic and archaeological interest, will be discovered in the future." (NPPF, para 192).

The current Local Heritage List is out of date (2014) and not based on agreed criteria. The new Local List criteria, approved in 2023, was the first step in ensuring that the Council has a robust, evidenced and up-to-date Local List. Now nominations have been received and assessed, and the current Local List also updated against this new

criteria, the new Local List should be approved so it can protect heritage assets and be used in planning decisions.

OTHER OPTIONS CONSIDERED AND REJECTED

Other options considered;

Don't adopt and publish the new Local List. This option was rejected as the local heritage list needs to be updated to help protect local heritage assets and to provide up-to-date heritage evidence for the Local Plan review, as required in the NPPF. All work has been completed to update Havering's Local List. To move forward, and to protect the assets identified by the new Local List, it needs to be approved and published.

PRE-DECISION CONSULTATION

Consultation on the Local List criteria took place from 29th June 2023 to 10th August 2023.

Consultation on the Local List nominations took place from Thursday 21st September to Thursday 21st December 2023.

These consultations have fed into the updated Local List.

The lead member for housing and regeneration, Councillor Williamson, has also been consulted on the progression of the Local List.

Part B - Assessment of implications and risks

LEGAL IMPLICATIONS AND RISKS

The Local List is a non-statutory list of buildings compiled by the Council.

The National Planning Policy Framework states that "Local planning authorities should maintain or have access to a historic environment record. This should contain up-to-date evidence about the historic environment in their area and be used to:

- a) assess the significance of heritage assets and the contribution they make to their environment; and
- b) predict the likelihood that currently unidentified heritage assets, particularly sites of historic and archaeological interest, will be discovered in the future."

The Government's Planning Practice Guidance advises that plan making bodies such as local planning authorities should make up to date information on non-designated heritage assets accessible to the public. Local planning authorities are recommended to keep a local list of non-designated heritage assets to provide greater clarity and certainty for owners, developers and decision-makers.

By adopting and publishing the updated Local List, heritage assets on the list will be protected.

FINANCIAL IMPLICATIONS AND RISKS

There is an estimated £300 printing cost associated with the adoption and publication of the local list. Letters will be sent to all assets included on the Local List to inform them of their designation.

This will be funded through the existing Local Plan budget.

HUMAN RESOURCES IMPLICATIONS AND RISKS (AND ACCOMMODATION IMPLICATIONS WHERE RELEVANT)

There is no Human Resources implications of the proposed decision.
