

# Notice of KEY Executive Decision containing exempt information

## Part A – Report seeking decision

## DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

For the reasons set out in this report, the Strategic Director of People is recommended to agree to award the contract for the car port and photovoltaic panel project at Central Park Leisure Centre to Energy Gain UK limited via direct award using the Fusion 21 Heating, Renewables and Electrical Framework Lot 9 Photovoltaic and Battery Storage.

## STATEMENT OF THE REASONS FOR THE DECISION

## 1. Background

1.1 The government's Swimming Pool Support Fund (SPSF) provided a total of £80 million to local authorities in England as a support package for public leisure facilities with swimming pools and was split into two phases.

**Phase I - Revenue:** £20m was available to support facilities with swimming pools with increased cost pressures, leaving them most vulnerable to closure or significant service reduction.

**Phase II - Capital:** £60m was available from the government for capital investment to improve the energy efficiency of public facilities with pools in the medium to long term.

- 1.2 The Council applied to the Capital fund and was successful with a bid of £700,000 to install car ports with photo voltaic panels on the roof to provide a renewable and sustainable energy source for Central Park Leisure Centre.
- 1.3 The award of £700,000 can be used on eligible expenditure that for this scheme includes everything except for the car port frames which are ineligible expenditure.

## **Decision Required**

- 1.4 It is proposed to use the Fusion 21 Heating, Renewables and Electrical Framework Lot 9 Photovoltaic and Battery Storage. This framework permits direct award to the highest ranked supplier that can meet the requirements at catalogue prices.
- 1.5 The top rated supplier in the Heating, Renewables, and Electrical category, Energy Gain UK limited has provided a quote to undertake and complete the work to construct, install and commission the car ports and photovoltaic panels at Central Park Leisure Centre. The financial detail of this quote is contained within the exempt section of this report.

- 1.6 Another company did provide a quote for the project but that was at a higher overall cost. It is considered therefore that this provides a benchmark which demonstrates that award to Energy Gain UK offers best value for the Council.
- 1.7 A condition of the Swimming Pool Support Fund grant is that the works have to be completed and the drawdown of the grant has to be by the end of March 2025.
- 1.8 In order to meet these timescales and to not risk losing the £700,000 grant, it is recommended to award the contract for this project to Energy Gain UK, who have indicated they can both carry out the project and meet the timescales in order to drawdown the grant.
- 1.9 The Council will use the JCT 2016 Minor Works contract with London Borough of Havering amendments for this project as this is permitted by the Fusion 21 Framework direct award route.

## OTHER OPTIONS CONSIDERED AND REJECTED

- Do nothing to do nothing would result in losing the grant of £700,000 from the swimming pool support fund. It would also result in not achieving a reduction in carbon emissions that will contribute to the Council's climate objectives. There are also potential savings to the Council through reducing energy consumption and the leisure management contract position on surplus share and absorbing the risk on price of utilities. Do nothing has been rejected for these reasons.
- 2. Carry out a full tender process for the project. Energy Gain UK have been ranked as the top provider in the Heating, Renewables, and Electrical category of the Fusion 21 Framework on both quality and price. Another company did provide a quote for the project but that was at a higher overall cost. As mentioned within this report, the project has to be completed by the end of March 2025 with the Swimming Pool Support Fund grant drawn down before the end of the financial year. It is for these reasons this option is rejected.

## Part B - Assessment of implications and risks

## LEGAL IMPLICATIONS AND RISKS

Section 1 of the Localism Act 2011 grants Local Authorities a General Power of Competence, allowing it to do anything that an individual may do, provided there are no statutory constraints, No limitations are engaged by this decision.

The Local Authority is a Contracting Authority for the purposes of the Public Contract Regulations 2015 (PCR). The value of the contract is below the works threshold of £4,733,252, therefore this Contract is not caught by the full PCR regime. The procurement must comply with the Council's Contract Procedure Rules (CPR).

CPR 20.4 requires awards via frameworks to comply with the rules of the framework. As set out in this report, the proposed direct award using the JCT minor works contract with London Borough of Havering amendments complies with the Fusion 21 Heating, Renewables and Electrical Framework award procedure.

The Council is a best value authority. As set out in this report, officers consider the direct award to represent best value.

For the reasons set out above, the Council may award the contract.

## FINANCIAL IMPLICATIONS AND RISKS

The Council has accepted the terms and conditions of the Swimming Pool Support Fund (SPSF) grant. SLM were also required to sign a Grant Adherence Agreement committing them to adhere to the conditions of the grant award along with the Council.

The SPSF does not include the physical car port structure, that is required to place the photovoltaic panels on the roof, as eligible expenditure. This element of the project is costed at £121,453 and will be split 50/50 between SLM and the Council. The Council contribution of £73,403 will be funded from the capital lifecycle budget included as a contractual obligation as part of the leisure management contract.

The balance of the project, as detailed in the exempt section to this report, will be funded through the SPSF grant of £700k.

One of the conditions of the funding is that funds must be drawn down by March 2025, there is a small risk that if any works are not complete then funding for these will not be available from the SPSF grant and Havering would have to cover the cost. To mitigate

this risk, the project will be managed to ensure it is completed by the required deadline and invoices are submitted without delay from the contractor.

Any ongoing maintenance costs will be covered by SLM and will not cause any additional pressures for LBH.

There are also potential savings to the Council through reducing energy consumption through the leisure management contract position on surplus share and absorbing the risk on price of utilities.

The recommendations made in this report do not give rise to any identifiable HR risks or implications that would affect either the Council or its workforce.

In addition, the Council is also committed to improving the quality of life and wellbeing for all Havering residents in respect of socio-economics and health determinants.

## HEALTH AND WELLBEING IMPLICATIONS AND RISKS

This project to construct car ports to enable photovoltaic panels on the roof space will contribute to the Council's position to become carbon neutral by 2040 or sooner. Some of the car ports spaces can also be used for bicycle storage to expand existing bicycle spaces. This will improve the health and wellbeing of residents by directly contributing to the climate emergency.

The project will also contribute to the sustainability of Central Park Leisure Centre and contribute to the ongoing opportunities to participate in physical activity and sport to enjoy the physical, health and wellbeing benefits this brings.

## ENVIRONMENTAL AND CLIMATE CHANGE IMPLICATIONS AND RISKS

This project will contribute to the ambition for the Council to be carbon neutral by 2040 or sooner. Approximately 46t of CO2 emissions will be saved through the installation of photovoltaic panels at Central Park Leisure Centre.
