Part A – Report seeking decision

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

The decision Maker is requested to:

- Note that the Football Foundation has offered a grant award for preconstruction work for the development of a football hub at Brittons Playing Field.
- 2. Agree and sign the terms and conditions of the grant offer.

STATEMENT OF THE REASONS FOR THE DECISION

Background

1. On 11 December 2004, in a report on the development of a football hub at Brittons Playing Fields Cabinet agreed (amongst other things) to

Authorise the Head of Leisure and Culture, in consultation with the Strategic Director of Resources and the Cabinet Member for Adults and Wellbeing to:

- a. Make an application to the Community Infrastructure Fund and to external funders for the funds necessary as partnership funding, progress the feasibility study to substantiate an application to the Football Foundation for further grant funding and to progress the preliminary design work necessary for an application for planning permission.
- Subject to (a) above being satisfactorily achieved, to make an application for planning permission to allow for development of the land

including and around the existing 3G pitch at Brittons Playing Fields into a "football hub" comprising of two additional 3G pitches and ancillary facilities.

- Subject to (b) above being satisfactorily achieved, to submit a funding application to the Football Foundation in conjunction with the National Football Trust.
- The Football Foundation has offered a grant of up to £202,733 to assist the Council towards the cost of the upfront fees and surveys associated for completing RIBA Stages of Work 1-3 for the proposed Football Hub at Brittons Playing Field.
- 3. The offer of a grant is for up to 60% of the costs for the above, with the Council contributing up to £135,155 as 40% match funding.

Current Situation

4. In order to receive the grant award from the Football Foundation, the terms and conditions of the award are required to be signed. The offer letter with the terms and conditions is attached as Appendix A.

OTHER OPTIONS CONSIDERED AND REJECTED

Do nothing – if the terms and conditions of the grant award are not signed the
offer of the grant will be withdrawn. This has been rejected as without external
funding the feasibility, design and planning application will not be concluded
and the football hub project will cease.

Part B - Assessment of implications and risks

LEGAL IMPLICATIONS AND RISKS

The Council has a general power of competence under Section 1 of the Localism Act 2011 to do anything an individual can do, subject to any statutory constraints on the Council's powers. None of the constraints on the Council's Section 1 power are engaged by the recommendations within this report.

The Council's Contract Procedure Rules state:

- 25.1 Where the council receives Grant Funding and is named as the accountable body for the expenditure of monies, and where the terms of the grant permits the council to directly carry out Works, or buy Services or Supplies, any procurement will be conducted in line with CPR.
- 25.2 Where the funding received exceeds £500,000 a report will be presented to the SLT for approval to enter into the Grant Agreement (or other funding arrangement) and to record the availability of funding subject to the terms of the grant.
- 25.4 Where the funding is for use by a third party, the obligation to account for the funding contained in the grant terms will be included in the agreement with the third party. Furthermore, the terms of making the grant shall include a clause to competitively tender for Services, Supplies or Works and reflect the Council's strategies, policies and objectives in so much as they apply to, or are compatible with, the funding objectives as set out in the grant terms imposed on the Council and CPR.

The grant offer letter including the terms and conditions is attached as Appendix A.

FINANCIAL IMPLICATIONS AND RISKS

This decision paper is seeking approval to accept £202,733 of funding from The Football Foundation.

The offer of grant funding is to progress RIBA Stages 1-3 of the Football Hub project. The total RIBA 1-3 costs are estimated to be £337,888, The Football Foundation grant offer of £202,733 will fund 60% of these costs and one of the conditions of this funding

is that it requires 40% match funding from LBH equating to £135,155. This was agreed by Cabinet at their meeting on 11 December 2024

Should the project fail at any point of these stages, the project will cease and no further expenditure will be committed. For each stage, the Football Foundation will fund 60% of the costs and the Council 40%.

Additional external funding is still being sourced to fund the Football Hub project in full. It is likely that this match funding will be secured, and this can contribute to the RIBA 1-3 costs.

There is a risk that the RIBA 1-3 costs cannot be met from external funding arrangements, these costs would then be funded from within Culture and Leisure's existing budgets.

If the project fails at any stage of the RIBA 1-3, the project will cease and 40% of the incurred costs will need to be funded by Culture and Leisure's revenue budget as no further funding would be available. The football foundation would only cover 60% of any incurred costs to date and any grant amount remaining would need to be repaid to the football foundation.

If at any point LBH decides not to proceed with the project, other than in the event of circumstances outsides its control, the Football Foundation can request the full amount of the grant to be repaid

This financial support is no guarantee that the main application will be successful and a formal decision on the main application needs to be received before any building work takes place. If the main application is unsuccessful then alternative funding would need to be sought in order to continue the project. If further funding is not successful then the RIBA stage 1-3 costs would be sunk costs that need to be met by LBH up to the value of £135,155.

HUMAN RESOURCES IMPLICATIONS AND RISKS (AND ACCOMMODATION IMPLICATIONS WHERE RELEVANT)

There are no human resource implications or risks associated with accepting this grant offer from the Football Foundation.

EQUALITIES AND SOCIAL INCLUSION IMPLICATIONS AND RISKS

However, if Havering is awarded additional funding to develop a Football Hub, the team will acknowledge best practice regarding climate change and environmental needs in line with the Havering Climate Change Action Plan and the Council's target of becoming carbon neutral by 2040.
