<b>DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION</b>
<p>The council has been successful in obtaining funding under the Council Homes Acquisition Programme (CHAP) a Greater London Authority initiative aimed at increasing the supply of affordable housing for low-income families, with the focus on acquiring larger properties.</p> <p>Further information can be found using the link below:</p> <p><a href="#">Council Homes Acquisition Programme   London City Hall</a></p> <p>This proposed acquisition contributes towards our target of 45 properties to purchase in this financial year, utilising the allocated funding under CHAP.</p> <p>113 Rush Green Gardens, Romford, RM7 0NS has been identified as a property to purchase under the scheme. It is a 2 bedroom Flat and the property meets the criteria for the Council Home Acquisition Programme (CHAP).</p> <p>After consideration of an independent valuation report and knowledge and expertise of the Council's property services it is recommended that the Council purchases this property.</p> <p>The recommended action is to purchase the property as set out in the Financial Exempt Report at Appendix C. This price has been negotiated within the Surveyors valuation recommendation.</p>

### **STATEMENT OF THE REASONS FOR THE DECISION**

The purchasing of 113 Rush Green Gardens, Romford, RM7 0NS will have the following benefits for the Housing Revenue Account (HRA):

- The additional stock will utilise allocated funding under the CHAP funding programme.
- Provide additional units of accommodation to house those in need.

Option: To not purchase the property.

Reason for Rejection: This has been rejected as not purchasing will not give the council the opportunity to increase housing stock and assist with agreed target spend under CHAP funding.

## **Part B - Assessment of implications and risks**

### **LEGAL IMPLICATIONS AND RISK**

The Council has the power to acquire houses and land under section 17 of the Housing Act 1985. The power does not preclude the repurchase of former council properties.

It is understood that external solicitors will be instructed to deal with the conveyancing.

The purchase will be subject to the necessary legal due diligence taking place.

### **FINANCIAL IMPLICATIONS AND RISKS**

The CHAP provides additional funding for the purchase of properties, at a contribution of £150,000 per unit, with the aim of increasing stock levels. The remainder of the funding will come from the HRA Capital Programme.

### **ENVIRONMENTAL AND CLIMATE CHANGE IMPLICATIONS AND RISKS**

There is a current requirement for properties that are purchased to either have an EPC with a minimum of a 'C' rating or that a 'C' rating can be achieved. The final decision is with Senior Management as it may be beneficial to acquire leasehold properties below the minimum rating to make it easier to arrange the required energy improvement works to leasehold blocks.
