Policy context:	This initiative will support Havering Council to meet its People Theme priorities of ensuring that people are helped to live independent, socially connected, and healthier lives as set out in the Corporate Plan 2022/23 – 2026/27. The vaping stop smoking initiative is part of the local Stop Smoking project within Havering's Health and Wellbeing Strategy priorities and Partnership agenda to reduce smoking-related harms and reduce inequalities caused by smoking across the borough.
Financial summary:	Funding for this vaping initiative will come from the government allocation for local stop smoking provision and is from the Department of Health and Social Care (DHSC) via Office for Health Improvement & Disparities (OHID) to Havering. The vapes provided will be provided by the national Swap to Stop Scheme also funded by OHID. This funding is part of the government's national commitment to achieve a smoke

	free generation by 2030 by supporting local authorities to enhance their stop smoking provision. The grant will be made available under section 31(3) and section 31(4) of the Local Government Act 2003.
	The Council has been allocated a grant total of £315,741 for smoking cessation activities in the financial year 2025-26.
	Change, Grow, Live (CGL) will offer vapes as a standalone initiative within their current treatment service offer. The variation of the contract with Change, Grow, Live will be for the sum of £24,035.00. It will take place from 1 st June 2025- 31 st March 2026.

DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

This decision paper seeks approval to vary the existing Adult Treatment & Recovery Service contract with Change, Grow, Live (CGL) to include provision of a 10-month vaping service initiative from 1st June 2025 to 31st March 2026 at the cost of £24,035.00.

AUTHORITY UNDER WHICH DECISION IS MADE

4.2 To award all contracts with a total contract value of below £1,000,000 other than contracts covered by Contract Procedure Rule 16.3. This delegation shall include the ability to extend or vary a contract up to and including a value of £1,000,000 (provided that the extension is in line with the existing contractual provisions.)

STATEMENT OF THE REASONS FOR THE DECISION

Local authorities currently fund the provision of local stop-smoking services and support through the public health grant.

The government is investing an additional \pounds 70 million per year to support local authority led stop smoking services and over the five financial years of 2024 to 2025 through to 2028 to 2029. Indicative allocations to local authorities were published on 4 October 2023. The Havering allocation for first year 2024 to 2025 was \pounds 307,543. In 2025 to 2026 this increased to \pounds 315,741.

This new funding will be provided through a new section 31 grant on top of the current public health grant allocations. The funding is ring fenced for stop smoking activities. To receive the funding, local authorities must maintain their existing spend on stop smoking services through the public health grant. Acceptance of this grant has been authorised through a separate non key ED.

This additional allocation is part of the government's announcement to create a 'smoke free generation' by stopping young people from starting smoking through legislation, and by supporting existing smokers to quit. This is through ensuring a nationwide comprehensive offer to help people stop smoking across England and to increase the number of smokers engaging with effective interventions to quit smoking. this will be achieved by:

• stimulating more quit attempts by providing more smokers with advice and swift support

- linking smokers to the most effective interventions to quit
- boosting existing behavioural support schemes designed to encourage smokers to quit (for example the 'swap to stop' scheme)
- building capacity in local areas to respond to increased demand
- strengthening partnerships in local healthcare systems

In order to boost existing behaviour support schemes to encourage smokers to quit, particularly those from one of the groups with highest smoking prevalence, those receiving treatment for drug and alcohol addiction (smoking prevalence 60% for alcohol and non-opiates misuse, 69.7% all opiate misuse), a specialist vape service (using the government Swap to Stop scheme) will be delivered by the current treatment provider Change, Grow Live. The vape provision will be available to all individuals engaged with the service, as well as those entering treatment within the period of the pilot.

The intervention model will include:

- Very Brief Advice (VBA+) to service users identified as smokers,
- Carbon Monoxide (CO) level testing
- Provision of a vape starter kit and follow on liquids via direct delivery.

• Referrals for onward support made to the Specialist Advisor Stop Smoking Service currently delivered by Barking and Dagenham Council's Healthy Lifestyle team. This service will contact the client and offer a full, tailored, 12 week programme of support to further support them in making a successful quit.

- Follow up consultation at 4 weeks for confirmation of smoking status
- Monitoring of uptake and referrals

Following approval of this decision, Havering Council will proceed with a 10-month variation (1st June 2025 to 31st March 2026) to the existing CGL contract for the provision of the adult drugs and alcohol treatment and recovery service.

The Council have a contract with CGL, which commenced on 1st April 2021 for a period of 5 years (with an option to extend for a further three years), to provide drug and alcohol treatment and recovery service. The value of the contract is £1.4M per annum. In December 2024, the Council varied the contract so that CGL Havering delivered the vape intervention to reduce smoking at a cost of £31K. Since its launch, the service has been running successfully, achieving the target of distributing 80 vape kits over a period of 6 months. Two new staff members were recruited to support delivery of the service, which is now offered from both CGL hubs and satellite locations. These staff members have completed NCSCT Level 2 training, and the wider team has also undertaken vape training delivered by the Elfa Pro Team.

In addition to the initial stock received in December 2024, CGL has recently received further vape supplies to support ongoing service delivery. The specialist stop smoking service continues to provide fortnightly satellite support from the CGL premises acting as a smooth pathway for people requiring more intensive support than the lighter touch approach being offered by CGL. The service has been instrumental in assisting residents to reduce their dependence on smoking, which in turn has enhanced their financial resilience by significantly lowering cigarette-related expenses. Furthermore, it has offered vital support for substance dependency reduction and provided comprehensive care to pregnant residents, leading to beneficial results for both the mother and the child.

Data shows that drug and alcohol misuse and smoking are closely linked, thus having one provider deliver the service means resources can be used more efficiently.

Following approval of this decision, Havering Council will proceed with a ten-month variation (1st June 2025 to 31st March 2026) to the existing CGL contract for the provision of the adult drugs and alcohol treatment and recovery service.

OTHER OPTIONS CONSIDERED AND REJECTED

This is the only provider in the borough working with people with substance misuse and provides a treatment programme. In addition, CGL has achieved the targets agreed for the initial 6-month vaping stop smoking initiative and the 10-month programme would provide a welcome opportunity for residents to reduce their dependency on tobacco. The provider will be able to continue identifying smokers, providing harm reduction advice (making every count count), promoting the vaping provision, and facilitating engagement.

Provide the service in –house – this is not possible as the Council do not have the resources in house to deliver this service.

Undertake a procurement – due to the need for the funding to be spent within this financial year and the funding amount being relatively small, this is not appropriate and would take too long for delivery of service.

Part B - Assessment of implications and risks

LEGAL IMPLICATIONS AND RISKS

The Council has an existing contract with Change, Grow, Live (CGL) for adult treatment and recovery services and it is making a decision to vary the contract. The Council has the power to vary the contract for these services through section 111 of the Local Government Act 1972, which allows the Council to do anything which is calculated to facilitate or is conducive or incidental to the discharge of any of its functions. Additionally, the Council has the power to vary the contract through its general power of competence in section 1 of the Localism Act 2011 to do anything that individuals generally may do. There are limitations on the general power of competence, but the limitations do not apply to this decision.

The existing contract is for a value of £1.4M per annum or £10.6M over the maximum life of the contract. This is above the threshold for light touch services under the Public Contract Regulations 2015 (as amended) (PCR) and therefore any variation must be in compliance with Regulation 72 PCR and the Council's Contract Procedure Rules (CPR).

The proposed variation has a value of £24K which is below the threshold for light touch services and less than 10% of the original contract value. The proposed variation is in accordance with Regulation 72(1)(f) and CPR 19.3 and thus the Council can vary the contract as set out in the body of the report.

FINANCIAL IMPLICATIONS AND RISKS

This decision paper seeks approval to vary the existing Adult Treatment & Recovery Service contract with Change, Grow, Live (CGL) to include provision of a 10-month advice and vaping service initiative from 1st June 2025 to 31^{st} March 2026 at the cost of £24,035. The spend will be funded from the Council's smoking cessation grant for which the council has been allocated £315,741 in 2025-26. The contract spend of £24,035.00 can be accommodated within the overall planned expenditure associated with this grant and meetings the grant conditions. Any associated financial risk has been successfully mitigated, as the provider demonstrated value for money and achieved expected outcomes within the six-month period of 2024-2025. The total expenditure for this period was £31,007.76.

CGL are the only substance misuse treatment provider working within the borough at this time and a variation of our existing contract with them represents the most expeditious way of reaching the required group within the timeframes required (i.e. by the end of this financial year). This is the first time the Council will have employed CGL to undertake smoking cessation activities, but CGL has experience of delivering stop smoking initiatives in other boroughs. Secondly, substance misuse clients seen by CGL are among the groups with high smoking prevalence in the borough and therefore provision of support to stop smoking will benefit their health. Contract management will monitor the effectiveness of the service against key metrics such as the number of people offered kits and the number abstaining from smoking at 28 days.

The recommendations made in this report do not give rise to any identifiable HR risks or implications that would affect either the Council or its workforce.
