## Part A - Report seeking decision

#### DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

To formally respond to the Mayor of London on the Towards a new London Plan consultation.

## **AUTHORITY UNDER WHICH DECISION IS MADE**

## 2. Planning

2.1 To exercise all powers and functions on behalf of the Council and to meet all obligations imposed upon the Council pursuant to any planning legislation, except where such powers, functions and obligations are reserved to the Council or its committees.

#### STATEMENT OF THE REASONS FOR THE DECISION

#### Introduction

- The London Plan 2021 is the strategic, spatial plan for Greater London and is part of the Development Plan for Havering. It includes policies on housing and growth, employment, public transport and open spaces. The Mayor of London is required to produce an up to date London Plan every 5 years and is now working on the next London Plan. The new London Plan will cover the period from 2027 to 2050.
- 2. Towards a new London Plan was launched on 9 May 2025 for consultation. The document is a high level consideration of a range of policy areas. The consultation closes on Sunday 22 June.
- 3. This report sets out a proposed response to the consultation comprising of a letter summarising key concerns to the proposals (Appendix A) and specific answers to the consultation questions (Appendix B).

## Increasing London's housing supply

#### **Housing**

4. Housing targets set out in the new London Plan will apply from 2026-27 for 10 years. Towards a new London Plan proposes significantly increasing the current housing target for the whole of London for this period from 522,870 to 879,920. The new Plan will apportion targets for individual boroughs but these have not been set out in the consultation document.

#### Development in the Green Belt

5. The GLA has commissioned a London—wide Green Belt review and this will include identifying 'grey belt' land across London. The consultation document has not provided any details on the areas being considered for strategic, large-scale urban extensions or where the transport interventions are being considered. The Council is undertaking its own Green Belt study for evidence for the Local Plan and will engage with the GLA as they progress with their evidence base.

#### Planning for affordable homes

- 6. Towards a new London Plan continues to support planning for affordable homes and will review threshold requirements to ensure they support affordable housing needs and delivery. The document proposes identifying types of development where affordable housing is difficult to achieve and where the threshold of 10 units may have negative impacts on delivery.
- 7. The consultation document recognises that the greatest affordable housing need is for social rent homes and proposes exploring options such as specific targets for social rent and increasing the proportion of social rented homes.

## Gypsies, Travellers and Travelling show people

- 8. The adopted London Plan does not set targets for individual boroughs for permanent pitches and plots for Gypsies, Travellers and Travelling show people. The consultation document suggests that the new London Plan sets these targets in order to achieve better provision across London.
- 9. The consultation document also proposes requiring boroughs to consider granting permanent permission for suitable sites that have temporary planning permission and a London wide target for transit pitches.

## **Growing London's economy**

#### Digital infrastructure

10. The consultation document recognises the importance of datacentres, and aligns with the NPPF on the importance of significant infrastructure such as this. The Council is currently working on a Local Development Order for a datacentre campus in North Ockendon. If a LDO is progressed, the datacentre would be the biggest in Europe and be of national significance.

#### Culture

- 11. Culture and the creative industries contribute significantly to London's economy and employment. The consultation considers retaining a specific London approach and impacts on design and location of noise-sensitive uses.
- 12. Havering's Cultural Strategy 'A Good Life' aims to nurture and grow the cultural life of Havering residents. The Council agrees that cultural assets need protection, but more should be done in the London Plan to encourage new cultural spaces and designate areas of underdeveloped cultural ecologies.

## London's capacity for growth and design quality

- 13. The consultation document considers ways of increasing housing supply and types of house builders. It suggests setting building heights that are acceptable in principle in all locations across London that share the same characteristics. It also proposes that the new plan could identify and define tall building clusters.
- 14. Havering published its own Character Study in 2024 and this provides an analysis of the character and the built typologies across Havering. The study has identified where there are opportunities for densification and for tall buildings. The proposals in the consultation are likely to undermine the approach we have taken to ensure new development respects the character of the existing area.

## Homes for families

- 15. The consultation document recognises that the needs of Londoners of all ages, and through different life stages, should be met. The document makes several proposals including specific requirements for family homes, preventing the loss of family sized homes and adopting a London-wide approach on making higher density areas in London better for children and young people.
- 16. Family numbers are increasing in Havering and there is a very significant identified need for family housing. The London Plan should strongly support the delivery of family homes in those boroughs that can evidence that there is a significant need.

## London's infrastructure, climate change and resilience

### **Energy efficiency**

17. Havering took part in the commissioned evidence base Towards Net Zero (TNZ) to consider the assessment process of energy use of different forms of development. It is understood through the TNZ study that carbon reduction targets based on SAP calculations (that the current London Plan energy targets are based around) may not be the most accurate or effective.

The Council is supportive of improving the way energy is measured. The current carbon reduction measures are generally well understood, but planners and applicants are less familiar with these alternative methods of measurement.

#### Waste

- 18. The new London Plan will update borough-level waste apportionment targets and ensure they align with the latest data and policy reforms.
- 19. The Council has prepared a response on waste together with Barking and Dagenham, Newham, and Redbridge, who we are working with on the East London Joint Waste Plan. The response focuses on points of disagreement with the current London Plan waste policies and lack of clarity around issues such as sharing surplus capacity, which has come up through production on the Joint Waste Plan.

#### Next steps

- 20. Following the consultation on Towards a new London Plan, comments will be reviewed and a draft new London Plan will be published for consultation in 2026. Further evidence base documents are expected to be published during 2025.
- 21. The indicative timetable for preparing the new London Plan is shown below:
  - Towards a London Plan consultation 9 May 2025 to 22 June 2025
  - Draft London Plan consultation 2026
  - Examination process 2026 2027
  - Adoption 2027

#### OTHER OPTIONS CONSIDERED AND REJECTED

Do nothing – this option was rejected as there are only limited opportunities for the London Borough of Havering to input into the drafting of the London Plan.
