## **BACKGROUND**

- (A) The Parties to this agreement have come together for the purposes of a joint bid to the Department for Energy Security and Net Zero for funding under Wave 3 of the Social Housing Decarbonisation Fund Wave 3.
- (B) As part of the bid, the parties shall enter into an agreement to formally establish consortium to provide the governance framework for delivery of the programme (the **Partnership Agreement**). As part of this process, the Parties are required to enter into the agreement contained in Schedule 1 (the **Data Sharing Agreement**).
- (C) Any organisation admitted as a new party to the Partnership Agreement (**New Party**), will also need to be admitted as a new party to the Data Sharing Agreement.

## **1. INTERPRETATION**

1.1 The following definitions and rules of interpretation apply in this Deed of Authorisation.

**Deed of Accession** the deed contained in Schedule 2.

**Host Member** means the London Borough of Camden, or such other party appointed as Host Member in accordance with the terms of the Partnership Agreement.

1.2 Clause, schedule and paragraph headings shall not affect the interpretation of this agreement.

1.3 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.

1.4 A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.

1.5 In the case of any ambiguity between any provision contained in the body of this agreement and any provision in the Partnership Agreement, the provision in the body of the Partnership Agreement shall take precedence.

1.6 A reference to **writing** or **written** includes email.

## 2. **AUTHORISATION OF FUNCTIONS**

2.1 Each of the Parties authorise the Host Member (on behalf of the other Parties) to counter-execute each Deed of Accession in respect of a New Party.

2.2 Upon executing the Deed of Accession any New Party shall be bound by the provisions of the Data Sharing Agreement.

## 3. **GENERAL**

3.1 No one other than a Party to this agreement shall have any right to enforce any of its terms.

3.2 No variation of this agreement shall be effective unless it is in writing and signed by the Parties (or their authorised representatives).

3.3 For the purposes of this agreement the Parties shall include their affiliates, including but not limited to any subsidiaries (as defined by section 1159 of the Companies Act 2006) and any parent or associated undertaking.

3.4 This agreement may be entered into in any number of counterparts and by the Parties on separate counterparts, all of which taken together shall constitute one and the same instrument.

3.5 This agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.

3.6 The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims), arising out of or in connection with this agreement or its subject matter or formation.
