		I hope this letter finds you well. I am writing in response to the recent proposal regarding the installation of electric vehicle (EV) charging bays in Bader Way.
		While I appreciate the Council's initiative to promote electric vehicles and sustainability, I must express my strong objection to the plan as it currently stands.
		The proposal to reduce the number of existing parking bays for residents is concerning, especially given that we currently have only eight parking spaces available on our street servicing the 12 flats on the Road. Many residents are already struggling to find adequate parking, and reducing the number of available bays would exacerbate this issue significantly. In addition, the private houses on the opposite side of the road are allowed to have dropped down kerbs so they can have private parking in their compounds which further reduces the cars parked on the road. 		notification. This relies solely on footfall and residents attempting to read the notice. The second page of the notice has been printed on the back of the first page, this makes it incredibly difficult to see the print. The content on page 2, is upside down
		when you try to read it, rendering it unreadable. The placement of the notice during winter is also inadequate, few residents will be walking and equally lingering in winter to read the sign.
		Many of the properties surrounding the affected area on Pretoria Road and Oak Street are rented properties, the owners of these properties have not been consulted and are very unlikely to have seen the small A4 notice attached to the lamppost.
		Property values will be affected detrimentally by the introduction of the electric vehicle charging points and these individuals should have been notified and given the opportunity to oppose the bays.

		I would like to strongly object to the installation of Proposed Electric Vehicle Charging Parking Bays in Abbs Cross Gardens.
		There are severe parking, traffic congestion and safety problems in Abbs Cross Gardens and these proposals will only make a bad situation considerably worse. We have already had to fight a proposal several years ago to put residents parking bays and parking meters along the road, on the grounds that it would exacerbate parking and road safety problems, and were successful in getting those proposals cancelled, so we are very angry and disappointed that we are having to fight another proposal that would reduce our ability to park anywhere near our homes.
		Abbs Cross Gardens is used for parking by residents of Victor Walk who, not having a road outside their homes, have no other parking alternatives anywhere near their homes. We already have severe parking problems, exacerbated by workers at the Sorting office parking here, and also parking by visitors to the High Street that don't want to pay to park in the council car parks. These problems include residents returning home just to find there are no parking spaces available at all in the road, daily health and care workers visiting residents having nowhere to park, delivery vehicles having to stop in the middle of the road for lengthy periods of time while deliveries are made, and tradesmen such as builders having no place to park when they are engage on work in the buildings in Victor Walk. These problems will be made much worse by the loss of parking to these proposed Electric Vehicle Charging Parking Bays.
		At present 7 vehicles can park behind Block 1-23 Victor Walk. Marking out parking bays, even without parking restrictions, would reduce the number of vehicles that could park along this stretch of road by forcing drivers to park within parking bays which are measured out to accommodate the largest of vehicles. In reality, due to the pressures on parking, the proposed Dual Use Bays would never be used for electric charging as they would be used for normal parking by the residents of Victor Walk. This would then leave us with the loss of at least 3 parking spaces to the proposed EV Charging Only Bays, and the loss of another space due to not being able to squeeze cars in together due to the marking of the bays.
		The loss of these parking spaces would also cause traffic congestion and safety problems further along Abbs Cross Gardens, both on the bend going towards the Sorting Office and in the other direction towards Abbs Cross Lane, as drivers that currently park behind Block 1-23 Victor Walk would be displaced. Through long years of experience we know that tight and solid parking on both sides of the road by the bend causes accidents as drivers in both directions are forced into the middle of the road on a blind bend. At best this causes congestion as vehicles have to back up a long way to allow others to pass, and at its worst it has led to head-on collisions between vehicles.
		These proposed EV charging points would also be of no current benefit to the residents of Victor Walk, or to the flats opposite in Abbs Cross Gardens. This is an estate of mostly social housing, where residents can't afford to replace their current cars with EVs, or are using work vehicles which they can't choose to switch to Electric Vehicles. The residents and their visitors and carers would therefore be losing their parking to parking for any passing non-resident.
		Another objection is to the charging points themselves. The pavement is narrow and frequently used by people with prams and on mobility scooters. The charging points are large and would be a significant obstruction to these and other pedestrians using the pavement for its intended purpose, and carelessly placed charging leads would also lead to obstructions and dangerous trip hazards.

Parking is already extremely limited, and as someone who lives here, I often struggle to find a space near my residence. The introduction of dedicated charging bays would further reduce the already scarce parking availability, making it even more difficult for residents to park close to their homes.  Additionally, while I understand the push towards electric vehicles, I do not currently have the financial means to purchase one, being a single parent and with the rising cost of living. As such, I am concerned that the introduction of these bays would disproportionately affect residents like myself who rely on traditional vehicles and have no alternative parking solutions.  If the proposal were to proceed, I would appreciate clarification on what measures the council would implement to support Collier Row residents in securing adequate parking. Are there any plans to increase general parking availability in the area, or provide alternative solutions to those affected?  I would be grateful if my concerns could be considered as part of the consultation process, and I look forward to your response.
		I strongly object to the proposes EV charging bays in Abbs Cross Gardens Hornchurch. The proposed location ie outside 1 to 23 Victor Gardens, is predominantly used by residents of that block and the further residents of Victor Walk. Parking in Abbs Cross Gardens has been a serious problem for many years and reducing the number of free spaces available by 4 will only make the problem worse for the residents. This road is one of the few around the High Street which has free parking and the residents of the Victor Estate are competing for spaces with workers at the Sorting Office, shop workers and shoppers who do not want to pay for the Councils car parks. Many of them are parked all day. Every morning we have the sight of Carers visiting residents circling round looking for a place to park and sometimes obstructing the parking bay at the bottom of Victor Walk. The same problem faces any visitors we have or tradesmen and delivery drivers. The residents of Victor Walk have no road outside their Flats or houses so the opportunity to park outside our home is not available to us. It is not unusual to arrive home and find all of the parking spaces taken and the only option left being the council car parks and a long walk home. The small car parks on the estate are not sufficient for the number of residents who own cars.  The Victor Estate is largely made up of Social Housing and many of the residents are elderly.
		To my knowledge none of them own Electric Cars and are unlikely to buy one in the near future. We will be giving up 4 free parking spaces out of the 7 that can park along that part of the road to the disadvantage of the residents and the benefit of any passing motorist.

Property Value and Investment I made a substantial investment of almost XXXX in this property with the clear understanding that I could install a driveway, as evidenced by neighbouring properties. The proposed charging bay would significantly diminish both the functionality and value of my property. I have no objection to any other charging bays, just not directly outside my house.
		3. Safety and Security Concerns I have unfortunately experienced multiple car break-ins, making secure off-street parking a necessity rather than a luxury. As a council tax payer, I believe I have the right to protect my property by creating safe parking arrangements.
		4. Precedent and Fairness  My immediate neighbor at the end of the road has a dropped kerb, as do most other properties on XXXX. This creates a clear precedent for residential driveways in this area. The sudden introduction of a charging bay outside a privately owned property is arbitrary and unfair.
		5. Traffic Impact The installation of charging bay would likely increase traffic congestion on our residential street, as vehicles queue to use the charging points. This would affect not only residents but also emergency service access.
