## DETAIL OF THE DECISION REQUESTED AND RECOMMENDED ACTION

To approve the procurement of an immigration advice service for Havering

#### **AUTHORITY UNDER WHICH DECISION IS MADE**

#### **Scheme 3.3.3**

## **Powers common to all Strategic Directors**

4.1 To approve commencement of a tendering process for all contracts below a total contract value £1,000,000.

#### STATEMENT OF THE REASONS FOR THE DECISION

- 1.1 This Decision seeks Directors' approval to agree to go out to tender for the provision of bespoke Immigration Advice, currently run by Praxis, following the current provision ending in February 2026
- 1.2 Havering seek to procure a new stand-alone offer which will provide immigration advice to Havering residents with precarious status with a view to regularise their status giving them access to public funds thus reducing the cost of the council's obligation in providing financial and accommodation support to these residents while they have no recourse. We currently have a six month wavier in place with Praxis whilst procurement of the tender is taking place.
- 1.1 The need is for face to face immigration advice and follow up case work for 0.8 FTE OISC level 2 immigration advisor (and associated support). This contract will run from 01.03.26 to 31.09.2027 (18 months)subject to procurement timelines, approximate cost £133,000, fully funded from The Homes for Ukraine Grant (Funding from the MHCLG received on a quarterly basis allows for the commissioning or provide services that ensure guests and sponsors are provided with a source of advice and support to assist with registering for mainstream benefits and services, including where necessary specialist public health services and community integration.
- 1.2 Havering has supported over 1500 refugees and people seeking asylum since launching in July 2022. It has built partnerships with over 30 voluntary and community organisations. Havering supports people seeking sanctuary with their health and wellbeing, access to advice and support, to realise their rights and to help them lead independent, healthy and happy lives. The programme prioritises face-to-face interactions by attending various locations each week, including a weekly one-stop shop at the YMCA reducing barriers to access and building trust. The Havering team benefits from employing people with lived experience who themselves have experienced resettlement in the UK and together speak 16 different languages.
- 1.3 Our current immigration advice service currently has over 20 cases with Havering at any one time to work through, not just status, but any visa issues that we are unable to deal with.

#### OTHER OPTIONS CONSIDERED AND REJECTED

- 1.4 If this procurement does not progress, there will be no immigration offer provided by Havering Council to support any refugee pathway and asylum seekers on immigration issues.
- 1.5 Access to immigration advice is an essential intervention for families to resolve their immigration status, gain recourse to public funds, extensions of visa, any issues with current visas and exit Local Authority support.

### PRE-DECISION CONSULTATION

The Leader of the Council has been kept informed of the requirements that local councils have in providing support to families to rebuild their lives and fully integrate into communities.

#### Part B - Assessment of implications and risks

#### **LEGAL IMPLICATIONS AND RISKS**

- The Council has the power to procure the contract under Section 111 of the Local Government Act 1972, which permits the Council to do anything which is calculated to facilitate, or is conducive to, or incidental to, the discharge of any of its functions.
- 8.2.2 The Council also has a general power of competence under Section 1 of the Localism Act 2011 to do anything an individual can do, subject to any statutory constraints on the Council's powers. None of the constraints on the Council's s.1 power are engaged by this decision.
- 8.2.3 The contract value is below the services threshold of the Procurement Act 2023. The procurement is therefore not caught by the full Procurement Act 2023 regime.
- 8.2.4 the procurement must however comply with the Councils Standing Orders.

This decision paper is seeking approval to procure an 18-month immigration advice contract valued at £133,000. This will be funded through the Homes for Ukraine Grant from MHCLG. The council has received this grant consistently over the past four years, and the £1.6 million allocation for 2025/26 has already earmarked funding for this service. Additional flexibility is available through the Afghan Resettlement Scheme and the Asylum Dispersal Grant, both of which may be used to support the service if required.

The contract will deliver a range of targeted services, including:

- Attend and participate in a minimum of 24 drop-ins per year, aiming for 2 per month.
- Provide up to 4 days per week OISC level 2 Immigration advice: 55 beneficiaries for assessments, of which 18- 20 beneficiaries for caseload per year.
- Provide 1 training sessions/workshops of ½ day to council staff per year.
- Utilise a referral system.
- Quarterly monitoring reports on outcomes and outputs
- Issue feedback questionnaires when cases are closed

This investment could result in cost avoidance through reduced reliance on emergency housing, social care, and other public services, while supporting vulnerable migrants to secure legal status and access employment. Although the financial impact cannot be quantified at this time, it will be monitored through quarterly reporting to assess progress and inform future decision-making.
