I will expect you to be able to show that you are acting with all due diligence and this WILL extend to having SUITABLY TRAINED AND ALERT STAFF MEMBERS WORKING WITH YOU OR IN YOUR ABSENCE. Where the conditions of your premises licence dictate that a CCTV system is installed & a refusals register should be kept I EXPECT YOU TO COMPLY WITH THE REQUIREMENTS AND I EXPECT THE CCTV SYSTEM TO BE IN GOOD WORKING ORDER AND OPERATING.
